2-Ethylhexyl (4-chloro-2-methylphenoxy)acetate (MCPA-2-ethylhexyl) (CAS No. 29450-45-1)

**Product information, including uses/applications and source(s) of imports:**

The subject product is a synthetic organic chemical herbicide that is used to control a wide variety of broad-leaved weeds in cereals, grasses, flax, and non-crop areas. The subject product is imported from the United Kingdom.

To extend the temporary suspension of duty on 2-ethylhexyl (4-chloro-2-methylphenoxy) acetate.

3 **SECTION 1. 2-ETHYLHEXYL (4-CHLORO-2-METHYLPHENOXY)**

4 **ACETATE.**

5 (a) IN GENERAL.—Heading 9902.10.54 of the Har-  
6 monized Tariff Schedule of the United States (relating to  
7 2-ethylhexyl (4-chloro-2-methylphenoxy) acetate) is  
8 amended by striking the date in the effective period col-  
9 umn and inserting “12/31/2011”.

1       (b) EFFECTIVE DATE.—The amendment made by  
2 subsection (a) applies to goods entered, or withdrawn from  
3 warehouse for consumption, on or after the 15th day after  
4 the date of the enactment of this Act.
