p-Anisaldehyde (CAS No. 123-11-5) (provided for in subheading 2912.49.10).

The subject product is a synthetic organic chemical intermediate that is used in the production of certain types of sunscreen products. The product is imported from India.⁴

A BILL

To extend the temporary suspension of duty on Anisic Aldehyde.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ANISIC ALDEHYDE.**

4 (a) IN GENERAL.—Heading 9902.11.57 of the Har-
5 monized Tariff Schedule of the United States (relating to
6 Anisic Aldehyde) is amended by striking the date in the
7 effective period column and inserting “12/31/2011”.

8 (b) EFFECTIVE DATE.—The amendment made by
9 subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
