The subject synthetic organic chemical is a growth regulator that is used on fruits, vegetables, and turf. The product is imported from Japan.

A BILL

To extend the temporary suspension of duty on 3-oxido-5-oxo-4-propionylcyclohex-3-enecarboxylic acid calcium salt.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. 3-OXIDO-5-OXO-4-PROPIONYLCYCLOHEX-3-**
4 **ENECARBOXYLIC ACID CALCIUM SALT.**

5 (a) IN GENERAL.—Heading 9902.22.03 of the Har-
6 monized Tariff Schedule of the United States (relating to
7 3-oxido-5-oxo-4-propionylcyclohex-3-enecarboxylic acid
8 calcium salt) is amended by striking the date in the effec-
9 tive period column and inserting “12/31/2011”.

1 (b) EFFECTIVE DATE.—The amendment made by
2 subsection (a) applies to goods entered, or withdrawn from
3 warehouse for consumption, on or after the 15th day after
4 the date of the enactment of this Act.
