**Proponent name,<sup>3</sup> location:** Bayer CropScience, Research Triangle Park, North Carolina.

**Other bills on product (110<sup>th</sup> Congress only):** H.R. 4346 (Mr. Tim Murphy of Pennsylvania).

**Nature of bill:** Temporary duty suspension through December 31, 2011.

**Retroactive effect:** None.

**Suggested article description(s) for enactment (including appropriate HTS subheading(s)):**

Thionyl chloride (CAS No. 7719-09-7) (provided for in subheading 2812.10.50).

**Product information, including uses/applications and source(s) of imports:**

The subject product is used to manufacture agricultural pesticides and pharmaceutical intermediates. The proponent uses the product to make a herbicide to control postemergence grass and broadleaf weeds. The herbicide is used on corn, soybeans, and other rotation crops. It is also used in the chemical industry as a mild chlorinating agent. A specialized use of thionyl chloride is to make protease inhibitors for HIV treatment. The product is imported from Germany and Switzerland.

**Technical comments:<sup>5</sup>**

The Commission staff notes that there is an existing duty suspension for the subject product under HTS heading 9902.28.01 that expires on December 31, 2009. HTS heading 9902.28.01 should be used to extend the existing duty suspension. The Commission staff also notes that H.R. 4346 and H.R. 5413 cover the same product. Only one bill should be enacted.

However, by law, only the U.S. Customs Service is authorized to issue a binding ruling on this matter. The Commission believes that the U.S. Customs Service should be consulted prior to enactment of the bill.

1 *Be it enacted by the Senate and House of Representa-*

3 **SECTION 1. THIONYL CHLORIDE.**

4 (a) IN GENERAL.—Subchapter II of chapter 99 of  
5 the Harmonized Tariff Schedule of the United States is  
6 amended by inserting in numerical sequence the following  
7 new heading:
