The Proposed Rule fails to define what "additional disclosure" would be required for IDS submissions before a first Office action or what "additional disclosure" would be required for IDS submissions after a first Office action. As such, the Proposed Rule has failed to provide the public and members of the Bar with sufficient information to properly evaluate and comment on the Proposed Rule.
