1. <u>GRANTEE</u>: EMD Chemicals Inc. Cincinnati, OH

## 2. PURPOSE AND LIMITATION:

- a. This special permit authorizes the transportation in commerce of certain hazardous materials listed in paragraph 6 below across a public road, from one part of a plant to another. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.
- b. The safety analyses performed in development of this special permit only considered the hazards and risks associated with transportation in commerce.
- c. No party status will be granted to this special permit.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR §§ 171.1(a)(1), 172.200(a) in that shipping papers are not required; 172.301(c) and 172.302(c) in that the special permit number marking requirement is waived, except as specified herein.
- 5. <u>BASIS</u>: This special permit is based on the application of EMD Chemicals, Inc., dated September 15, 2006, submitted in accordance with §§ 107.109 and 107.105 and the public proceedings thereon.

## 6. HAZARDOUS MATERIALS (49 CFR § 172.101):

7. SAFETY CONTROL MEASURES: Prescribed packagings must be in accordance with the requirements of the Hazardous Materials Regulations, as appropriate. Packagings may not exceed 1250 liters (\*330 gallons) in capacity.

## 8. <u>SPECIAL PROVISIONS:</u>

- a. This special permit only authorizes the material listed in paragraph 6, packaged in accordance with HMR, to be transported across a public road from one part of a plant to another. Materials covered under this special permit must be transported by vehicles owned and operated by EMD Chemicals Inc.
- b. No more than thirty five (35) pallets containing hazardous materials may be transported in or on one vehicle.
- 9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.
- 10. <u>MODAL REQUIREMENTS</u>: No additional requirements other than as required by the HMR.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et seq</u>:
  - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
  - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.

o Registration required by \$107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)—"The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption' to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety -- OHMSPA, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
