2. PURPOSE AND LIMITATION:

- a. This special permit authorizes the transportation in commerce of certain DOT specification cylinders containing Propane, a Division 2.1 gas, which is forbidden for shipment aboard passenger carrying aircraft. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.
- b. The safety analyses performed in development of this special permit only considered the hazards and risks associated with transportation in commerce.
- c. No party status will be granted to this special permit.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR § 172.101 (Hazardous Materials Table, Column (9A) and § 175.75(a)(1) in that the material is forbidden for transportation in a passenger-carrying aircraft, except as specified herein.
- 5. BASIS: This special permit is based on the application of \overline{G} & S Aviation LLC, dated January 10, 2006, submitted in accordance with § 107.109 and additional information dated January 23, 2006.

7. <u>SAFETY CONTROL MEASURES</u>:

a. PACKAGING - Packagings prescribed are DOT Specification 4BA and/or 4BW cylinders.

b. OPERATIONAL CONTROLS -

- (1) No more than 60 pounds net weight of propane may be transported aboard each aircraft.
- (2) Prior to loading the cylinders aboard the aircraft, the pilot must check the cylinders for possible leakage, ensure that the valve is closed tightly, and perform a visual check for cylinder integrity. The cylinders must be loaded and secured in a method which will prevent movement during transportation.
- (3) Before each flight, the pilot-in-command:
 - (i) Informs each passenger of the location of the propane and the hazards involved; and
 - (ii) Prohibits smoking, lighting matches, the carrying of any lighted cigar, pipe, cigarette or flame, and the use of anything that might cause an open flame or spark, while loading or unloading or in flight.
- (4) This special permit authorizes the use of small passenger carrying aircraft, in other than scheduled passenger operations, operating within or into a remote area in the United States to carry not more than 60 pounds net weight of propane if -

- (i) Transportation by air is the only practical means of delivering the propane;
- (ii) Carriage is necessary to meet the needs of a passenger on the same aircraft;
- (iii) Each area or compartment in which the propane is loaded is suitably ventilated to prevent the accumulation of vapors.
- (iv) Each cylinder must be loaded in such a manner that a crew member or other authorized person can see, handle and when size and weight permit, separate such packages from other cargo during flight.
- 8. <u>SPECIAL PROVISIONS</u>: None, as a condition of this special permit.
- 9. <u>MODES OF TRANSPORTATION AUTHORIZED</u>: Passenger-carrying aircraft.
- 10. MODAL REQUIREMENTS: A current copy of this special permit must be carried aboard each aircraft used to transport packages covered by this special permit. The shipper shall furnish a current copy of this special permit to the air carrier before or at the time the shipment is tendered.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et seq</u>:
 - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
 - o Registration required by § 107.601 <u>et seq.</u>, when applicable.

Each "Hazmat employee", as defined in § 171.8 who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by § 172.700 through § 172.704.

No person may use or apply this special permit, including display of its number, when the special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) - 'The Hazardous Materials Safety and Security Reauthorization Act of 2005' (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term 'exemption' to 'special permit' and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
