1. GRANTEE: Accent Stripe, Inc.
Orchard Park, New York
2. PURPOSE AND LIMITATION:
 - a. This special permit authorizes the transportation in commerce of certain non-DOT specification cargo tanks used for roadway striping. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.
 - b. The safety analyses performed in development of this special permit only considered the hazards and risks associated with transportation in commerce.
 - c. Party status will not be granted to this special permit.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR § 173.242 in that the use of non-DOT specification cargo tanks is not authorized except as specified herein.
5. BASIS: This special permit is based on the application of Accent Stripe, Inc. dated March 31, 2006, submitted in accordance with § 107.109.

7. SAFETY CONTROL MEASURES:

- a. PACKAGING - Packagings authorized are certain non-DOT specification cargo tanks securely bolted to a motor vehicle, used for roadway striping. Each tank is mounted to a vehicle with an identification number as listed in the special permit application on file with the Office of Hazardous Materials Special Permits and Approvals (OHMSPA). Only the vehicles which are listed by identification number in the application for special permit are authorized. Other vehicles may be used only after notifying OHMSPA in writing to amend the list and receiving written confirmation from OHMSPA that the amendment is approved.
- b. TESTING - External visual inspection of each tank must be performed before each use. Each tank must be tested in accordance with § 180.407(c) as specified for a DOT Specification 406 cargo tank motor vehicle, except that internal visual inspection of each tank must be performed annually.
- c. OPERATIONAL CONTROLS -
 - i. Each tank may not be filled so as to be liquid full at less than or equal to 130°F.
 - ii. Tanks must not be pressurized when the motor vehicle is traveling to and from job sites.

8. SPECIAL PROVISIONS:

- a. MARKING - Each vehicle must be plainly marked on both sides near the middle in letters at least two inches in

height on a contrasting background "DOT-SP 11714." Each vehicle identification number must be marked on both sides of the vehicle.

b. Hydrostatic test certificates for each tank must be maintained by the manufacturer or owner and be made available to any representative of the Department of Transportation upon request.

c. Packagings permanently marked 'DOT-E 11714', prior to October 1, 2007 may continue to be used under this special permit for the remaining service life of the packaging or until the special permit is no longer valid. Packagings marked on or after October 1, 2007 must be marked 'DOT-SP 11714'.

d. Shipping papers displaying 'DOT-E 11714' may continue to be used until October 1, 2007, provided the special permit remains valid.

9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.
10. MODAL REQUIREMENTS: A current copy of this special permit must be carried aboard each motor vehicle used to transport packages covered by this special permit.
11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:
 - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
 - o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat Employee", as defined in § 171.8 who performs a function subject to this special permit must receive training on the requirements and conditions of this


special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display its number, when the special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)- 'The Hazardous Materials Safety and Security Reauthorization Act of 2005' (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term 'exemption' to 'special permit' and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
