# DOT-SP 11753 (THIRTEENTH REVISION)

(FOR RENEWAL, SEE 49 CFR § 107.109)

- 1. GRANTEE: (See individual authorization letter)
- 2. PURPOSE AND LIMITATION:
  - a. This special permit authorizes the transportation in commerce of certain UN1H1 drums containing ammonia solutions placed within temperature controlled vehicles. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.
  - b. The safety analyses performed in development of this special permit only considered the hazards and risks associated with transportation in commerce.
  - c. Unless otherwise stated herein, this special permit consists of the special permit authorization letter issued to the grantee together with this document.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED</u>: 49 CFR § 173.24a(b)(4) except as specified herein.
- 5. <u>BASIS</u>: This special permit is based on the application of Ashland Chemical Company dated March 31, 2004, submitted in accordance with § 107.109.

### 6. HAZARDOUS MATERIALS (49 CFR § 172.101):

#### 7. SAFETY CONTROL MEASURES:

- a. <u>PACKAGING</u> Prescribed packagings must be certified to a minimum performance level of DOT UN1H1/Y1.2/150 or UN6HH1/Y2.0/300.
- b. OPERATIONAL CONTROLS Shipment must be by a dedicated contract carrier utilizing temperature controlled vehicles which maintain the temperature of the ammonia solution below that which would result in the internal pressure of the 1H1 drums exceeding 85 kPa.
- c. The driver must be trained in accordance with the refrigeration system failure plan and the specific emergency action guidance plan or the Handling and Shipping Information/Checklist on file with the Office of Hazardous Materials Special Permits and Approvals (OHMSPA). The plans and checklist must be carried on the motor vehicle for all shipments made under this special permit.

## 8. SPECIAL PROVISIONS:

- a. A person who is not a holder of this special permit who receives a package covered by this special permit may reoffer it for transportation provided no modification or change is made to the package or its contents and it is reoffered for transportation in conformance with this special permit and the HMR.
- b. Each drum must be marked "DOT-SP 11753" in accordance with the requirements contained in § 172.301(c).

- c. Packagings permanently marked 'DOT-E 11753', prior to October 1, 2007 may continue to be used under this special permit for the remaining service life of the packaging or until the special permit is no longer valid. Packagings marked on or after October 1, 2007 must be marked 'DOT-SP 11753'.
- d. Shipping papers displaying 'DOT-E 11753' may continue to be used until October 1, 2007, provided the special permit remains valid.
- 9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.
- 10. MODAL REQUIREMENTS: A current copy of this special permit must be carried aboard each motor vehicle used to transport packages covered by this special permit.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et</u> seq:
  - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
  - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
  - o Registration required by § 107.601  $\underline{\text{et seq.}}$ , when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when the special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)- 'The Hazardous Materials Safety and Security Reauthorization Act of 2005' (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term 'exemption' to 'special permit' and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
