This report describes the work activities and accomplishments during the July 2006 to June 2007 program year as required by the Training and Employment Guidance Letter (TEGL) No. 3-06. This report outlines the progress in each of the following core products and services.

A. Core Products and Services

1. Continue to populate the Workforce Information (formerly ALMIS) Database with state and local data.

Staff continued to populate and maintain America's Labor Market Information (ALMIS) core and other ALMIS database tables beyond the core requirements. All Core tables have been populated to the extent that the programs and data exist on Guam. Updated Occupational Licensing databases were submitted to the National Crosswalk Service Center for placement on the ACINet site. Now Guam's occupational licensing information databases including licensed occupations and licensing agencies as well as other occupational licensing information can be viewed online as part of the national licensing information system. In addition to licensing information, other occupational information for Guam including the highest paying jobs by occupation is included and accessible through this site.

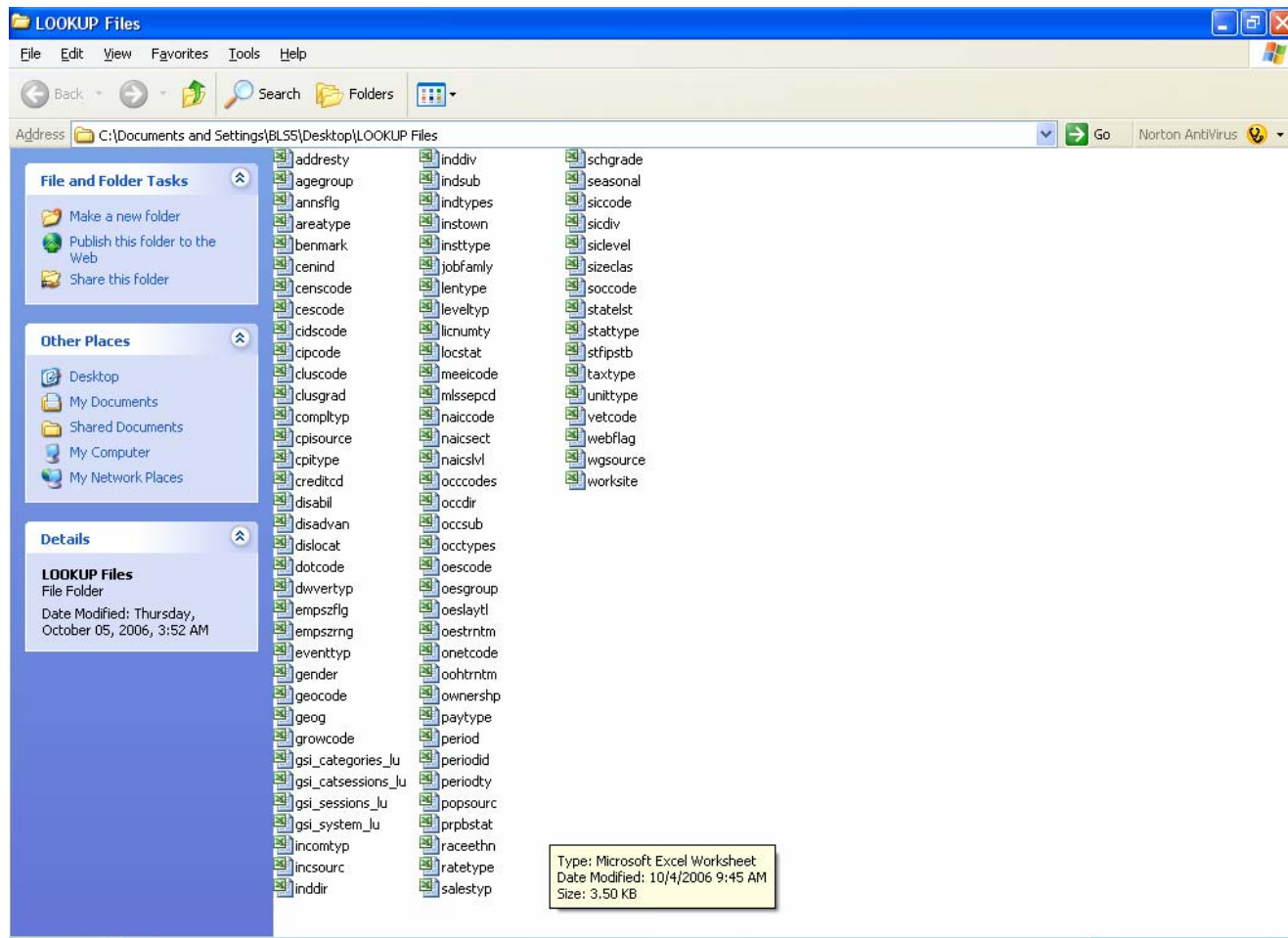

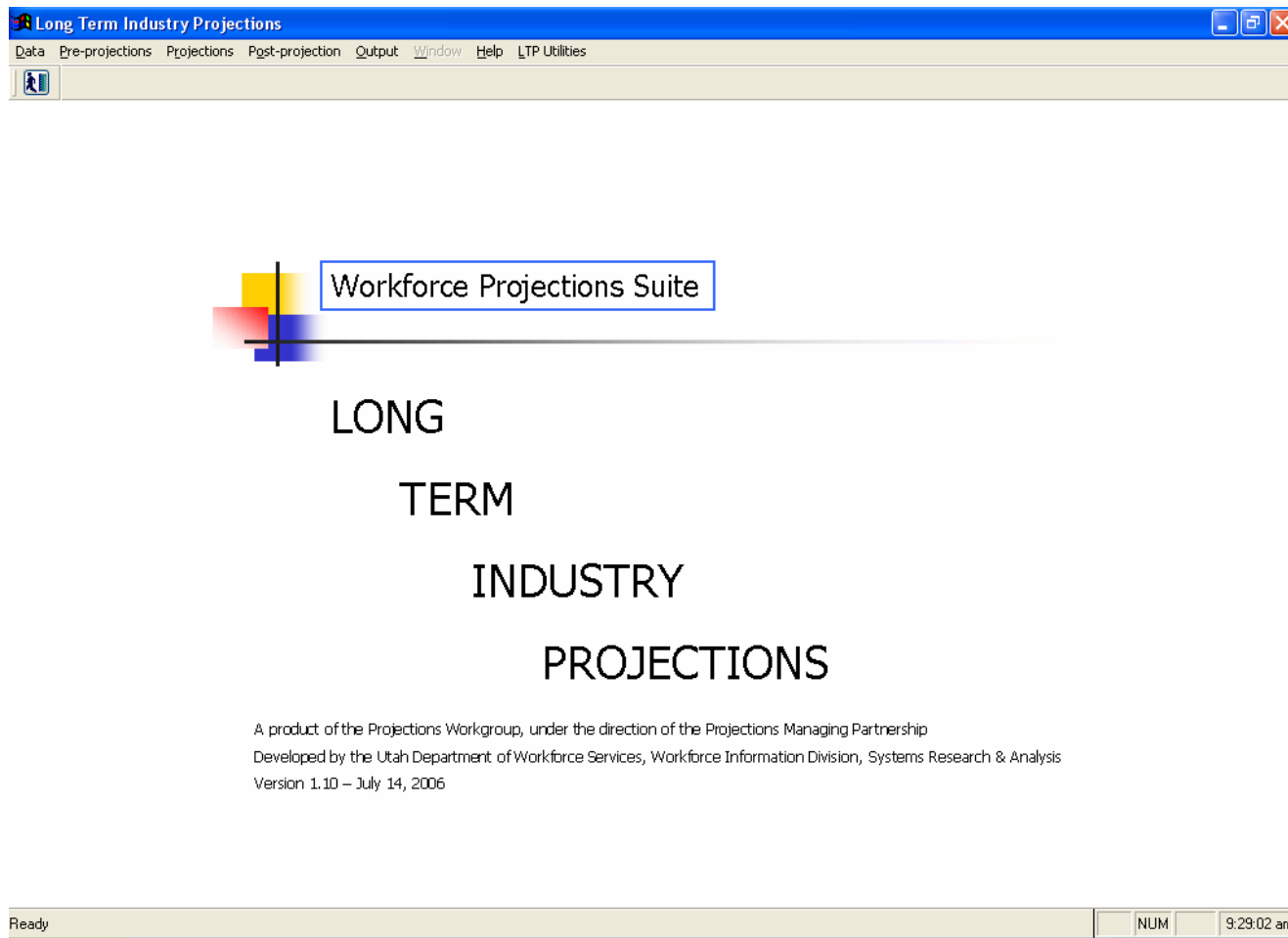
Now that Guam has populated ALMIS databases, they are accessible online where there is a national system to display them as noted above. However, for most of the databases, there is no national system for access and display. As the reader can see from the slides of a few of our populated database tables, the format is not suitable for use directly.

States, therefore, have either developed or contracted private vendors to provide search, access and display capabilities to make the user hostile database format accessible. Guam has reviewed the private vendor arrangements and found them to be expensive relative to the grant funding. Alternatively, the use of the ADAM system (Distributed Access Method) system under development by a consortium with North Carolina as the lead has had development delays and is not yet available outside of the test areas. We have therefore again through meetings of the state labor market information directors in the region sought the technical assistance and support to use existing software already developed and in use by other states. We specifically requested such support from the state of Oregon and discussions are underway regarding implementation of a system to make the remaining populated Guam ALMIS databases available online in the Oregon format. This format provides information from a variety of the databases such as licenses, wages, training and more in response to searches for specific occupations. This capability provides very focused and user friendly and customized information for a person looking for occupational information. Funding for making the software changes needed to use the software on Guam remains to be identified.

2. Produce and disseminate industry and occupational employment projections

One of the primary challenges of producing such information is the creation of an industry employment time-series database. As Guam does not have an unemployment insurance program and consequently the associated U.S. Department of Labor, Bureau of Labor Statistics, Quarterly Census of Employment and Wages Program (QCEW). In lieu of this Guam operates an Annual Census of Establishments survey program which provides the employer database for U.S. Department of Labor, Bureau of Labor Statistics cooperative statistical programs. The annual survey continues to be completed and during this program year, time-series employment data was compiled by Standard Industrial (SIC) industry categories and is available for 4, 3, 2 and industry division levels. This provides the foundation for producing industry trends using historical patterns.

The time-series data is in the process of conversion to the NAICS format to produce NAICS based industry formats. There are substantial developments expected on Guam in the future associated with plans to relocate approximately 8,000 Marines from Okinawa and equal number of dependents to Guam. This and other large scale defense construction plans as well as those of the local government and private industry has resulted in the need for specific plan and construction information which is now being collected systematically to support forecasts which involve substantial changes to employment beyond those shown in historical trend analysis. Guam continues to successfully operate the U.S. Department of Labor's Occupational Employment program which provides the database of occupational information required to develop occupational forecasts. Guam has obtained and is populating the long-term industry software to produce the long-term projections. New staff hired perform the employment projections have not been trained in using the software and procedures and such training has been planned and scheduled for early FY 2008 with projections to follow the training. The short-term projections software requires monthly time-series data. Guam does not have monthly time-series data. We discuss and work with the software trainers and developers to work through alternative approaches to producing the short-term projections.

3. Publish an annual economic analysis report for the governor and the SWIB.

An annual economic has been prepared and incorporated as a section into the Executive Budget each year. The FY 2008 Economic Outlook report fulfills this requirement.

4. Post products, information, and reports on the Internet.

All of the statistical reports produced by the Guam Department of Labor, Bureau of Labor Statistics are posted on the Department of Labor website at: www.guamdol.net Additionally, data produced in Federal/State cooperative statistical programs is posted on the respective federal agencies website so that data are available comprehensively as part of each national statistical program.

This funding provides the primary financial support for printing and decimation of occupational information products with both printing and on-line access. The publications of reports noted the milestones items including quarterly publication of the Current Employment Report, Annual publication of the Annual Census of Establishments, Annual Publication of an Economic Outlook report and Semi-Annual publication of the Occupational Employment and Wage Statistics reports have been accomplished as planned.

We provide Guam data on U.S. Department of Labor, U.S. Department of Commerce, America's CareerInfoNet and Department of Interior websites which provide data for states and territories including Guam as part of their respective statistical programs.

Labor. The Governor of Guam is vested with the authority to issue temporary labor certifications on Guam if, after testing the local labor market, it is found that: qualified U.S. citizens or permanent residents are not available to perform the required services and that employment of a non-immigrant alien will not adversely affect the wages and working conditions of U.S. resident workers who are similarly employed on Guam. This temporary certification is issued by the Guam Department of Labor for a period of one year or less. Extensions may be granted for a period not to exceed three consecutive years. Minimum wage is set by the prevailing U.S. rates.

WORKFORCE & LABOR MARKET

Guam's total non-government employment reached 43,660 in December 2006. With the public sector included, employment level is at 58,860. The main contributors are: a) services, which account for almost 30% of the total annual payroll and; b) retail trade at about 20%. The single largest contributor, the services sector, employed a total of 15,820 people. Many of these jobs are directly related to tourism which is Guam's primary industry. It injects more than \$1.5 billion into the island's economy each year from its 1.2 million visitors. These figures are expected to grow in the coming years as new markets (Taiwan, Korea and China) are developed and as the Japanese economy picks up (Japan is the number one source of Guam's in-bound travel). Local hotels are currently renovating and/or expanding their facilities in anticipation of this surge. With a robust local tourism, it is no wonder that wholesale and retail trade provided the next most number of jobs at 14,080 in the same period. The next leading employer is the transportation and public utilities (8.5%) followed by construction at 7.44% or about 4,380 jobs.

As regards public employment, the above table shows that 1 out of every 5 employed people in Guam works for the territorial government. Federal employment accounts for 6% of the total island employment.

The population of Guam is relatively young with the median age of 27.4 years. In 2004, Guam's total civilian population 16 years and older totaled 99,783. The labor force participation rate is 62%, meaning there are 61,523 working age residents who are willing and able to work and are either employed or actively seeking employment. The employment ratio in the same period is 57%. Guam's unemployment rate is 4.72%, slightly higher than the U.S. national average of 5.6%. There is no unemployment insurance requirement.

In terms of education, for school year 2005-2006, the University of Guam reported a total number of 370 graduates., 83% of whom were awarded an undergraduate degree while 17% earned a master's degree. The Guam Community College in 2005 reported a total of 10,268 enrollees. Twenty-three (23%) of whom were enrolled in certificate courses, 54% in continuing education classes, 17% were secondary students taking trade courses, and about 6% were in either an apprenticeship, journeyworker's or adult education programs.

Prevailing wage rates and labor laws in Guam are set, administered and enforced pursuant to 22 GCA "Guam Fair Labor Standards Act" which mirror that of U. S. federal labor laws (pursuant to section §101(a)(15)(h)ii of 8 U.S.C. 1186).

5. Partner and consult on a continuing basis with workforce investment boards:

Guam has one Workforce Investment Board. Various members individually request and receive information and reports primarily by e-mail as requested. The board is periodically provided reports and statistical information separately or as part of other information to support various activities. A specific annual presentation to the Board is conducted to provide an update on the information available, information systems enhancements and the economy. The milestones have been accomplished as planned. The agency director meets with the Workforce Investment Board regularly.

6. Conduct special studies and economic analyses.

Two major important special studies and economic analyses were produced this year. One special study on the Tourism industry under contract with the Guam Visitors Bureau was produced. A comprehensive report on federal expenditure trends was produced by the Department of Labor, Bureau of Labor Statistics. The Bureau of Labor statistics also produces time-series statistical tables on building permits and federal construction projects to produce leading information for future construction industry employment.
