# Tuesday, October 16, 2007

Chairman Mr. Basher called the meeting to order at 8:15 AM.

Mr. Dougherty introduced new members to the committee Charles Battaglia, Ron Chamrin, Carlos Martinez, Craig Burnette and Joseph Autry. Announced committee members' appointment terms and presented certificates of appointment from Secretary VA to Craig Burnette and Joseph Autry.

Mr. Dougherty continued the meeting with review of committee's annual report. Discussed findings on the subject of Permanent Housing. Mentioned that there are 2 new proposals in Congress which have multiple provisions for homeless veterans that was a direct result from findings in the committee's annual report. On the subject of Surplus Land he emphasized the committee suggestion that the VISN put in the performance plan the designation of a modest portion of property. Mr. Dougherty explained to the committee the concept of matching funds for Grant Per Diem. Discussed committee's recommendation for HUD-VASH to manage money not used and return to veteran pool.

Finally, Mr. Dougherty mentioned other significant issues in the Advisory Report. Items discussed were:

OEF/OIF homelessness and funding Dental Care program funding grown from 9 million to 10 million Multifamily housing significant challenges Mental Health Task Force

#### Mr. Paul Smits, Associate Chief Consultant, Homeless and Residential Treatment Programs, Department of Veterans Affairs

Provided an update of VA's Homeless Programs:

Explained that an outside consultant will be looking at Grant Per Diem program. Discussed more on the misconception VA funding Grant Per Diem.

HCHV and HCMI will get support from Congress.

There are as of the 3<sup>rd</sup> quarter of FY07:

330 Outreach Staff20,000 intakes48,000 services to homeless veteransContract programs with \$6.5 million in funding

Residential Treatment: Through GPD 15,000 veterans Through contract 1,000 veterans DOM Homeless based program 6,000 veterans

In terms of success:

60% of the veterans are housed after discharged from the DOM 55% more GPD compared to 30% in 2004

Employment for homeless veterans discharged from the DOM increased 40% From GPD program 50% HCHV 40%

Future Initiatives: Incarcerated veterans see 5,000veterans to connect with community and VA services In 2008 request for 17 additional Specialist Network Homeless Coordinator in each VISN

Chairman Basher called the meeting to order at 8:30 AM.

# National Coalition of Homeless Veterans (NCHV) Mr. John Driscoll assistant to Ms. Cheryl Beversdorf, President &CEO

Mr. Driscoll emphasized the progress in the following areas:

- Technical assistance grants
- GPD tripled from 250 to 3,000 organizations

Progress because of two tracks approaches: Interactive and communication

These approaches have contributed to five areas of concentration:

- 1) Consultations on GPD applications to complete
- 2) Resource diversity and potential investors/new funding sources
- 3) Veterans access to program services other than VA
- 4) Regional and National training/ Chaleng process

5) Training and consultations on permanent housing and transition models Increase in Special Needs grants

# Jim McGuire NEPEC Director/CHALENG Evaluator on Incarcerated Veterans

Veterans are 12% of prison population

Planning conference to outreach to prisons. Will be done in two phases.

Phase 1: Central goal to get to get these veterans connected to VA

Hire 21 Re-entry specialist for VISN basing with highest concentration of prisoners

Phase 2: Access issues Point of Contact for Primary Care/HP/SA/MH Working toward a national access system Goal to contact 5,000 prisoners annually and get at least half of them in case management

Focus on 10 year plan to decrease chronic homelessness community from baseline

The plan concentrates in these areas:

Regional with use of ICH resource guide State Department of Veterans Affairs developing plans for housing homeless veterans Encourage VA growing involvement GPD Identifying innovations and best practices: Project Homeless Connect, assertive Community Intervention

Challenging issues:

Plans do not translate to a specific strategy Lack of understanding from providers of VA as a resource Inaccurate reports on progress
