I just wanted to follow-up with you regarding the above referenced issue concerning the potential redevelopment of the Existing Airport Site. The FAA has determined that **formal** consultation with the U.S. Fish and Wildlife Service is not appropriate or required at this time due to the fact that final redevelopment plans for the existing Panama City airport have not been selected or approved by local officials. Any analysis of potential adverse immpacts to federally-listed species resulting from redevelopment of the existing airport site at this time would be premature and a waste of your staff resources and the FAA's. particularly considering that more reliable information will be available before FAA takes any further Federal action(s) necessary for reuse of the existing airport site.

Virginia, future release of the airport property would not require EFH consultation unless there are development conditions attached to the release which would require 'on the ground" activities that may adversely affect EFH. Simple release (a title transfer type of

activity) by itself should not impact EFH and, thus, would not trigger the Magnuson-Stevens Act consultation requirement. On the other hand, after release, if the new owner of the property pursues activities which may adversely affect EFH and require federal permits or other federal approvals or funding, the agency(s) responsible for those actions would be required to consult.

Of course my comments on the matter are advisory, since it is FAA's responsibility to make the initial determination of whether disposal of the airport property requires EFH consultation. If this is confusing in any way, let me know and we can discuss or correspond further.
