Request for Proposals: National Forest Foundation Community Assistance Program

The National Forest Foundation (NFF), chartered by Congress, engages America in community-based and national programs that promote the health and public enjoyment of the 192-million-acre National Forest System, and administers private gifts of funds and land for the benefit of the National Forests. The NFF believes that communities should play a significant role in determining the future of our National Forests and Grasslands.



The NFF established the Community Assistance Program (CAP) to promote the creation of locally-based, collaborative natural resource partnerships which seek to build ecological, social and economic sustainability. The program will support newly-forming or re-organizing non-profit organizations that are in need of start-up funds for capacity building that intend to proactively and inclusively engage the local community in forest management and conservation issues on and around National Forests and Grasslands.

CAP awards provide collaborative groups with start-up grants of \$5,000 to \$15,000, as well as basic tools and guidance, to enable them to resolve differences and play a more active role in the sustainable management of nearby National Forests, Grasslands and surrounding communities. CAP will support the organizational and technical assistance needs of newly forming or reorganizing, multi-party collaborative groups that act as problem-solvers, bringing diverse members of the community together to address specific issues related to community-based forest stewardship, recreation, watershed restoration, and wildlife habitat, through constructive dialogue and hands-on involvement.
