ARIZONA COLLATERAL SCHEDULE

261.1 Scope.

- (a) The prohibitions in this part apply, except as otherwise provided, when:
- (1) An act or omission occurs in the National Forest System or on a Forest road or trail.
- (2) An act or omission affects, threatens, or endangers property of the United States administered by the Forest Service.
- (3) An act or omission affects, threatens, or endangers a person using, or engaged in the protection, improvement or administration of the National Forest System or a Forest road or trail.
- (4) An act or omission occurs within the designated boundaries of a component of the National Wild and Scenic Rivers System.
- (b) Nothing in this part shall preclude activities as authorized by the Wilderness Act of 1964 or the U.S. Mining Laws Act of 1872 as amended.

TITLE 36 CODE OF FEDERAL REGULATIONS

SUB-PART A - GENERAL PROHIBITIONS

Forest Officer means an employee of the Forest Service.

<u>Permit</u> means authorization in writing by a forest officer.

Persons means natural person, corporation, company, partnership, trust, firm or association of persons.

<u>National Forest System</u> includes all national forest lands and waters reserved or withdrawn from the public domain of the United States, national forest lands and waters acquired through purchase, exchange, donation or other means, National Grasslands and land utilization projects and waters administered under title III of the Bankhead-Jones Farm Tenant Act (50 Stat.535,7 U.S.C. 1010-1012), and other lands, waters, or interests therein acquired under the Wild and Scenic River Act (16 U.S.C. 1271-1287) or National Trails System Act (16 U.S.C. 1241-1249).

<u>Permission</u> means oral authorization by a forest officer.

State means any State, the Commonwealth of Puerto Rico, and the District of Columbia.

<u>State Law</u> means the law of any State in whose exterior boundaries an act or omission occurs regardless of whether State Law is otherwise applicable.

<u>Volunteer or host enrollee</u> means any person, not a forest Service employee officially participating in a Forest Service human resource program as authorized by and act of Congress and identified to accomplish one or more of the following objectives; provide skills training; education; useful work; develop understanding of ecological systems and conservation or natural resources; build cultural and communication bridges between various socioeconomic groups; and further the administration, development and management of National Forest resources, forest research, and State and Private Forest activities.

261.3 INTERFERING WITH A FOREST OFFICER, VOLUNTEER, OR HUMAN RESOURCE PROGRAM ENROLLEE OR GIVING FALSE REPORT TO A FOREST OFFICER.

<u>Campfire</u> means a fire, not within any building, mobile home or living accommodation mounted on a motor vehicle, which is used for cooking, personal warmth, lighting, ceremonial or esthetic purposes. Fire includes campfire.

<u>Stove fire</u> means a campfire built inside an enclosed stove or grill, a portable brazier, or a pressurized liquid or gas stove, including a space-heating device.

<u>Unauthorized livestock</u> means any cattle, sheep, goat, hog, or equine not defined as a wild free-roaming horse or burro by & 222.20(b)(13), which is not authorized by permit to be upon the land on which the livestock is located and which is not related to use authorized by a grazing permit; provided, that noncommercial pack and saddle stock used by recreationists, travelers, other Forest visitors or occasional trips, well as livestock to be trailed over an established driveway when there is no overnight stop on Forest Service administered land do not fall under this definition.

261.9 PROPERTY

<u>Archaeological resource</u> means any material remains of prehistoric or historic human life or activities which are of archaeological interest an are at least 50 years of age, and the physical site, location, or context in which they are found.

<u>Cave</u> means any naturally occurring void, cavity, recess, or system of interconnected passages beneath the surface of the earth or within a cliff or ledge and which is large enough to permit a person to enter, whether the entrance is excavated or naturally formed. Such term shall include any natural pit, sinkhole, or other opening which is an integral part of the cave.

<u>Cave resource</u> means any materials or substances occurring in caves including, but not limited to, biotic, cultural, mineralogic, paleontologic, geologic, and hydrologic resource.

<u>Damaging</u> means to injure, mutilate, deface, destroy, cut, chop, girdle, dig, excavate, dill or in any way harm or disturb.

<u>Historic resource</u> means any structural, archaeological, artifactual or other material remains of past human life or activities which are of historical interest and are at least 50 years of age, and the physical site, location, or context in which they are found.

<u>Paleontological resource</u> means any evidence of fossilized remains of multicellular invertebrate and invertebrate animals and multicellular plants, including imprints thereof. Organic remains primarily collected for use as fuel such as coal and oil are Paleontological Resources, but are excluded from the prohibitions under the rule.

<u>Prehistoric resource</u> means any structural, architectural, archaeological, artifactual or other material remains of past human life or activity generally prior to the advent of written records and of anthropological interest, and the physical site, location, or context in which they are found.

OCCUPANCY AND USE

<u>Distribution of printed material</u> - means disseminating, posting, affixing, or erecting printed material as defined in this section.

<u>Operating plan</u> means a plan of operations as provided for in 36 CFR part 228, subpart A, and a surface use plan of operations as provided for in 36 CFR part 228, subpart E.

<u>Printed material</u> - any written and/or graphic material including but not limited to pamphlets, brochures, photographs, graphics, signs and posters.

<u>Special-Use authorization</u> means a permit, term permit, lease or easement which allows occupancy or use rights or privileges of National Forest System land.

261.12NATIONAL FOREST SYSTEM ROAD AND TRAILS

<u>Forest road or trail</u> means a road or trail wholly or partly within or adjacent to and serving the National Forest System that the Forest Service determines is necessary for the protection, administration, and utilization of the National Forest System and the use and development of its resources.

<u>National Forest System road</u> means forest road other than a road which has been authorized by a legally documented right-of-way held by a State, county, or other local public road authority.

<u>National Forest System trail</u> means forest trail other than a trail which has been authorized by a legally documented right-of-way held by a State, county, or other local public road authority.

<u>Vehicle</u> mean any device in, upon, or by which any person or property is or may be transported, including any frame, chassis, or body of any motor vehicle, except devices used exclusively upon stationary rails or tracks.

<u>Motor vehicle</u> means any vehicle which is self-propelled, other than: (1) A vehicle operated on rails; and (2) Any wheelchair or mobility device, including one that is batterypowered, that is designed solely for use by a mobility-impaired person for locomotion and that is suitable for use in an indoor pedestrian area.

261.13 Motor vehicle use.

After National Forest System roads, National Forest System trails, and areas on National Forest System lands have been designated pursuant to 36 CFR 212.51 on an administrative unit or a Ranger District of the National Forest System, and these designations have been identified on a motor vehicle use map, it is prohibited to possess or operate a motor vehicle on National Forest System lands in that administrative unit or Ranger District other than in accordance with those designations, provided that the following vehicles and uses are exempted from this prohibition:

- (a) Aircraft;
- (b) Watercraft;
- (c) Over-snow vehicles;
- (d) Limited administrative use by the Forest Service;
- (e) Use of any fire, military, emergency, or law enforcement vehicle for emergency purposes;
- (f) Authorized use of any combat or combat support vehicle for national defense purposes;
- (g) Law enforcement response to violations of law, including pursuit;
- (h) Motor vehicle use that is specifically authorized under a written authorization issued under Federal law or regulations; and
- (i) Use of a road or trail that is authorized by a legally documented right-of-way held by a State, county, or other local public road authority.

261.14 Use by over-snow vehicles.

It is prohibited to possess or operate an over-snow vehicle on National Forest System lands in violation of a restriction or prohibition established pursuant to 36 CFR part 212, subpart C, provided that the following uses are exempted from this section:

- (a) Limited administrative use by the Forest Service;
- (b) Use of any fire, military, emergency, or law enforcement vehicle for emergency purposes;
- (c) Authorized use of any combat or combat support vehicle for national defense purposes;
- (d) Law enforcement response to violations of law, including pursuit;
- (e) Use by over-snow vehicles that is specifically authorized under a written authorization issued under Federal law or regulations; and
- (f) Use of a road or trail that is authorized by a legally documented right-of-way held by a State, county, or other local public road authority.

<u>Camping</u> means the temporary use of National Forest System lands for the purpose of over night occupancy without a permanently-fixed structure.

<u>Camping equipment</u> means the personal property used in or suitable for camping, and includes any vehicle used for transportation and all equipment in possession of a person camping. Food and beverage are not considered camping equipment.

<u>Developed recreation site</u> means an area which has been improved or developed for recreation.

261.18 NATIONAL FOREST WILDERNESS

<u>National Forest wilderness</u> means those parts of the National Forest System which were designated units of the National Wilderness preservation System by the Wilderness Act of September 3, 1964, and such other areas of the National Forest Systems as are added to the wilderness system by act of Congress.

<u>Motorized equipment</u> means any machine activated by a non-living power source except small battery-powered handcarried devices such as flashlights, shavers, Geiger counters, and cameras.
