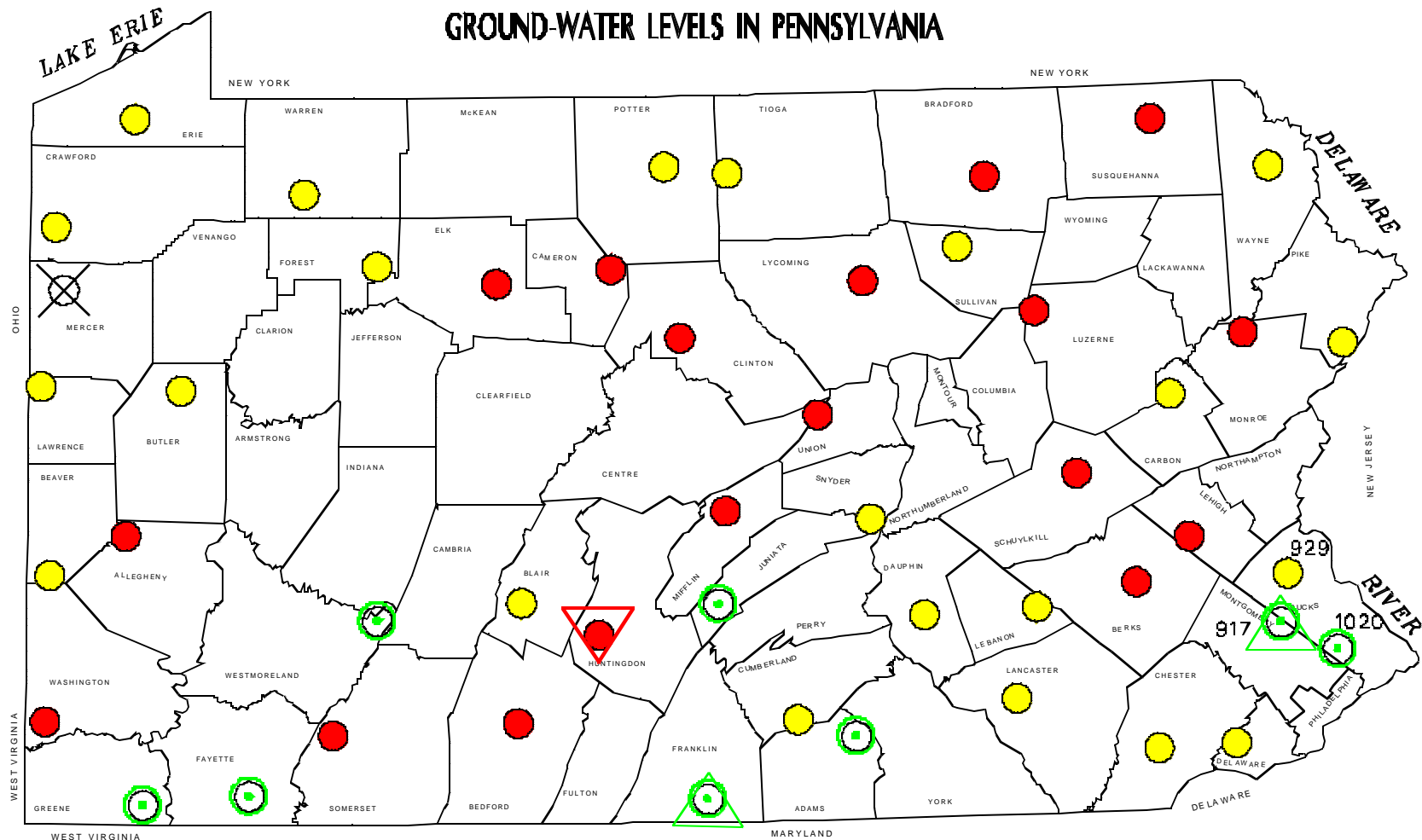
NOTE:

MEAN WATER LEVELS IN OBSERVATION WELLS
