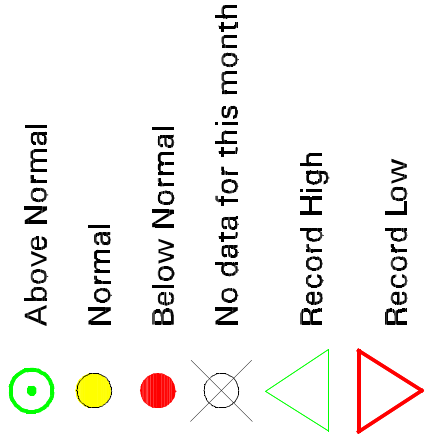
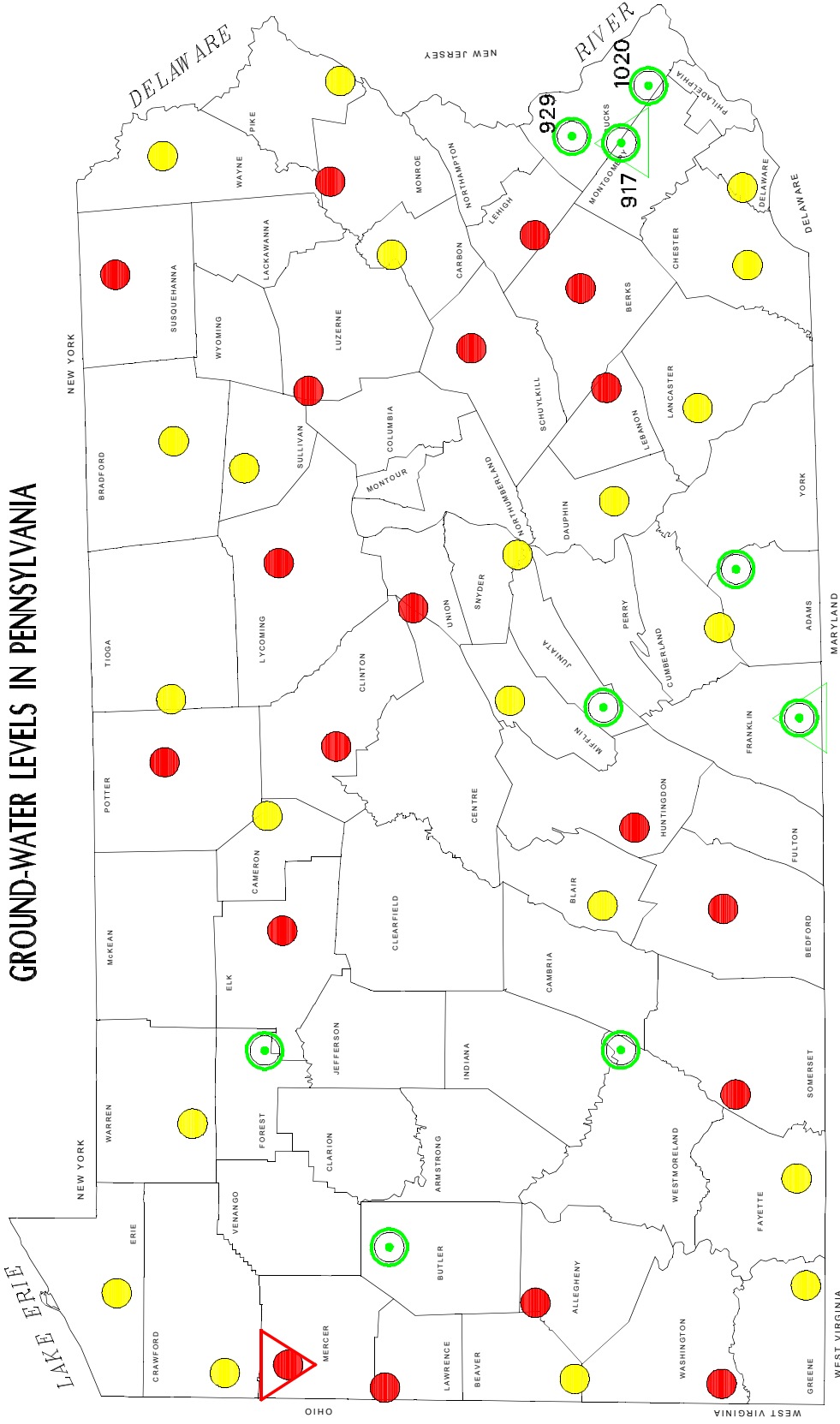
NOTE:
