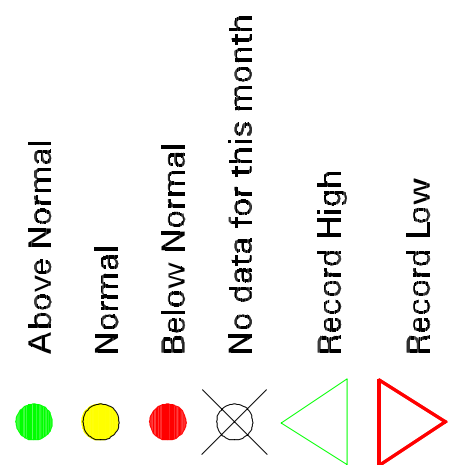
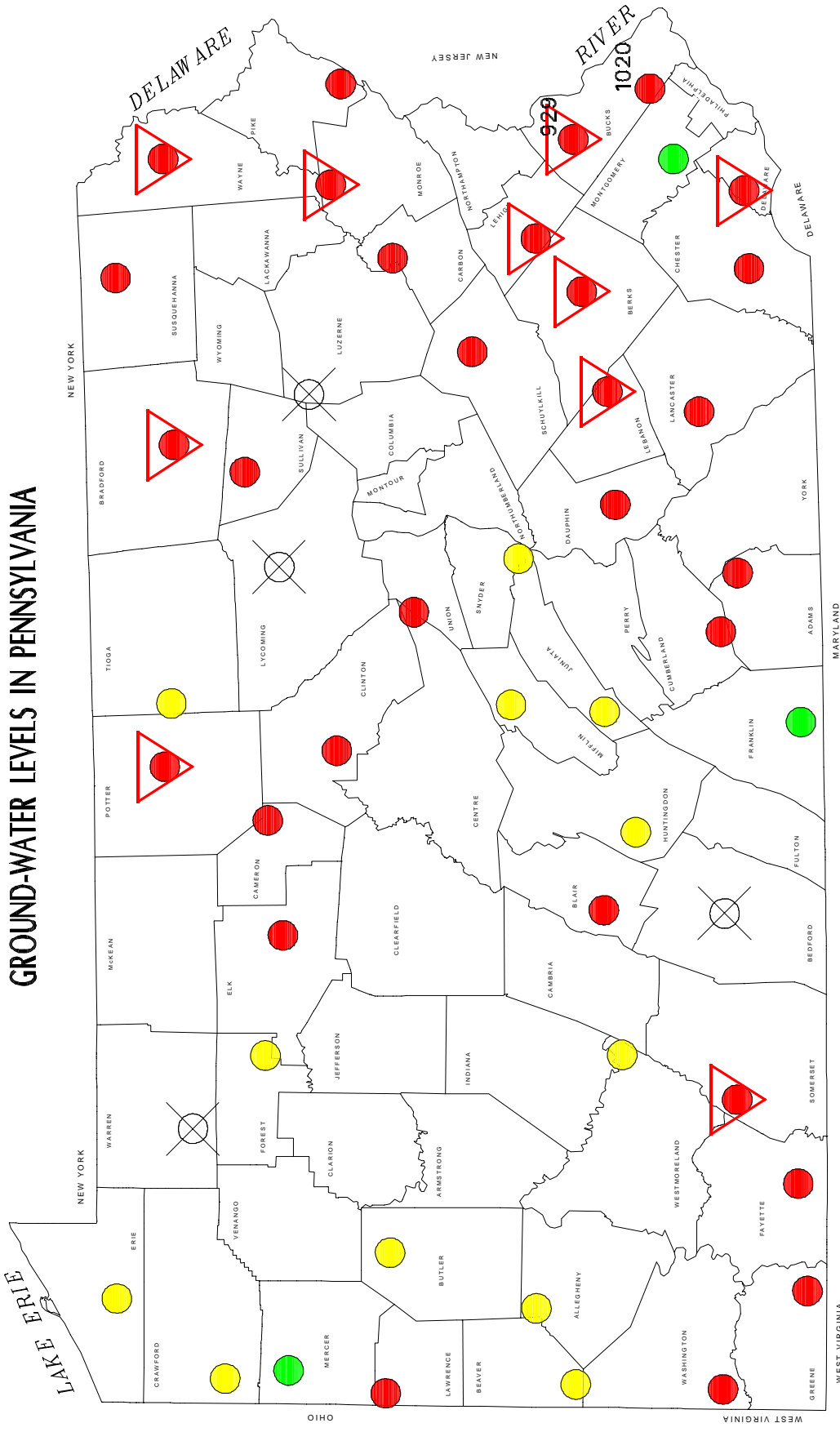

MEAN WATER LEVELS IN OBSERVATION WELLS
