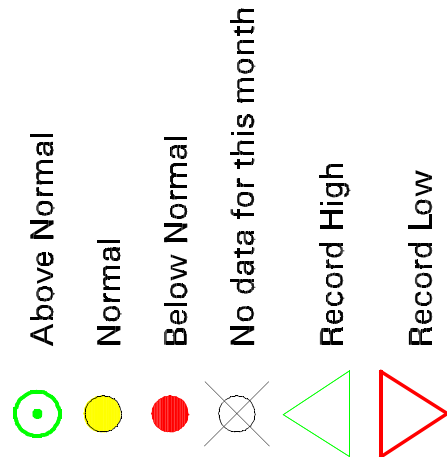
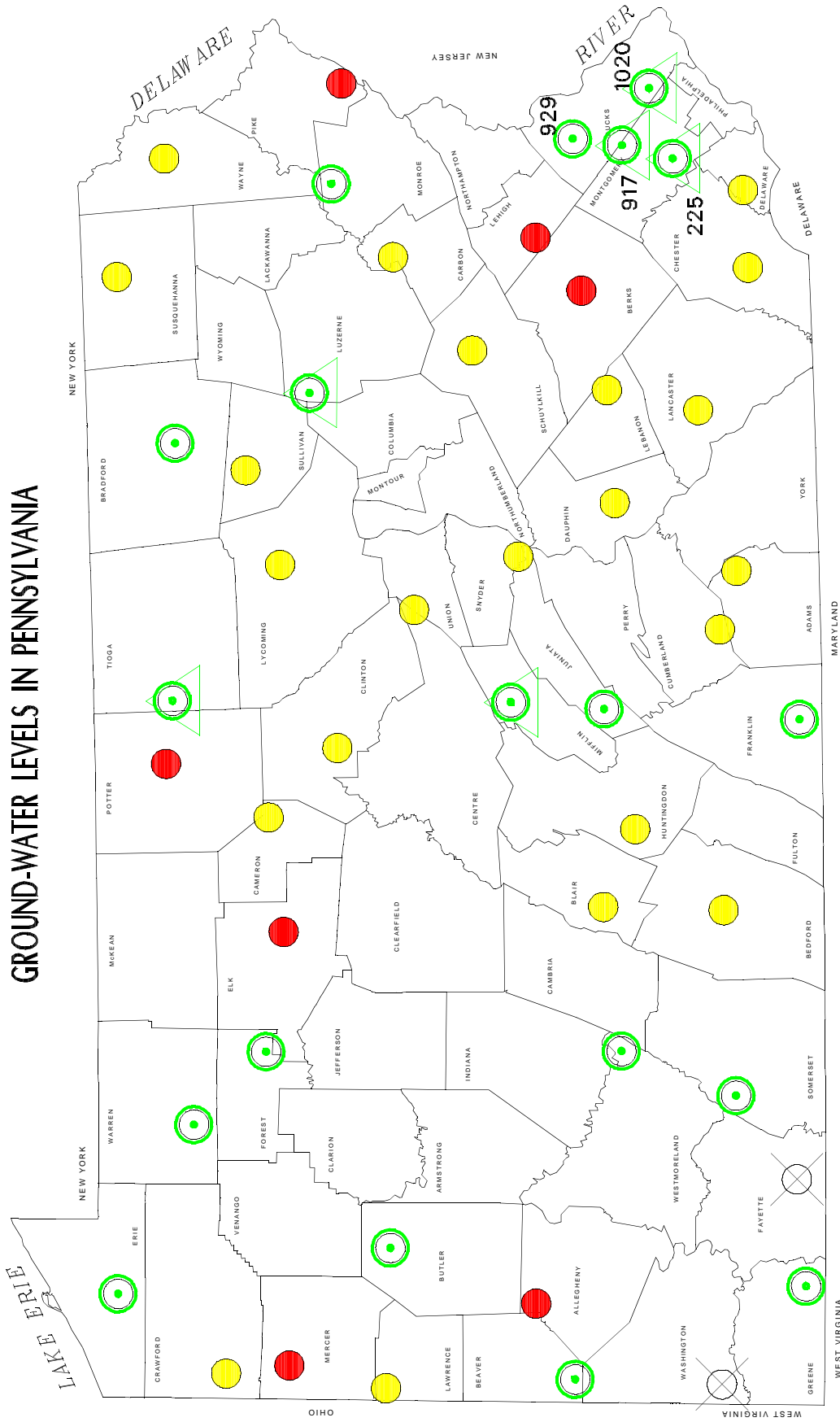
NOTE:
