

#### Malheur National Forest

- All paved road's (hard surface) single or double lane are closed to ATV'S.
- All double lane gravel roads are closed to ATV'S.
- Roads determined to be inappropriate for mixed ATV/passenger car traffic will be posted "closed" to ATV use, following similar signing anticipated for the Backcountry Discovery Route. This will include signing at National Forest entrances explaining which roads are closed to mixed traffic. Signing will be consistent throughout the three Blue Mountain Forests, especially where roads cross administrative boundaries.





The Umatilla, Malheur and Wallowa-Whitman National Forests now require the Oregon State Parks and Recreation ATV Operating Decal when operating ATV's. Decals can be purchased through the Oregon State Parks and Recreation offices or their vendors. A current vendor list is available online

www.prd.state.or.us /atv\_vendors.html. Proceeds from the sales of the decals are available

competitively to help support ATV activities including the maintenance of current trails, constructing new trails, and trail management and enforcement of regulations governing use.

The three National Forests will work together to develop a long-term strategy beginning this fall. This strategy will include active public involvement, and will closely reflect any additional changes by the State of Oregon. This interim strategy is designed to respond to changes brought about by the State of Oregon, while providing for user safety for people operating ATVs, as well as others that may encounter ATVs under mixed traffic conditions. Each National Forest has completed some degree of access and travel management planning and decisions over the past ten years. Decisions made on individual roads under those processes are not expected to change. In the State of Washington, no changes have been made and it is still illegal to operate ATV's on roads open to passenger vehicle traffic.
