ORDER OF THE FOREST SUPERVISOR CLOSING AN AREA TO ENTRY, TO WIT:

TEMPORARY ROAD AND AREA CLOSURE ORDER IN AFFECTED TORNADO AREAS LAKEWOOD-LAONA RANGER DISTRICT CHEQUAMEGON-NICOLET NATIONAL FOREST

Under authority of the Act of Congress of June 4, 1897, as amended (16 USC 551), and pursuant to the Secretary of Agriculture's Regulations set forth at 36 CFR 261, Subpart B (36 CFR 261.50(a) and (b), the following acts or omissions are prohibited in the "Tornado Affected Area" located on the Chequamegon-Nicolet National Forest, Lakewood-Laona Ranger District, Langlade and Oconto Counties, Wisconsin, said area being described:

1. Using any type of motorized vehicle on forest development Forest Roads (36 CFR 261.54(a)). For Public Safety, it is prohibited to go into or be upon any area closed (36 CFR 216.53(e)).

AREA AFFECTED: **Old Graves Rd** (**FSR 2317**) **Dispersed Camp Site**; Township 31 North, Range 15 East, Sections 9. **Boulder Lake Bike Trail**: at its intersection with Traxels Point Road (FR2045) in Township 31 North, Range 15 East, Section 20, SW1/4NW1/4, northward to the trails intersection with Old Graves Road (FR2317) Township 31 North, Range 15 East, Section 18. NE1/4NW1/4.

2. For Public Safety, it is prohibited to go into or be upon any area closed (36 CFR 216.53(e)).

AREA AFFECTED: **Spring Lake Dispersed Campsite**: Township 31 North, Range 15 East, Section 20.

THESE RESTRICTIONS ARE NECESSARY FOR PUBLIC SAFETY AND TO PROTECT NATIONAL FOREST PROPERTY. THEY ARE IN ADDITION TO THE GENERAL PROHIBITIONS SET FORTH IN 36 CFR 261. THE PROHIBITIONS WILL BE IN EFFECT FROM THE DATE OF THIS ORDER UNTIL SPECIFICALLY WITHDRAWN BY TERMINATION ORDER OF THE FOREST SUPERVISOR.

THIS ORDER SUPERCEDES AND RECINDS FOREST ORDER R9 13-07-06.

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this order:

- 1. Persons with a permit specifically authorizing the otherwise prohibited act or omission.
- 2. Any Federal, State, or local officer or member of any organized rescue or fire fighting force in the performance of an official duty.

Violations of these prohibitions are punishable by a fine of not more than \$5,000 for an individual and \$10,000 for an organization, or imprisonment for not more than SIX (6) months, or both. (16USC 551, 18 USC 3559 and 3571).
