FIRE CLOSURE

Pursuant to 36 CFR 261.50(a), the following acts are prohibited on the area described in this order and depicted on Exhibit A, within and/or administered by the Gifford Pinchot National Forest, Mount Adams Ranger District, until further notice:

1. Going into or being upon the area affected by the Cold Springs Fire. (36 CFR 261.52(e))

AREA DESCRIPTION:

The following description serves as the exterior boundary and closes all lands encompassed within it as depicted in attached Exhibit A:

From a beginning point at the intersection of National Forest System (NFS) Road 8040 and Morrison Creek Trail #39 in the NE corner of Section 22, T7N, R10E. Travel E along the North side of Trail #39 about 2.0 miles to the junction of Gotchen Creek Trail #40. Go SE along the N side of Trail #40 to the junction of NFS Road 8020, then E along the N side of NFS Road 8020 to NFS Road 8225-150. Then go E along the N side of NFS Road 8225-150 to NFS Road 8200-071. Travel SE along the NE side of NFS Road 8200-071 to the junction of NFS Road 8200-060. Turn E and travel along the N side of NFS Road 8200-060 to the junction of NFS Road 8200. Travel E along the N side of NFS Road about 0.5 miles to the junction of NFS Road 8290. Turn NE and travel along the NW side of NFS Road 8290 for 0.25 miles to the GPNF (Gifford Pinchot National Forest) boundary in the SE corner of Section 16, T7N, R11E. Then go N along the E boundary of the GPNF to the SE corner of Section 32, T8N, R11E near the 5900 foot elevation. Travel W about 1.75 miles to NFS Road 8040-550 and Cold Springs Campground. Then travel generally SE along NFS Road 8040-500 to its junction with NFS Road 8040. Travel S along the E side of NFS Road 8040 about 4.0 miles to the beginning point.

Exclusions to the Fire Closure Area: The geographic feature known as the AG Aiken Lava Flow, NFS Road 8225-150 N of its junction with NFS Road 8200-071 and a signed corridor 50 feet in width leading from the terminus of NFS Road 8225-150 to the AG Aiken Lava Flow.

Pursuant to 36 CFR 261.50 (e), the following persons are exempt from this Order:

- (1) Persons with a permit specifically authorizing the prohibited act or omission.
- (2) Any Federal, State, or local law enforcement officer or a member of an organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.


