- ★ The Office of **Health Data and Informatics (HDI)** and its program offices focus on advancing and improving the understanding of health information and electronic health records within VHA and beyond.
- ★ The **VA / DoD Health IT Sharing (HITS) Program** facilitates and supports the development of critical health information sharing between VHA and the Department of Defense (DoD) Military Health System.

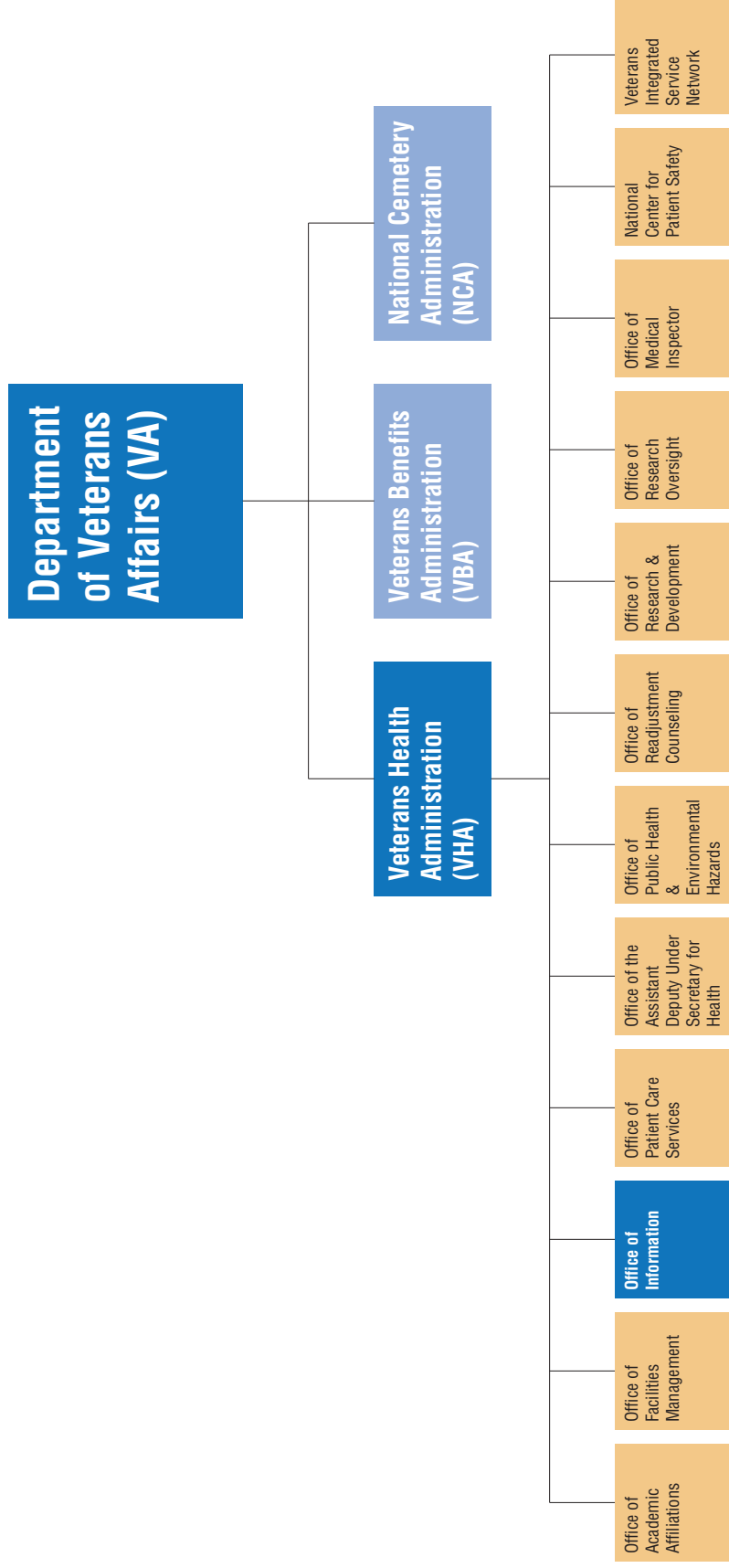

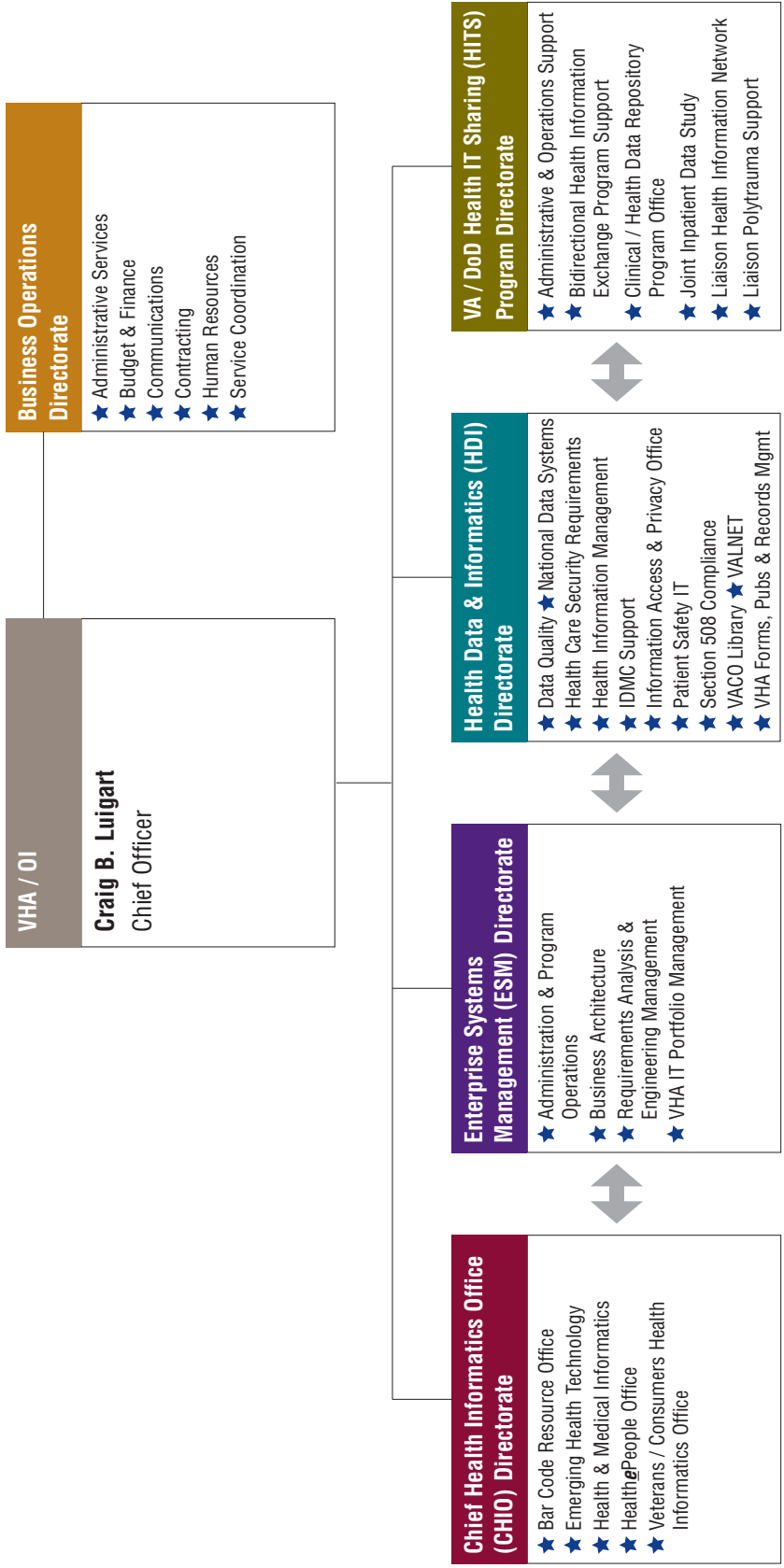

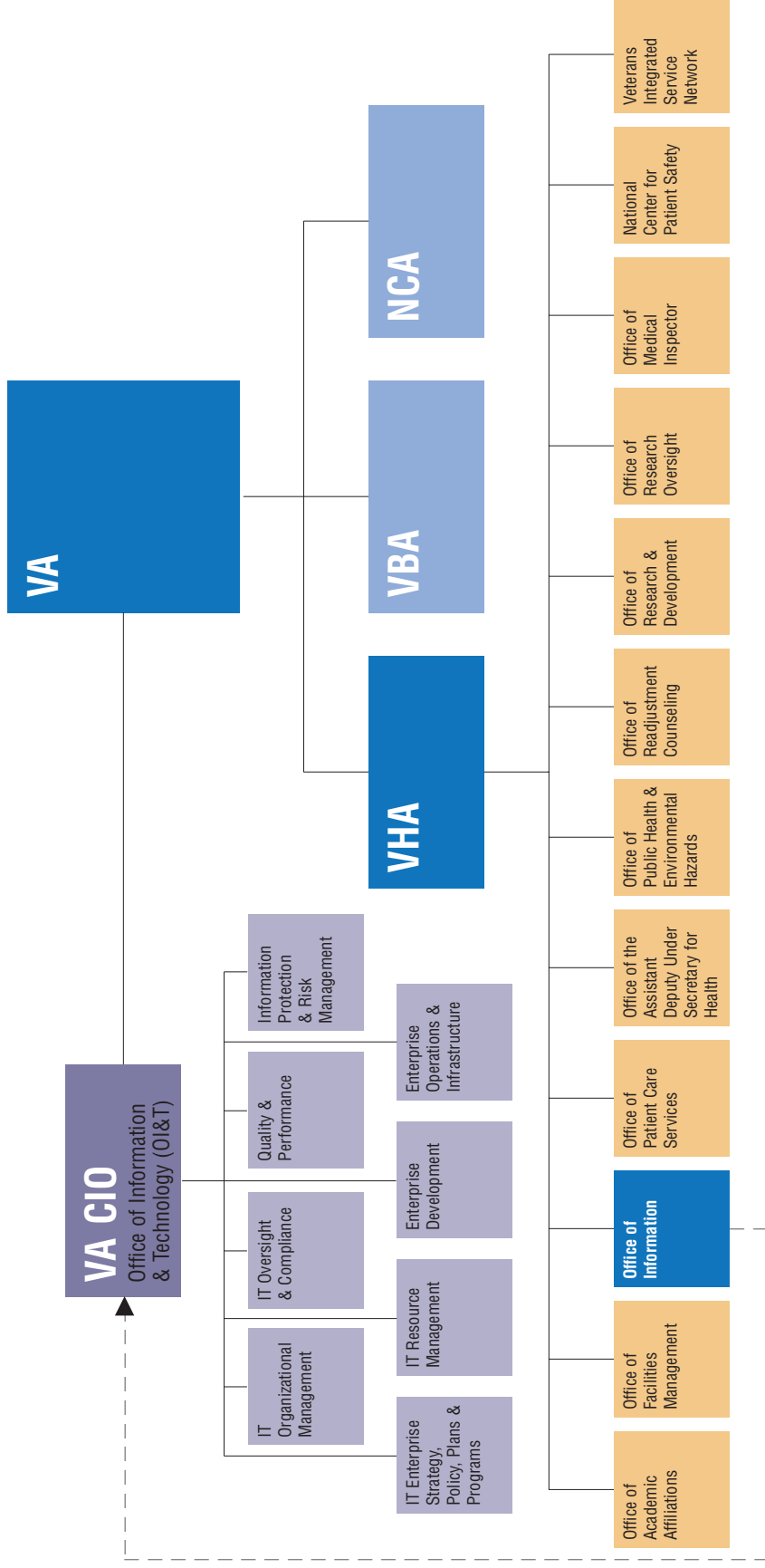
# Veterans Health Administration Core Offices

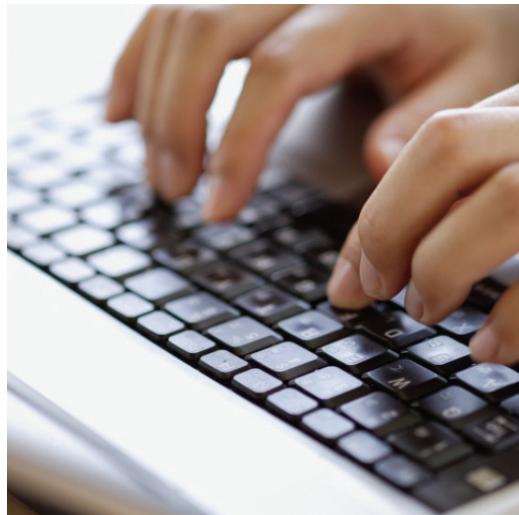
