#### Fisheries managers need guts






## Our Vision for Recreational Fisheries

- Conduct public team meetings to match regional activities with the national priorities
- Develop regional work plans based on team input
- Collect and report regional activities to the National Implementation Team for coming year AOP development
- Meeting twice annually with other regional coordinators
