

CDX Goals for Environmental Reporting

- Minimize cost to EPA program offices
 - Development
 - Maintenance
- Reduce time to build and deploy new data flows
- Provide a shared service that meets unique program needs
- Meet all Federal electronic reporting requirements
- Keep it as simple as possible for programs to build new reporting data flows

What is CDX-Lite?



- A secure Web-based reporting service that supports the transfer of data from external entities into the Agency
- A streamlined approach to developing and maintaining EPA program data flows
- Primarily supports file transfers, limited fielded text and attributes about the submitters and data



Services Provided by CDX-Lite

- Consolidated Life-Cycle Development Combines requirements, design and development phases
- Data flow and registration development A menu driven and visual approach
- Automatic Utilization of Services
 - Web Services deliver to EPA Program Systems
 - Document Zipping, Encryption, and PKI Signature
 - Email Notices, CDX Web Document Messaging documents one account to another
 - Quality assurance services
- Transaction History Provides a web-based Transaction History Menu for users
- Documentation Service All new designs and requirements are loaded directly into CDX-Lite Metadata Tables eliminating paper documentation
- Project Plan- All work conducted using a standardized project plan

CDX-Lite Developer Tools



- **CDX-Lite Registration Provisioning** Quickly defines new data flow functions to CDX without coding
- **CDX-Lite Designer** Used by customers to design their own CDX-Lite flows
- **CDX-Lite Submitter** Submit designs requested by customers for review and publishing
- CDX-Lite Publishing
 - Captures submitted designs
 - Streamlines data flow review/approval
 - Publishes new Data Flows to Test & Production.



CDX-Lite Service Limitations

- Primarily used for file transfers
- Basic Web-form functions
 - Radio buttons and check boxes
 - Drop-down boxes
 - Generic field inputs
- Edit checking for batch files only



Benefits of CDX-Lite



- Significantly reduces time and costs to establish requirements and design
 - Real-time requirements capture with the customer
- Eliminates development costs through reusable components
- Reduces maintenance single versus many systems
- Meets many unique program requirements
- Reduces costs for security, software certification, and learning curve to use and maintain CDX core services
- Opens the door for smaller reporting programs
- Will support compliance with EPA's Cross-Media Electronic Reporting Rule
- Reduces financial risk to program offices through fixed pricing
- Reduces contract administration time and cost through streamlined procurement



What is eBeaches?

The CDX eBeaches (electronic Beach Environmental Assessment and Coastal Health System) is a system that helps states submit Beach Locational, Monitoring and Notification Data to the EPA via CDX. These resources will assist you in meeting data reporting requirements under the BEACH Act Grants Program.

How will Beach Monitoring data be submitted?

Beach monitoring data (advisories and closings) can be submitted using the Central Data Exchange (CDX).

CDX is a single portal on the Web for environmental data entering EPA. It offers States, Territories, Tribes and other entities a faster, easier, more secure reporting option. CDX is EPA's point of entry on the National Environmental Information Exchange Network (NEIEN).

Can Notification data also be submitted using CDX?

Yes. While you may only be responsible for Monitoring data, another organization within your state or territory may be responsible for submitting Notification data. To submit Notification data, return to the "My CDX" page, and go to "Available Account Profiles", select "eBeaches:Notification", and follow the instructions.

This web site provides resources for submitting Beaches Monitoring data to the EPA.

How can this tool be used?

The **new** Beaches Monitoring Data Roadmap describes how to submit Beaches Notification data to the EPA. The Roadmap contains the following steps:

1. Prepare your monitoring data. For further information on preparation tools available please go to your Beaches Data User Corner

2. Save your formatted data on your workstation

3. Press the [browse] button, below and select your saved formatted data and press the [send] button.

4. Check your Transaction History for confirmation that your Beaches Monitoring Data submission to the EPA is complete.
