#### **Spring Training Conference**

One of the high points of this year's Spring County Veterans Service Officers (CVSO) Conference-a training conference sponsored by the Oregon Department of Veterans' Affairs

As a part of the ceremony, Marshall Tall Eagle, a Vietnam veteran and member of the Apache Nation, accompanied by an Honor Guard of Native American veterans, presented a "Warrior's Medal of Valor" from the "Native American Nations of the United States of America" to each veterans service officer and benefits counselor. This medal for "valorous service to a grateful nation" is the first medal ever minted for the Native Americans Nations to honor all military personnel, active duty, reservist, National Guard and veterans,

regardless of cultural background. Tall Eagle noted that while not all service officers have military service, the medals were awarded to acknowledge the gratitude and respect service officers deserve for their service to veterans.

### A Message From the Director

On August 15, 2005 we will observe the 60<sup>th</sup> Anniversary of VJ Day or Victory over the Imperial Japanese Empire. It was and is a signature event in the history of the United States. Just three months earlier, the allied forces had celebrated VE Day or Victory in Europe, but everyone serving and everyone back at home knew that the job was only half done. All hope for the future hinged on victory in the Pacific and with renewed energy, America and her allies focused on finishing the job.

It was Emperor Hirohito who on August 15, 1945 announced Japan's surrender to the Japanese people. The formal surrender took place on board the battleship U.S.S. Missouri on September 2, 1945. With the signing of the formal instrument of surrender, World War II was over.

It is estimated that there are some 3,600,000 American veterans of World War II still living as this issue of the *VETS NEWS* goes into publication. It is not too late to find a veteran or someone who served in shipbuilding, an aircraft plant or a munitions plant and say a simple thank you for their service and sacrifice in the name of our freedom.

It is notable that not only did this greatest generation win World War II, but also they had the presence of mind not to enter into a peace that featured punishment of the civilian populations of the defeated nations. Rather, they set about rebuilding Germany, Italy and Japan. While we would go on to endure the years of the Korean War and the many years of the Cold War, we did so in a country that was itself recovering from the time lost from 1941 to 1945.

# New State Veterans' Home Loan Product Coming in 2006

With the Oregon Legislature's passage and Governor Kulongoski's signature on Senate Bill 223, the Oregon Department of Veterans' Affairs (ODVA) is authorized to offer 100% loan-to-value home loans beginning in 2006. The principal feature of the new loan product will be that qualifying veteran homebuyers will not be required to ante up the dollars for a down payment. While closing costs will still be required, veterans may be able to reduce closing costs if sellers are willing to pay all or a portion of the closing costs.

Underwriting details of the new veterans' home loan product are still being formulated. Watch future issues of the *VETS NEWS* for developments.

### Navy Sailors Aboard Merchant Ships



When thinking of Navy Service in World War II, many immediately think of the sailors who manned the aircraft carriers in the Pacific, destroyer crews fighting the U-Boat menace in the Atlantic, or valiant aviators, guarding the skies.

What is little known is the fact that from the outbreak of World War II, over 144,900 Navy sailors served as "Armed Guards" aboard the merchant ships of the United States and those of her allies. These sailors served in all theaters of war and shared the perils of running vital supplies to both United States (U.S.) troops and U.S. allies with their counterparts of the Merchant Marine. The danger of this undertaking is reflected in the 2,085 Armed Guards who perished and 1,127 wounded during the course of the war.

From convoy duty in the North Atlantic transports of troops to landing zones, and the grueling Murmansk run, these sailors protected the ships that carried them from, at times, impossible odds. Not only did the Armed Guards aboard merchant ships man guns and provide damage control assistance, they also trained members of the Merchant Marine in the use and maintenance of the guns aboard the ships on which they served.

Without the service of these sailors, many more ships would likely have fallen prey to enemy surface ships, submarines and aerial attack. Their sacrifice, tenacity and valor will never be forgotten.

#### National Registry for Veterans With ALS

The U.S. Department of Veterans Affairs (VA) is developing a nationwide registry for veterans who have Amyotrophic Lateral Sclerosis (ALS), also known as Lou Gehrig's disease. The purpose of the registry is to help the VA understand the patterns of ALS among veterans and provide valuable data for future studies. Those participating in the study will also be informed of research studies in which they may enroll.

ALS is a chronic and progressive neurodegenerative disease that attacks the brain cells that control muscle movement. As the cells die, the affected muscles weaken and then shrink, leading to progressive paralysis. Presently, there is no cure for the disease. ALS is a non-contagious disease that is rare among individuals under the age of 45 years old.

The VA encourages veterans who have been diagnosed with ALS, or their friends and family members, to call for more information or visit the ALS registry website. Qualified veterans will be asked to complete a brief telephone interview including basic questions about their disease and military history. Follow-up interviews with registry enrollees will be conducted on a biannual basis to assess health status of veterans participating in the study.

A VA-conducted study, which began in March of 2002, showed that veterans who served in the Persian Gulf War are nearly two times more likely to be diagnosed with ALS than veterans who did not serve in the Persian Gulf.

# Oregonian Selected to Merchant Marine National Position

Nelson Cauble, a Sutherlin resident, was recently elected National Secretary for the American Merchant Marine Veterans (AMMV). Cauble accepted his new position at the AMMV National Convention in May. In his new post, Cauble will be responsible for public relations and communications for the organization. He will also play an integral part in the Merchant Marine participation in the WWII Commemoration event (see related article on this page) that will take place in Vancouver, Washington this summer.

# Commemoration Celebrations in Vancouver

World War II (WWII) 60<sup>th</sup> Anniversary observances in the United States began in February of this year. In early 2004, the Department of the Army established the Department of Defense 60th Anniversary WWII Commemoration Committee. Six cities were selected to host regional celebrations.

The events will commemorate the outstanding service and sacrifice of WWII veterans. Vancouver, Washington has been selected to host the northwest region celebrations. The northwest region consists of several states including Oregon.

The celebrations in Vancouver are set for August 26-28, 2005 and will be held at the scenic Vancouver National Historic Reserve - home of the Fort Vancouver National Historic Site, Vancouver Barracks, which has a military history dating back to 1849.

The City of Vancouver, the National Park Service and the Vancouver National Historic Reserve Trust are co-hosts of the event, which will culminate on Sunday with the official Department of Defense 60th Anniversary WWII Commemoration.

The celebration in Vancouver titled, "America's Celebrate Freedom Salute," has been expanded to three days to provide a variety of activities to include military displays, musical entertainment, vintage aircraft fly-ins, historical displays, fireworks and much, much more. WWII Memorial prints, pins, brochures and Registry information will also be available and the Library of Congress Veterans' History Project will be on-site to document and record veterans' personal stories from all wars.

The coordinators of the event have indicated that military and veterans groups or organizations, as well as individuals interested in being a part of the celebration may contact event organizers at 360-992-1825 for information and to inquire if you or your group can provide a display, serve as a volunteer, or if you have equipment or memorabilia from WWII to provide.

#### **Anniversary of First Atomic Bomb**

In the predawn hours of July 16, 1945, the incredible event that took place in a remote area of New Mexico, forever changed the world. The impressive and destructive powers of the atom were unleashed and suddenly what had been proven only in theory became reality.

The test of the first atomic bomb was the culmination of three years of planning and development within the top secret Manhattan Project formed in 1942 and headed by General Leslie R. Groves. An isolated corner of the Alamogordo Bombing and Gunnery Range located 230 miles south of Los Alamos, New Mexico, was selected for the test that was given the code-name "Trinity". Dr. J. Robert Oppenheimer directed the team, comprised of some of the greatest scientific minds of the time, headquartered at Los Alamos.

A steel tower was built in preparation for the test, which would suspend the bomb one hundred feet above the ground. Many were apprehensive as to whether the bomb would be a dud and others were concerned that the test might launch a catastrophic chain of events in the earth's atmosphere, and still others feared the possible consequences of radioactive fallout.

The bomb designed to test at Trinity Site actually involved two explosions. First there was the conventional TNT explosion followed by the nuclear explosion a fraction of a second later.

Three observation points were established at 10,000 yards from ground zero. These were shelters made of wood and protected by concrete and earth. The automatic firing device was triggered from the south bunker observatory, which served as the control center.

Originally, the test was scheduled to take place at 4 a.m. on July 16, but due to rain and lightning it was postponed until the clouds cleared and winds died down. A short time later the weather cleared up and the test was given the go ahead. At 5:10 a.m. the countdown began and at 5:29:45 the atomic device successfully exploded.

It was the birth of a new age – The Age of Atomic Energy.

#### **An Additional Note:**

Members of the United States Armed Forces were exposed to ionizing radiation from atomic and nuclear weapons testing during the period beginning with the Trinity Blast of July 16, 1945 at Alamogordo, New Mexico; continuing through the U.S. clean-up of Nagasaki / Hiroshima; during the 235 atmospheric atomic and nuclear weapons tests in the Pacific and Nevada test sites; until the Nuclear Test Ban Treaty of 1963.

The National Association of Atomic Veterans recognizes that civilians as well as military personnel were exposed to harmful nuclear material radiation and have accordingly opened the membership to all civilians and their families. The National Association of Atomic Veterans (NAAV), a non-profit, tax exempt, veterans organization, was founded in August, 1979 by the late Orville E. Kelly, and his wife, Wanda, of Burlington, Iowa.

#### **Massing of the Colors**

The clouds parted just in time for a beautiful Massing of the Colors and Service of Remembrance ceremony at the Oregon State Capitol on June 14, 2005, National Flag Day. The 70-year tradition offers a unique, patriotic opportunity to honor veterans of the Armed Forces, those living and deceased who have served our nation. The ceremony was an emotional one, especially for the many families of Oregon servicemembers who have died in Afghanistan and Iraq. Many were on hand for the event, which was dedicated to their loved ones.

Oregon Department of Veterans' Affairs Director, Jim Willis spoke to the importance of honoring our flag and the men and women in uniform.

"Whenever Americans see the American Flag anywhere in the world, in most cases they can be sure there are fellow Americans close by who understand freedom, who know what it is to enjoy our individual liberties, and who understand the price paid to preserve our way of life," said Director Willis.

Eight area color guards participated including the Oregon Trail Chapter of the Korean War Veterans Association, the American Legion, and the Oregon Chapter of the American Merchant Marines, and the Young Marines.

The Pledge of Allegiance ended with a flyover by two F-15 Fighter Jets. Later, the crowd enjoyed hearing the young women of the American Legion Girls State sing, "America the Beautiful." Finally, family members looked on as all of the names of the Oregon Servicemembers who paid the ultimate sacrifice in Afghanistan and Iraq were read.

It was a day of patriotism and special tribute to all of the men and women who continue to serve our nation.

# Department Presented with Liberty Ship

On April 26, 2005, the Oregon Department of Veterans' Affairs (ODVA) was presented with a made-to-scale replica of a Liberty Ship, the U.S.S. Jeremiah O'Brien.

Members of the Emerald Sea Chapter of the U.S. Merchant Marine Association from Eugene made the presentation to Val Conley, Veterans' Services Administrator who accepted the gift on behalf of ODVA. On hand at the presentation was the Chapter President Joe Johnson, along with members and guests Pauline Johnson, Sherry Johnson, Edgar Lingenfield, Marian Sorensen, Sheri Sorensen, Ben Montoya, Karen Montoya, Ben Masengil, and Clark Smith.

In November 2004, ODVA held a ceremony to pay tribute and honor Merchant Marine veterans. The Department also designated a display case to house WWII Merchant Marine memorabilia. The display case is located in the lobby of the Oregon Veterans' Building at 700 Summer Street N.E, Salem, and is intended to serve as a reminder that we should never forget the exceptional sacrifice that the Merchant Marine made for our country. The display holds many items that have been presented to the Department from Merchant Marine Association members.

Marian Sorensen presented ODVA with the Liberty Ship replica that was made by her late husband Andy Sorensen, who was a Merchant Seaman in World War II.

The Merchant Marine display in the Oregon Veterans' Building will alternate the displaying of this latest Liberty Ship addition with that of a made-to-scale replica of a Victory Ship, also made by Sorensen. The lobby of the Oregon Veterans' Building is open to the Public on regular business days from 8 a.m. to 5 p.m.

### Statement by Governor Kulongoski on BRAC Recommendations

Note: Below is Governor Ted Kulongoski's official response to the proposed military base closures. This press release is available on the Governor's website at http://governor.oregon.gov/.

(Salem, OR) – The Base Realignment and Closure (BRAC) Commission's recommendations today not only have a direct impact on Oregon's economy, but also risk compromising our homeland security efforts in the Pacific Northwest.

The 142nd is the premier F-15 fighter wing in our national air defense system and the only unit responsible for carrying out the homeland air defense mission in the Pacific Northwest. The BRAC makes no recommendation for how that critical mission will be filled.

The recommendations today will also strip the Portland Air Base of all aircraft including the 939th Air Refueling Wing, which had made substantial infrastructure improvements to the base and

served as the replacement unit following the transfer of aircraft from the 939th Rescue Wing in April 2003.

I will continue to work closely with the congressional delegation and communicate directly with the Chair of the BRAC commission and the Secretary of Defense regarding our concerns. To that end I will be joining our congressional delegation in inviting the commission members to come to Portland and see the Portland Airbase firsthand.

### Federal Legislation Introduced

In February of 2005, legislation was introduced in the U.S. Congress that would provide free medical care to military retirees; a promise many veterans say was made when they enlisted. H.R. 602 is called the "Keep our Promise to America's Military Retirees Act." If passed, the legislation would provide Federal Employees Health Benefits (FEHB) coverage to eligible beneficiaries.

To qualify for the benefits, the veteran must meet the following criteria: (1) a member or former member entitled to military retired or retainer pay; (2) an unremarried former spouse who was married to a member for at least 20 years, during which such member performed at least 20 years of retirement-creditable military service; (3) a dependent of a deceased qualifying member or former member; (4) a dependent of a living member or former member; and (5) a family member.

The legislation would reimburse any expenses under the FEHB program that would not have been incurred under Tricare, as well as improve pharmacy benefits.

At time of print, this legislation was still pending.

### You Can Apply For A Discharge Upgrade

Veterans (their surviving spouses, next of kin, or legal representative" if the veteran is deceased or legally incompetent) may apply to have their discharges corrected or upgraded. Title 10, United States Code, Section 1553, is the law governing military discharges.

Pursuant to the law, application for discharge upgrades must be made within 15 years of discharge to the appropriate service's Discharge Review Board. The Army, Air Force and Coast Guard have separate boards. The Navy operates the board for both Navy and Marine Corps. personnel. For discharges older than 15 years, application must be made apply for a change to military records

### Memorial Garden Bricks Available

The Vietnam War Memorial Garden located on the Campus of the U.S. Department of Veterans Affairs (VA) Medical Center in Vancouver, was dedicated in November of 2002. The purpose of the Garden is to honor all Vietnam Era veterans from the United States and notably the Pacific Northwest. The Garden creates a symbolic journey; with varied landscapes the journey along the path starts in native Pacific Northwest foliage and transitions to plantings set to resemble Vietnam and Southeast Asia.

Further along the path, a 360 degree observatory offers a view of areas just visited and is intended as a place for reflective thought, remembrance and healing. Finally, the pathway leads to a brick plaza called the "Honor Plaza' which contains a reflective dish designed to extend appreciation and remembrance to all Vietnam veterans.

# Co-Pay for Smoking Cessation Counseling Eliminated

Effective May 2, 2005, the U.S. Department of Veterans Affairs (VA) designated smoking cessation counseling, both individual and group sessions, as being exempt from co-payments. According to the VA, removing the financial barrier of co-payments is intended to increase the number of individuals who participate in smoking cessation counseling.

Medical literature cites smoking cessation as the most cost-effective medical intervention, next to immunizing children for disease.

#### Looking For Recipients of the Distinguished Flying Cross

It's a mission Mike Scorcio will never forget. As a navigator on a B-17 flying over targets in Czechoslovakia during World War II, Scorcio received the scare of his life when his bomber was hit by enemy fire and lost two engines. Scorcio helped navigate the aircraft over 600 miles to reach a base in Italy before landing safely. For his actions on that fateful day, Scorcio was awarded the Distinguished Flying Cross (DFC), a medal awarded to service members of the Armed Forces of the United States who distinguish themselves in combat by "heroism or extraordinary achievement while participating in an aerial flight." The DFC is this nation's second highest military award, preceded only by the Medal of Honor.

More than 60 years later, Scorcio is looking for other Oregonians who have been awarded the DFC to join an Oregon Chapter, which Scorcio helped establish. The Lewis and Clark Chapter, the 17<sup>th</sup> chapter in the nation, currently has more than 40 members. Scorcio and his fellow Chapter members hope to increase their membership significantly. The Chapter's goal is to have the stories of DFC recipients become permanent records at the Oregon Historical Society.

# OPVA Grant Will Educate First Responders

The Oregon Paralyzed Veterans of America (OPVA) has been awarded an \$18,500 grant by the National Paralyzed Veterans of America. The grant will fund an educational program for Emergency Rooms and Emergency Medical Technicians throughout Oregon about Autonomic Dysreflexia, an often mis diagnosed condition that can be life threatening for individuals with spinal cord injuries.

Autonomic Dysreflexia is a condition where the individual's blood pressure increases drastically in response to an unknown irritation to the system. Although it may be something as simple as a full bladder or clothing that is too tight, Autonomic Dysreflexia can become fatal as blood pressure rises to 220/160 or more. Proper, rapid diagnosis and treatment are vital to preventing stroke, heart failure, or death.

OPVA members will provide inservice presentations on the topic of Autonomic Dysreflexia, including how to recognize signs and symptoms and how they should be treated. A CD and booklet with information on this life threatening condition will be given to each Emergency Room, Fire Department EMT Team, and Ambulance company statewide to educate the personnel on various aspects of this often misdiagnosed condition.

"This two-year program to help educate first responders is vital to the entire spinal cord injured community," said OPVA President Jerry Ryan.

### Two New Campaign Medals - Afghanistan and Iraq

The Department of Defense has announced the creation of two new campaign medals for service in Afghanistan and Iraq. Previously, service members who served in Iraq and Afghanistan were awarded the Global War on Terrorism Expeditionary Medal. But now, those who served in Iraq and meet qualifications will be awarded the Iraq Campaign Medal and those who served in Afghanistan and meet qualifications will be awarded the Afghanistan Campaign Medal.

In order to receive the Afghanistan Campaign Medal service members must have served in direct support of Operation Enduring Freedom on or after October 24, 2001 to a future date to be determined by the Secretary of Defense or the cessation of the operation. The area of eligibility encompasses all land areas of the country of Afghanistan and all air spaces above the land.

Those authorized for the Iraq Campaign Medal must have served in direct support of Operation Iraqi Freedom on or after March 19, 2003, to a future date to be determined by the Secretary of Defense or the cessation of the operation. The area of eligibility encompasses all land area of the country of Iraq, and the contiguous water area out to 12 nautical miles, and all air spaces above the land area of Iraq and above the contiguous water area out to 12 nautical miles. Service members must have been

assigned, attached or mobilized to units operating in these areas of eligibility for 30 consecutive days or for 60 non-consecutive days or meet one of the following criteria:

- Be engaged in combat during an armed engagement, regardless of the time in the area of eligibility; or
- While participating in an operation or on official duties, is wounded or injured and requires medical evacuation from the area of eligibility; or
- While participating as a regularly assigned air crewmember flying sorties into, out of, within or over the area of eligibility in direct support of the military operations; each day of operations counts as one day of eligibility.

Service members qualified for the Global War on Terrorism Expeditionary Medal by reasons of service between October 24, 2001, and April 30, 2005, in an area for which the Afghanistan Campaign Medal was subsequently authorized and between March 19, 2003 and February 28, 2005, in an area for which the Iraq Campaign Medal was subsequently authorized, shall remain qualified for the medal.

#### **Groundbreaking for Afghan-Iraq Freedom War Memorial**

More than three hundred people gathered on the grounds of the Oregon Department of Veterans' Affairs on June 14, 2005 for the groundbreaking of the Afghan-Iraq Freedom War Memorial. The day was a dream come true for Clay and M.J. Kesterson who lost their son Erik – a Blackhawk Helicopter Pilot – in the conflict in Iraq in November 2003. Since his death they have dedicated much of their time to establishing a Memorial to honor Oregon Servicemembers who have given their lives serving in Afghanistan and Iraq.

Many of the families who lost loved ones in the ongoing conflict were on hand for the groundbreaking. Governor Ted Kulongoski, who attended most of their funerals, highlighted the significance of the day. "We set aside and consecrate this small patch of land to allow for quiet

contemplation and reflection, for those who are home or coming home,...and for the loved ones of those who did not – or will

not. In setting aside this land, we say thank you to all of the men and women from Oregon who have walked into harms way in

Afghanistan and Iraq. Their service has been brave, noble and selfless," said the Governor.

Luke Wilson, a veteran who lost his leg in Iraq spoke to the importance of establishing a permanent Memorial for his fellow servicemembers who paid the ultimate sacrifice.

"Every time I take my leg off in the morning and at night, it reminds me of all of them. I will think of them everyday and every night for as long as I live," said Wilson.

Fundraising for the Memorial continues, and the final approval for the location of the Memorial on the grounds of the Oregon Department of Veterans' Affairs is pending. A date for the dedication has not yet been set.
