Veterans Address Legislative Issues at Muster

On the front steps of the State Capitol in Salem, Oregon, hundreds of veterans and veterans' supporters gathered on February 9th during the biennial Veterans Muster to discuss current legislative issues that will impact Oregon's veteran community.

The United Veterans' Groups of Oregon

(UVGO) hosted the 2005 Veterans Muster, where veterans were joined by local legislators who attended to show their support.

Serving as master of ceremonies, Oregon
Department of Veterans' Affairs
Deputy Director
Paula Brown opened the ceremonies by introducing the Speaker of the Oregon House of Representatives, Karen Minnis.

Speaker Minnis praised all veterans for their service and sacrifice. During her speech, Speaker Minnis outlined her intent to help serve veterans and the veteran community's issues of interest as these issues present themselves on the House floor.

Under Speaker Minnis, the 2005 Legislative Session opened with a newlyformed House Veterans' Affairs Committee, chaired by Representative Donna Nelson. Oregon Department of Veterans' Affairs Director Jim Willis commended Speaker Minnis for the creation of the Committee.

Willis expressed appreciation of this first step in addressing the issues facing veterans locally and nationally.

"It is time in this country for Congress

to pass legislation that mandates funding for a federal healthcare system," said Director Willis. "If a vet anywhere in America loses a benefit, then all vets are in jeopardy of losing a benefit."

He thanked all members of the Legislative Assembly who attended the Muster for showing support of veterans. Willis also thanked veterans' service organization officers and county veterans' service officers for working "in the

trenches" every day for veterans.

Members of the Governor's Veterans' Affairs Committee and the Governor's Senior Policy Advisor on Veterans Affairs, Craig Campbell, also attended.

Representative Donna Nelson, Chair of the House Veterans' Affairs Committee, addressed attendees. She extended an invitation for all veterans to visit the Committee's weekly hearings, held on

The men and women of the Oregon Department of Veterans' Affairs join me in thanking all the members of the Oregon House of Representatives for extending this courtesy to Mr. Sohler, his family and friends.

On February 9, the traditional Veterans Muster was held on the steps of the State Capitol. The United Veterans' Groups of Oregon Commander Dick Lucht, and Robert Haltiner coordinated the event this year during which the veterans attending heard comments

60th Anniversary

The Oregon Department of Veterans' Affairs will mark its 60-year Anniversary on March 12, 2005.

In 1944, Oregon voters approved an amendment to the Oregon constitution authorizing a program to offer home and farm loans to World War II veterans. On March 12, 1945, the legislature signed the act (Chapter 201, Oregon Laws 1945) creating the office of Director of Veterans' Affairs.

Hugh E. Rosson, a World War I veteran was the very first Director appointed by then Governor Earl Snell, on June 27, 1945. Rosson immediately began taking steps to establish a Department of Veterans' Affairs, and specifically to organize a loan department for administering that benefit.

Written inside the first biennial report to the Governor, issued in September of 1946, are the words - "I have the honor to transmit herewith the First Biennial Report of the Director of Veterans' Affairs, covering the period from June 15, 1945, to September 30, 1946." The report addressed to the Governor of Oregon, The Honorable Earl Snell and signed by Oregon Department of Veterans' Affairs (ODVA) second Director George E. Sandy, presents a look at the very beginnings of the Department and the programs that were formed to administer benefits to veterans.

Over the last 60 years, the Department has faced numerous challenges and experienced tremendous successes as various factors have impacted the Department and its programs. There were times when the Department had to bend and times when it bravely had to stand in opposition of change.

One thing that has remained constant through all the years is the mission and desire of the Department to serve veterans, their dependants and survivors. The Department celebrates reaching this 60th anniversary milestone, but even more so, the Department's employees, past and present, are honored to have the opportunity to assist veterans and their families in obtaining the benefits they have earned by their honorable service to this state and country. The Department's employees pride themselves on serving veterans - one veteran at a time - to meet their unique needs.

The Department looks forward to the future and the challenges and opportunities it may bring. The Department strives to ensure that every Oregon veteran, their dependents and survivors are aware of the benefits to which they are entitled and to assist them in applying for those benefits. State Veterans' Home Loans Available

While many veterans are aware of their U.S. Department of Veterans Affairs (federal VA) home loan guaranty benefit, some are not aware of their state veterans' home loan benefit. Oregon is one of only five states that has a state veterans' home loan program.

The Oregon Department of Veterans' Affairs (ODVA) makes state veterans' home loans to veterans with qualifying active duty service who are still within 30 years of discharge from that qualifying service. It is not necessary for a veteran to have enlisted into the military from Oregon to be eligible for an Oregon state veterans' home loan. Veterans may have enlisted from any state.

Remember, too, that in 2000, Oregon voters approved Ballot Measure 83 to extend eligibility to veterans who served after the Vietnam War, which now includes Oregon National Guard members who have been activated and deployed to theatres of operations such as Afghanistan and Iraq.

Veterans can apply for a state veterans' home loan at ODVA's Salem office or via a participating private-sector mortgage broker or lender. Participating lenders and brokers are located throughout Oregon. ODVA lending staff and participating private-sector mortgage brokers and lenders are eager to assist and understand the special circumstances of veterans.

At the time this publication went to print in February 2005, interest rates lower than 5% were available. The maximum loan amount for a state veterans' home loan is currently \$359,650. Oregon veterans' home loans are serviced by ODVA for the entire life of the loans.

Tuesdays and Thursdays at 8:30 a.m. in the Capitol.

"We welcome your testimony and learning about any issues you're concerned about," Representative Nelson said. "There are 120 issues this year relative to you – you deserve our attention so we're glad [Speaker Minnis] made this happen."

During the Veterans Muster, UVGO Chairman Dick Lucht expressed the organization's support of pending legislation, the outcome of which could impact veterans.

Lucht said the UVGO is a veterans' voice on legislative matters and that it was important to utilize that vocal piece. Lucht encouraged veterans to go inside the Capitol and visit legislators to urge their support of legislation affecting veterans.

- IMPORTANT When Disabilities Worsen, Increased Benefits May Be Available

If you receive U.S. Department of Veterans Affairs (VA) disability compensation or VA pension, it is important to remember that if your disabilities worsen, you may be eligible for a higher rate of benefit payments.

For veterans who receive compensation for service-connected disabilities, if the service-connected condition worsens, you can request a reevaluation of the disability by the VA. Depending upon the results of the reevaluation, your disability rating for that condition could be increased entitling you to increased VA benefit payments.

Veterans who receive a nonserviceconnected pension may be eligible for additional benefits if they become permanently housebound or require the regular aid and attendance of another person.

Tax Deadline Approaching

Remember the Oregon Veterans' Home



The deadline for filing Oregon Individual Tax Returns is rapidly approaching. If you are due a refund when you file, please consider sharing some or all of that refund with the Oregon Veterans' Home – your Veterans' Home.

The Home is Oregon's only state veterans' home and serves veterans and their spouses in need of extended nursing home or rehabilitative care.

This will be the third year Oregonians have had the option of sharing some or all of their Oregon tax refund with the Oregon Veterans' Home by using the Charitable Checkoff portion of their Oregon income tax return.

"Last year, generous Oregonians donated \$13,010 to the Home using this method," said Jim Willis, Director of the Oregon Department of Veterans' Affairs.

Charitable Checkoff donations are sent directly to the Oregon Veterans' Home Trust Fund by the Oregon Department of Revenue.

"The Trust Fund is a tremendous benefit for the residents at the Home," Director Willis said. "It helps maintain a high quality of life for the residents, paying for everything from special food treats to emergency repairs. It's especially important because the Home has received no tax dollars from the State General Fund."

Tax-deductible contributions to the Oregon Veterans' Home are fast and simple to do. For those filing Oregon Form 40S (the short form):

- ·Locate Line 30 on the form.
- · Enter number "12" where it reads "Enter Code".
- · Choose an amount or select "other" and enter the amount of your choice.

For those filing Oregon Form 40 (the long form):

- ·Locate line 61 on the form.
- · Enter the number "12" on the line where it reads "Enter Code".
- · Choose an amount or select "other" and enter the amount of your choice.

If using the services of a tax professional, inform the preparer that you want all or a designated portion of the refund to go to the Oregon Veterans' Home, Code #12.

FINAL REMINDER

Be Sure to File for Veteran's Property Tax Exemption by April 1 Deadline

If you are a disabled veteran or the surviving spouse of a veteran, you may be entitled to exempt \$10,460 or \$13,930 of your homestead property's assessed value from your property taxes. For each assessment year after January 1, 1998, the exempt amount increases by three percent. The exemption is first applied to your home and then to your taxable personal property. If you are a qualifying veteran or a qualifying veteran's surviving spouse and live in your home, you may apply for the exemption.

How to apply:

The veteran's exemption is not automatic. You MUST apply to receive it. The deadline is April 1, 2005. The veteran's property tax exemption is not allowed unless you file an application by the deadline. Application forms may be obtained at county assessor's offices.

- If you did not file for an exemption for last year, you must file an application for the exemption on or before April 1, 2005.
- If you filed a claim last year, you must file a new claim by April 1, 2005 to avoid a late fee. (If not filed by April 1, the county assessor will notify you and for a \$10 fee, you can file until May 1, 2005. The May 1 deadline only applies to those who filed a claim and received the exemption the previous year.)
- Surviving Spouse: The surviving spouse can file a claim at any time during the current tax year if the war veteran died anytime during the previous tax year, or if the homestead property was acquired after March 1 but prior to July 1, and the veteran died within 30 days of the date property was acquired.

AMVETS Makes Large Donations

In early January 2005, American Veterans (AMVETS) Post 1984 presented the Oregon Department of Veterans' Affairs with a \$3,000 donation for the Oregon Veterans' Home. Deputy Director Paula Brown accepted the generous donation, which came on the heels of another large donation made by the organization.

Just a couple short months earlier in October 2004, the organization presented ODVA Veterans' Service Administrator Val Conley with a \$2,000 donation for the Edward K. Crouch Trust Fund. The Trust Fund is designated specifically to aid disabled veterans.

AMVETS, like several other veterans' organizations, has a long-standing history of making sizeable donations in support of veterans and the Veterans' Home located in The Dalles.

Oregon Department of Veterans' Affairs Director Jim Willis commented, "The generous donations of veterans' organizations are greatly appreciated and have a profoundly positive impact on veterans and their families in Oregon."

Veterans' Home Report

This report on the Oregon Veterans' Home is presented on behalf of the Governor's Veterans' Affairs Advisory Committee (VAAC). The VAAC consists of nine members appointed by the Governor, all of whom are required to be veterans. Veteran representation on the Committee currently includes World War II, Korea, Vietnam, and Desert Storm veterans.

The Oregon Veterans' Home, which opened in 1997, has entered its second year with Veterans Care Centers of Oregon (VCCO) as the contract operator. VCCO, a private non-profit corporation directed by an eleven-person board of directors is composed primarily of veterans. VCCO was created to provide future continuity for the residents and employees at the Home that are employed by the contract operator. The VCCO Board signed a contract with Westcare, a reputable management company with a long history of success.

The Oregon Department of Veterans' Affairs (ODVA), VCCO, and Westcare, have diligently worked together to deliver affordable, high quality care to the residents of the Oregon Veterans' Home.

With the added involvement of VCCO and the increasing onsite volunteer efforts and involvement of veterans' organizations and other volunteer groups and individuals, the Oregon Veterans' Home is under more scrutiny now than

ever before in its history. This involvement is in addition to two distinctly separates stringent surveys (inspections) conducted by the U.S. Department of Veterans Affairs and the Oregon Department of Seniors and People with Disabilities. With that being said, the VAAC is proud to report that the Oregon Veterans' Home's good name, honor, integrity, and reputation of delivering high quality care are absolutely intact.

Below is a re-cap of some happenings the VAAC believes may be of interest to all Oregonians, especially veterans, their families, citizens of Wasco County where the Home is located in The Dalles, veterans' organizations and auxiliaries, legislators, and volunteers.

- High quality care is delivered to residents and is evidenced by receipt of very good results on both the U.S. Department of Veterans Affairs (federal VA) survey (inspection) and the state Department of Seniors and People with Disabilities survey (inspection).
- Delivery of high quality care and customer satisfaction is confirmed by a survey of family members.
- Gaining Medicaid certification has resulted in approximately 40 additional residents being served at the Home.

- · A Wing, which was previously vacant, is being utilized as a result of an increase in the number of residents being served.
- To meet the needs of additional residents, staffing levels have been increased by 25 percent providing additional jobs and support to the local economy.
- VCCO held an open Board meeting in The Dalles to interact with local citizens about the Home in their community.
- Purchasing and operational efficiencies have been gained under VCCO, the current contractor.
- The application process has been streamlined to be more responsive to veterans and their families and allow for same-day admissions often necessary to meet the needs of veterans and their families.

The Governor's Advisory Committee commends the current contract operator, Veterans' Care Centers of Oregon, for its outstanding efforts and numerous accomplishments with the Oregon Veterans' Home. Additionally, the Committee appreciates Oregonians' continued interest and generosity toward the Home. Your support, donations, and volunteer efforts are all appreciated. Thanks for making the Oregon Veterans' Home the "Place Where Honor Lives".

Nicholson Confirmed as VA Secretary



Jim Nicholson, former U.S. Ambassador to the Vatican, was confirmed in January as Secretary of the U.S. Department of Veterans Affairs (VA).

"The challenge of leading such an organization is daunting, but I am prepared to accept it," Ambassador Jim Nicholson told a Senate Committee during a confirmation hearing on January 24, 2005.

Most recently, Nicholson served as the U.S. Ambassador to the Vatican. He is a West Point graduate and served eight years as a U.S. Army Ranger. The Vietnam veteran said that his military background provided preparation for the job because he could sympathize with the sacrifices that veterans have made. After 22 years in the Army Reserve, Nicholson retired as a Colonel.

"I have had the privilege of wearing the uniform of the United States Army in combat," he told the committee. "So I have seen both the horrors of war and the heroes of America making the greatest sacrifices of military service on behalf of their comrades and our nation."

President Bush nominated Nicholson after Anthony Principi submitted his resignation in December. As VA Secretary, Nicholson will lead more than 230,000 employees and the nation's second largest federal agency.

During his testimony, Nicholson outlined principles he will aim to attain during his post. These include ensuring that veterans have access to the best healthcare in the most appropriate clinical settings delivered in a timely, caring and compassionate manner.

He also said he wants prompt, accurate, equitable and understandable decisions on benefits claims for veterans, dependents and their survivors.

In February, Nicholson announced that President Bush will seek a record \$70.8 billion in the 2006 fiscal year budget for the Department of Veterans Affairs and the majority of those funds would be targeted for healthcare and disability compensation.

Nicholson was awarded the Bronze Star Medal, the Combat Infantry Badge, and the Meritorious Service Medal with Oak Leaf Cluster. He obtained a master's degree in public policy from New York's Columbia University and a law degree from the University of Denver.

Lung Cancer May Be Linked to Gulf War Fires

A committee of the Institute of Medicine (IOM) concluded during a 2004 study that occupational and environmental exposure to combustion products has been shown to demonstrate an increased danger of lung cancer in veterans of the Persian Gulf War.

These exposures could have resulted from oil well fires, exhausts and other sources while these veterans served in the 1991 Gulf War.

While presenting their findings to the federal government, these scientists identified a possible link between lung cancer in Gulf War veterans and their exposure to combustible products during the Gulf War. However, the report does not declare a cause-and-effect relationship between the two, and scientists added that their studies were not exclusive to examining veterans.

The report was titled Gulf War and Health, Vol. 3: Fuels, Combustion Products and Propellants. It is the third in a series examining the health effects to which these veterans may have been exposed. The study is sponsored in part by the U.S. Department of Veterans' Affairs.

It has not been uncommon for veterans of the 1991 Gulf War to report health problems that they attribute to their tour of duty in that region. These soldiers may have faced exposure to smoke from oil well fires in Kuwait, vehicle exhaust, heaters in poorly ventilated tents, cooking stoves, and hydrazines and nitric acid, which are ingredients used in Scud missile propellants.

These findings were part of a IOM investigation mandated by Congress to investigate exposure to chemical, biological or environmental agents during the Gulf War and their connections to health complaints by returning servicemembers.

In November 2004, former Secretary of Veterans Affairs Anthony J. Principi announced a plan for an additional \$15 million in research funding for studying Gulf War illnesses.

"We still don't have a definitive cause for Gulf War illnesses," Principi said in a released statement. "There has to be a reason why some of our veterans came home healthy, while others serving alongside them did not."

Memorial Planned for Canby

Vietnam veteran Mike Breshears has a dream for a memorial that honors Vietnamera veterans. With perseverance, determination, and patience as the fundraising continues, he is confident it will be a reality.

Already secured for the roadside memorial is a quarter of an acre on Oregon 99E located in Canby next to Burgerville, which was donated by the restaurant chain's owner, Holland Inc. Another large part of the future memorial is a UH-1H 'Huey' helicopter, which is being stored at Columbia Helicopters' headquarters on the outskirts of Canby. The company, which maintains, operates and repairs helicopters, is storing the aircraft free of charge.

Some 25 Columbia Helicopter employees, many of whom are Vietnam veterans, donated labor and time to refurbish the worn-out 1971 Huey. It was cleaned up, given a fresh coat of paint, put back together and made to look like a MedEvac air ambulance.

The contractor who worked on the Vietnam Veterans Memorial in Portland's Washington Park is involved in the project. The planned memorial will feature the Huey suspended approximately 20 feet from the ground with the appearance of coming to the

aid of two American soldiers and a Vietnamese girl.

For Breshears, the Memorial will be a reflection of a past which he knows he shares with many other Vietnam veterans. On Veterans Day in 1967, it was a Huey that saved his life. Breshears served as a U.S Army combat photographer during Vietnam. It was on a barren hilltop near Dak To, with about 150 U.S. soldiers in battle that he and the soldiers were pinned down by enemy fire. Breshears was hit with shrapnel in both shoulders and in his right leg. The Hueys hovered in and airlifted the soldiers from the battlefield. To Breshears, it was like seeing angels come from the heavens.

The Memorial project has many volunteers and supporters who have been working hard helping to see the project through to completion. However, approximately \$400,000 is still needed. A grant writer is helping the project and volunteers are planning fundraisers.

Afghan-Iraqi Freedom War Memorial Needs Your Help

With every dollar collected, MJ and Clay Kesterson grow one step closer to memorializing Oregon's sons and daughters lost in Iraq and Afghanistan, including one of their own.

Their son Army Warrant Officer Erik Kesterson is one of 35 Oregonians as of February 18, 2005, who have died serving in Operation Iraqi Freedom and Enduring Freedom in Afghanistan. Kesterson had been in Iraq for just eight days when he was killed in a Black Hawk helicopter crash.

For the Kestersons, the fight to keep each fallen heroe's memory alive wages on. After launching a campaign last year to create the Afghan-Iraqi Freedom War Memorial to honor all Oregon servicemembers serving in Iraq and Afghanistan, the couple from Independence is continuing their crusade by hosting fundraisers and teaming with local businesses to raise the estimated \$350,000 - \$500,000 needed for the memorial.

The planned memorial will feature a sculpture of an American soldier kneeling atop a 6-foot pedestal in a reflecting pool shaped like a world map. The Kestersons have joined forces with nearly all of the families of Oregon's

servicemembers who have died in Afghanistan or Iraq and are reaching out to Oregon's congressional, legislature and community leaders, along with area businesses and organizations for support. State Representative Donna Nelson, Chair of the House Veterans' Affairs Committee, joined the Board of Directors for the Afghan-Iraqi Freedom War Memorial Fund. The Kestersons are also working with the Oregon Department of Administrative Services and the Oregon Department of Veterans' Affairs to secure a site among the memorials surrounding the Veterans' Building, at 700 Summer Street NE, in Salem.

The Kestersons have raised about \$28,000 (as of this printing) and have fundraisers scheduled throughout the year.

Approximately 300 replicas of the Memorial will be available on ebay.com over the coming months, with all proceeds benefiting the Memorial. Each replica stands nine inches high.

On October 30, the Kestersons held a rally on the Oregon State Capitol Building's front steps in Salem, to recruit financial supporters. Both Governor Ted Kulongoski and Oregon Department of Veterans' Affairs Director Jim Willis were in attendance. MJ and Clay have traveled the state making

presentations, raising awareness, and seeking donations. Audiences have included veterans' organizations legislative committees, businesses, sporting events, trade fairs and shows and others.

In order to break ground on the Memorial by November 15, 2005 – the second anniversary of their son's death – the Kestersons are calling upon all Oregonians to donate at least one dollar in order to make this memorial honoring Oregon's newest veterans a reality.

"We need you to give up your [one cup of coffee]," MJ Kesterson said. "Don't buy a newspaper for one day. Instead help us memorialize the sons and daughters fighting in the war effort."



OPVA Provides Phone Cards to Oregon Troops

Sales from yellow, magnetic ribbons honoring Oregon troops have given the Oregon Paralyzed Veterans of America (OPVA) a means to send phone cards to deployed servicemembers to help them call home.

Through Project Troops Need to Talk (T.N.T.), OPVA has sent more than 1,000 phone cards to Oregon servicemembers deployed in Iraq and Afghanistan. Funds for phone cards are raised through the sale of magnetic yellow ribbons and lapel pins with crossing American and Oregon flags.

The \$10 cost of a magnetic yellow ribbon, which reads, "Support Oregon's Soldiers", covers the entire cost of one phone card and provides an Oregon soldier with about 15 to 20 international minutes of call time, which can be used in over 220 countries. Funds from the sale of \$5 lapel pins with crossing American and Oregon flags also provide for the purchase of phone cards.

OPVA believes Project T.N.T. has increased the community's awareness of how important it is for soldiers to keep in contact with loved ones and hopes that Project T.N.T. will ensure one phone card for every Oregon servicemember serving in the War Against Terrorism.

Units receiving phone cards from OPVA include the 3670th Maintenance Company of the Army National Guard based out of Camp Withycombe in Clackamas, Oregon. During the holidays, phone cards were also provided to wounded troops being treated at Walter Reed Army Medical Center and members of 2nd Battalion, 162nd Infantry Regiment of the Oregon Army National Guard.

President Bush Seeks \$70.8 Billion Budget for Federal VA

Secretary of Veterans Affairs Jim Nicholson announced on February 7, 2005 that President Bush plans to seek a Department of Veterans Affairs budget of \$70.8 billion for the 2006 fiscal year.

The proposed budget will include a 2.7 percent increase over the current year's discretionary budget and include funds targeted predominantly for healthcare and disability compensation. There is \$33.4 billion requested for discretionary funding primarily for healthcare, and \$37.4 billion in mandatory funding, which would facilitate compensation, pension and other benefit programs.

"This budget demonstrates the President's ongoing commitment to provide the very best healthcare and benefits to those veterans who count on VA the most," Nicholson said in the release.

The fiscal year 2006 proposed budget includes:

- A request for \$2.2 billion in enhanced mental health services, totaling \$100 million above this year's funding level. This proposal would ensure a full continuum of care for veterans with mental health issues, to include comprehensive treatment for those veterans with post-traumatic stress disorder.
- Proposed funding for noninstitutional long-term care to increase by more than 18 percent over fiscal year 2005, with investments totaling \$400 million.
- Continuation of the Presidential priority that the VA and Department of Defense work together to ensure that servicemembers returning from Iraq and Afghanistan and their families receive timely, high-quality services.

VA Clothing Allowance

Veterans with service-connected disabilities or conditions that require the use of prosthetic or orthopedic appliances, which tend to wear or tear clothing, may receive an annual clothing allowance from the U.S. Department of Veterans Affairs (VA).

The clothing allowance may also be available to veterans whose service-

connected conditions require prescribed medication that damages veterans' outer garments.

Camp Adair Historical Markers Need Restoration

Historical markers are erected around the state to commemorate people, events, places, culture, geography, history, and geologic features. One such marker is the Camp Adair World War II Historical Marker located approximately 13 miles north of the city of Corvallis on Highway 99W.

This and other historical markers have been the work of the Travel Information Council (TIC) and its volunteers. The TIC was formed by the Oregon State Legislature in 1972 in response to Federal Highway Beautification Legislation championed by Lady Bird Johnson. Funding for the small agency comes from monies received from businesses and attractions that use the Council's services. TIC receives no public dollars to operate the program or pay staff.

Working under the TIC is a group of volunteers who donate their time, labor and resources to help restore historical markers in Oregon. Their current project is the restoration of the Camp Adair Historical Marker, which marks the site where military divisions were trained during World War II.

Once the second largest city in Oregon, Camp Adair was chosen by the United States War Department as a training site for Triangular Divisions. During World War II, Camp Adair served as home base to four infantry divisions (ID); the 91st ID POWDER RIVER Division, the 70th ID TRAILBLAZERS Division, the 96th ID DEADEYE Division, and the 104th ID TIMBERWOLF Division.

With the extensiveness of the restoration and depending upon the exact method used in the restoration, it has been determined that even with the donation of time, labor, and resources by volunteers, the project will require an estimated \$20,000 to \$30,000.

Because the Council does not have sufficient funds to cover the cost, donations are being sought to raise the necessary funds for the Camp Adair marker restoration project.

Representative Donna Nelson serves as the Chair of the Committee. Representative Nelson, from McMinnville, is a small business owner and a third-term representative in the House. Representative Nelson served on the Board of Directors of the Evergreen Aviation Museum for 24 years. She moved to McMinnville in 1971. Along with her term as Chair, Representative Nelson serves concurrently on the Trade and Economic Development Committee.

Currently, Representative Nelson is a Board Member of the Afghan-Iraqi Freedom War Memorial Fund, the non-profit organization spearheading a memorial for all servicemembers who died while serving in Iraq and Afghanistan.

Representative Phil Barnhart, from Eugene, is a practicing psychologist and adjunct faculty at the University of Oregon. He also serves on the Environment and Water Committees. He has said his main issues of concern are those crafted to protect children, the poor and the elderly.

Representative Debi Farr of Eugene, is serving her freshman term as a member of the House of Representatives. She succeeds her husband Pat, for whom she served as Chief of Staff during his term.

Representative Brian Boquist from Dallas, is a military veteran and part-time farmer. Boquist recently returned from a tour in Iraq and is involved in the Veterans of Foreign Wars, American Legion and the National Guard Association.

Representative Scott Bruun, whose district includes West Linn, Tualatin, Lake Oswego and Stafford is Vice President and Chief Financial Officer for a Portland-based commercial general contractor. He is Vice-Chair of the Trade and Economic Development Committee and serves on the Transportation Committee as well.

Representative Dave Hunt represents Clackamas County for the second time this session. He was elected Assistant Democratic Leader by his peers following the 2003 legislative session. He also serves on the Transportation Committee and the Elections and Rules Subcommittee on Campaign Finance
