Brigadier General Austin Inducted Into Hall of Honor

The Evergreen Aviation and Space Museum honored five of Oregon's finest aviators in a Hall of Honor ceremony on October 21st. The museum has established an Oregon Aviation Hall of Honor to recognize outstanding men and women who have made contributions to aviation and airpower in all fields including but not limited to, military, civilian, engineering, business, education and government.

Mike Burrill, Sr., Chairman of the State Aviation Board is also Chairman of the Hall of Honor Committee and serves alongside committee members Lt. Col Russell Barney, Capt. Colin Armstrong and Jack Loacker.

"It is our pleasure to publicly recognize the significant contributions to aviation these Oregonians have made," stated Burrill.

Among the five 2007 inductees
was Brigadier General Staryl C.
Austin, Jr. of Salem. Mr. Austin
served as Director of the Oregon
Department of Veterans' Affairs from January
1981 to December 1984 and is currently
serving the second half of a four-year term on
the Governor's Advisory Committee to the
Director of the Department of Veterans'
Affairs.

The other four inductees were Colonel Lawrence E. Campbell, Jr., Colonel James Church, Major General Chester E. McCarty and Nevilles E. "Jim" Walker.

A native Oregonian Austin attended public schools in Bend and Albany and graduated from Salem High School in 1938. He enlisted in the Army Air Corps Civilian Patrol (CPT) in September of 1942. Austin has served in many leadership capacities in both the Army Air Force and Air National Guard since 1943. As a first lieutenant, Austin flew in the European Theatre of Operations and

completed 58 combat missions flying a P-47 Thunderbolt.

Austin joined the Air National Guard in 1953 and ultimately served as Commander of the 142nd Fighter Group, Chief of the Administrative Division at the Oregon Military Department and served 17 years as the Assistant Adjutant General until his retirement in 1981. During his service in the military Austin earned the Air Force's Distinguished Service Medal, Legion of Merit, Air Medal with seven oak leaf clusters and the European-African-Middle East Campaign Medal with four battle stars.

In 2006, Governor Ted Kulongoski presented a special Governor's Commendation Award to Austin in


Keynote speaker, Brigadier General Charles Yriarte, reported on integral improvements occurring on the ground in

Director's Message



fter two and one-half years of work, the Veterans' Disability Benefits Commission (VDBC) released its long awaited 562-page report on October 3 in Washington D.C.

The thirteen-member commission chaired by James Terry Scott, Lieutenant General, USA (RET) was established by Public Law 108-136, the National Defense Authorization Act of 2004. Between May 2005 and October 2007, the Commission conducted an in-depth analysis of the benefits and services available to veterans, servicemembers, their survivors and their families to compensate and provide assistance for the effects of disabilities and deaths attributable to military service.

Serving from Oregon on the Commission was Colonel Larry G. Brown, USA (RET) who was of great assistance to ODVA in the preparation of this report on the Commissions' work.

The Commission makes 113 recommendations. All are important and should receive attention from Congress, The Department of Defense (DoD), and U.S. Department of Veterans Affairs (VA). The Commission suggested that the following 14 recommendations receive immediate consideration.

<u>Priority Recommendations</u> (These are summaries of the recommendations)

Recommendation 4.23 - Chpt 4, Sect. 1.5

VA should immediately begin to update the current Rating Schedule, beginning with those body systems addressing the evaluation and rating of post-traumatic stress disorder and other mental disorders and of traumatic brain injury.

Recommendation 5.28 - Chpt. 5, Sect. 111.3

VA should develop and implement new criteria specific to post-traumatic stress disorder in the VA Schedule for Rating Disabilities. VA should base those criteria on the *Diagnostic and Statistical manual of Mental Disorders* and should consider a

multidimensional framework for characterizing disability due to post-traumatic stress disorder.

Recommendation 5.30 - Chpt. 5, Sect. 111.3

VA should establish a holistic approach that couples post-traumatic stress disorder treatment, compensation, and vocation assessment. Reevaluation should occur every 2-3 years to gauge treatment effectiveness and encourage wellness.

Recommendation 6.14 - Chpt. 6, Sect. 1V.2

Congress should eliminate the ban on concurrent receipt for all military retirees and for all servicemembers who separated from the military due to service-connected disabilities. In the future, priority should be given to veterans who separated or retired from the military under chapter 61 with:

- ◆ Fewer than 20 years of service and a service-connected disability rating greater than 50 percent, or
 - Disability as a result of combat.

Recommendation 7.5 - Chpt. 7, Sect. 11.3

Eligibility for Individual Unemployability should be consistently based on the impact of an individual's service-connected disabilities, in combination with education, employment history, and medical effects of an individual's age or potential employability.

Recommendation 7.6 - Chpt. 7, Sect. 11.3

Recognizing that Individual Unemployability is an attempt to accommodate individuals with multiple lesser ratings but who remain unable to work, the Commission recommends that as the VA Schedule for Rating Disabilities is revised, every effort should be made to accommodate such individuals fairly and with the basic rating system without the need for an Individual Unemployability rating.

Recommendation 7.7 - Chpt. 7, Sect. 111.2

Congress should increase the compensation rates up to 25 percent as an interim and baseline future benefit for loss of quality of life, pending development and implementation of quality of life measure in the Rating Schedule. In particular, the measure should take into account the quality of life and other non-work related effects of severe disabilities on veterans and family members.

Recommendation 7.9 - Chpt. 7, Sect. 111.2

Congress should consider increasing special monthly compensation, where appropriate, to address the more profound impact on quality of life by the disabilities subject to special monthly compensation and review ancillary benefits to determine where additional benefits could improve disabled veterans' quality of life.

Recommendation 7.10 - Chpt. 7, Sect. 111.2

Congress should enact legislation that would bring the ancillary and special purpose benefits to the levels originally intended considering cost of living and provide for automatic annual adjustments to keep pace with cost of living.

Recommendation 7.14 - Chpt. 7, Sect. 111.3

VA and DoD should realign the disability evaluation process so that the Services determine fitness for duty, and servicemembers who are found unfit are referred to VA for disability rating. All conditions that are identified as part of a single, comprehensive medical examination should be rated and compensated.

Recommendation 8.2 - Chpt. 8, Sect. 111.1.B

Congress should eliminate the Survivor Benefit Plan/Dependency and Indemnity Compensation offset for survivors of retirees and in-service deaths.

Recommendation 9.1 - Chpt. 9, Sect. 11.5.A.b

Improve claims cycle time by:

- Establishing a simplified and expedited process for well documented claims, using best business practices and maximum feasible use of information technology; and
- Implementing an expedited process by which the claimant can state the claim information is complete and waive the time period (60 days) allowed for further development.

Congress should mandate and provide appropriate resources to reduce the VA claims backlog by 50 percent within 2 years.

Recommendation 10.11 - Chpt. 10, Sect. V11

VA and DoD should expedite development and implementation of compatible information systems including a detailed project management plan that includes specific milestones and lead agency assignment.

Recommendation 11.1 - Chapter 11

Congress should establish an executive oversight group to ensure timely and effective implementation of the Commission recommendations. This group should be cochaired by VA and DoD and consist of senior representatives from appropriate departments and agencies. It is further recommended that the Veterans' Affairs Committees hold hearings and require annual reports to measure and assess progress.

Early reviews of the Commission's report by the National Association for Uniformed Services (NAUS) and the Veterans of Foreign Wars, (VFW) were congratulatory in nature and urged the VA, DoD and the Congress to "get on" with implementing the recommendations.

In closing, let me wish a belated Happy 232nd Birthday to the U.S. Navy on October 13, 2007. It is also time to say a Happy 232nd Birthday to the United States Marine Corps effective November 10th, 2007. Semper Fi Marines! I would also like to thank all of you who continue to support the Oregon Veterans' Home and our troops in the field around the world.

WWII Era PT Boat Restored, Docked

Following 15 years of restoration, a World War II Patrol Torpedo (PT) Boat has been moored at Portland's Swan Island **Naval Operational Support** Center on May 3rd. Reportedly the only operational PT boat left in the world, PT 658 is operated by a dedicated group of volunteers, mostly prior military and PT Boat veterans and docked near the U.S. Coast Guard Station in Portland.

The 62 year-old boat never saw combat action, but has been restored to near original condition.

Retired U.S. Air Force Reserve Lieutenant Colonel Dale Billups is part of PT 658's crew. The wooden hull craft became better known in the 1960's when the heroic actions of then - Lieutenant John F. Kennedy, skipper of PT 109, were made into a movie.

"This PT boat is a living memorial to the thousands of U.S. sailors who manned these tiny warships in nearly every World War II Theater of operations," Billups said.

Today, PT 658 has all of its original armament. An 1,800 horsepower Packard V-12 engine can propel the 78-foot craft at nearly 50 m.p.h.

Billups said that local members of the Machinist's union donated their time to overhaul the steering gear, rudders and propellers. The project received generous assistance from: the U.S. Navy, Air Force, Marine Corps, Coast Guard, the Oregon and Washington National Guard, the Oregon Military Museum, the U.S. Army Corps of Engineers, Peter Tare (the National Organization of World War II PT Boat officers), and numerous corporate and individual contributors."

With three free days of admission for all veterans, a hosted lunch event and other special activities, the number of veterans and their families attending the 2007 Oregon State Fair, August 23 - September 3, increased dramatically over 2006.

Oregon veterans were honored with Veterans' Appreciation Days during the first three days of the Fair and were treated to special events including a veterans' parade and a USO style show. Mo's Restaurants—Home of Mo's World Famous Clam Chowder—also provided a free lunch for veterans and their families.

Peggy Preisz, the general manager of Mo's, said they served more than 2,000 lunches and gave out 1,500 vouchers for a free cup of chowder at certain Mo's restaurants. "It was a wonderful experience for us to be part of that event," Preisz said. "They were so appreciative and it humbled us to be able to serve them."

The parade made its way through the fairgrounds and included Color Guards, a column of vintage military vehicles, veterans dressed in military uniforms from different eras and other patriotic participants.

State Fair official Desa Swaim said attendance by veterans had increased from 2006 by approximately 5,000. "We estimated that about 8,000 veterans were admitted this year, which is a sizable increase in attendance."

The free admission for veterans also meant more visitors at ODVA's booth, according to Val Conley, the Veterans Services
Administrator. Volunteers from veterans' service organizations worked with ODVA employees in the booth. "We're grateful to all of the volunteers who helped reach out to veterans at our state fair booth this year," said Conley.

ENHANCEMENT DAYS SERVE AS CAREER SPRINGBOARD

With career enhancement and job searches on their minds, more than 700 military members, including Oregon National Guard soldiers and active duty personnel, participated in the Soldier Enhancement Day at Medford's National Guard Armory, on September 22.

Army Guard members assigned to four companies within the 1-186 Infantry Battalion in southern Oregon cities volunteered in June 2006 to augment Oregon's 41st Brigade Combat Team who were deployed to Afghanistan. About 850 Guard members served in support of Operation Enduring Freedom.

Organized by the Oregon National Guard's Reintegration Team, the event brought 25 employers as well as college and university representatives together to meet with military members. The Team Manager, Sgt. First Class Vinni Jacques said the event is designed to help soldiers and their families.

"It's an opportunity for these soldiers to see what kinds of careers and resources are available to them and their families," he said. "Our goal is to help servicemembers and families. Our October outreach at the Oregon Institute of Technology in Klamath Falls drew over 300 people including many Vietnam vets."

The Reintegration Team was created in 2004 to help military members with everything from employment to counseling referrals with resources to assist them after returning from combat tours.

Jacques said two career enhancement day events will be hosted in coming months. Employers and other representatives will meet at Clackamas Community College on November 3 for a daylong outreach and another event is being planned in early - 2008 in the Albany-Lebanon-Corvallis area.

Iraq. The combat leader and Operation Iraqi Freedom (OIF) veteran, listed by the numbers, progress in schools, hospitals, water treatment, and inoculations.

A special tribute was given for Corporal Michelle Ring of McMinnville whose parents and family were in attendance.

Ring was Oregon's first daughter to die on the battlefield in the Global War on Terror (GWOT). Christopher Dauterman of ODVA, as emcee of the event, read the U.S. Army Creed in her honor and added "Corporal Ring died wearing the uniform of the greatest country on the face of the earth." Later, the playing of Echo Taps followed a 21-cannon salute in honor of all Americans who have died while serving their country.

Three veterans shared stories of their military experience. Delivering their accounts were Desert Storm and Operation Enduring Freedom (OEF) veteran, First Lieutenant Oscar Quijano, OIF/OEF combat-wounded Army veteran, Tom Wiggins and OIF combat-wounded Army veteran, Jereme Coker. Each of their personal stories were followed with a standing ovation.

During the event, recognition was given to those in attendance who were World War II veterans, Gold Star Families, POW/MIAs and veterans of the Global War on Terrorism. New Veteran Recognition License Plates

The Motor Vehicle Division (DMV) of the Oregon Department of Transportation (ODOT), as a result of the passage of House Bill 3161 in the 2007 Oregon legislative session, will have the new veteran recognition license plates available beginning January 1, 2008. The new plates feature a patriotic red, white and blue design including an American flag and the word 'Veteran'.

Veteran recognition plates may be issued to qualifying veterans with proof of military service in the form of a DD-214 or DD-215. Veterans will be able to choose according to their qualifying service, which designation to appear on their set of veteran plates. Some of the available designations include service related campaign medals, branch of service

seals or if eligible a Service Cross, Bronze Star or Silver Star.

DMV has developed a new one-page application form to help make the ordering process more efficient. Listed here are costs for the new veteran plates considering some variables. (See chart below)

New Plate Q & A

The Oregon Department of Veterans' Affairs (ODVA) and the Oregon Department of Transportation (ODOT) have worked closely together in instituting the new Veteran Recognition Plate Program in Oregon. Many veterans' organizations were instrumental in aiding the passage of this legislation during the 2007 session.

Here are some key questions and answers regarding the new Veteran Recognition Plate Program.

ODVA: When will the new veterans license plates be available?

ODOT: DMV will start issuing the new veteran plates the first week of January. Veterans may submit their applications the last two weeks of December.

ODVA: Who is eligible to purchase a set of veteran plates?

ODOT: Veteran recognition plates are only issued to qualifying veterans. There are no qualifications needed to apply for the Vietnam Veterans of America, or Non Commissioned Officers Association (NCOA).

ODVA: What existing military/veteran plate designations are not available under the new veteran plate program?

ODOT: Oregon Paralyzed Veterans are the only existing group that will continue to be issued on the tree background until their existing supply stock is depleted. All other veteran groups will be ordered on the new veteran plate background.

ODVA: What about the Ex-POW, Disabled Veteran and National Guard plates, are there any changes to those plates?

ODOT: No. Those plates are not veteran group plates and are issued under separate Oregon statutory authority.

ODVA: Are individuals who currently have one of the existing veteran group plates on their vehicle required to purchase a set of the new veterans plates?

ODOT: Vehicle owners are not required to replace their existing tree veteran group plate with the new veteran plate. The tree plates will still be valid until ownership of the vehicle changes or the owner *chooses* to replace the existing plates with the new veteran plates.

ODVA: Is the registration period for the new veteran plates still two years?

ODOT: Yes. Registration periods remain two years. The exception is for brand new vehicles; they are subject to initial registration of four years. Once that first 4-year period is up, they return to a 2-year registration cycle.

ODVA: Can a veteran order the new veteran plates and choose not to have any emblem or designation appear on the plates?

ODOT: Yes. A plain veteran plate will be available.

ODVA: Under the new veteran plate program there is a Gold Star Family plate. Are the requirements or eligibility different for that plate?

ODOT: Yes. The requirement for a Gold Star Family plate is different and customers applying for this plate will need to complete a different form, a Veteran Group Plate Eligibility Form.

ODVA: Does a veteran need to provide proof of military service?

ODOT: Yes, the application states –

GENERAL INFORMATION

Veteran Recognition plates may only be issued to qualifying veterans. Veteran Recognition plates may be issued with an insignia or service related medal, or with that area blank.

To apply for Veteran Recognition plates:

1. You must complete and sign this form.

You must provide proof of military service and/or proof of award of a military related medal. This proof must be provided in the form of a DD214 or DD215. The DD214 or DD215 must indicate the medal awarded or a letter indicating the award can accompany the DD214 or DD215.

ODVA: Can a veteran have more than one set of veteran plates?

ODOT: Yes, a veteran can have multiple sets of veterans' group plates. However, the Disabled Veteran plates and Ex-POW plates are not classified as group plates and are restricted to 1 set per veteran.

ODVA: What type of vehicles can the veteran group plates be used for?

ODOT: Group plates (of any type including all veteran group plates) are only issued for passenger vehicles.

ODVA: Can a veteran select a different designation for each plate of the set, for example a branch of service seal on one plate and a campaign medal on the other?

ODOT: No. All plates are sold in pairs with matching front and back plates.

ODVA: Can the plates be ordered by mail?

ODOT: Yes. The veteran can download the forms from the DMV website at www.oregon.gov/ODOT/DMV/forms. or pick them up at any DMV field office. Once completed the form should be returned along with either an Application for title and Registration (form 735-226) or an Application for Registration, Renewal, Replacement or Transfer of Plates and /or Stickers (form 735-268) and the required fees to DMV Headquarters, 1905 Lana Avenue, Salem, Oregon 97314.

Pearl Harbor 1941- 42... A Personal Recount

In tribute to Pearl Harbor Day, and in memory of the servicemembers who lost their lives that day, as well as those who survived the event, the Oregon Department of Veterans' Affairs is honored to reprint this first-hand account as the events of December 7, 1941 and the days immediately following unfolded.

We will never forget that fateful day, nor those who fought so bravely in the midst of chaos and suffering for America and their fellow Americans.

Makalapa Heights Pearl Harbor, T.H.

Monday December 8, 1941

Dear Family,

I feel that I must try to put on paper the events I have witnessed, as they occurred during the last 32 hours. I don't even know that I will be allowed to send this – but someday, perhaps, you will read it.

Yesterday morning, December 7, I awoke at 7 a.m. I was very annoyed with myself for waking so early as, on Sunday mornings, we don't have breakfast until 9:30. In order to pass the time, I sat in my bedroom working a crossword puzzle.

At about 7:40 I heard the sound of a terrific explosion. However, as crews have been blasting nearby (for underground oil storage facilities) every single day since we moved here in September, I didn't pay much attention. Then in a few minutes, when I heard a second and third explosion, I went to the window for a look – and was alarmed to see a huge fire with billows of thick, black smoke.

To me, the fire appeared to be on Ford Island or in the Navy Yard proper. I rushed to awaken dad, and pulling on some clothes, he came on the double. At first we thought the smoke might be from the burning of a sugar cane field – a common agricultural practice here. At just that moment, some planes flew right over our house, very low and close enough to see that they were not our planes – they immediately dive-bombed the OKLAHOMA and several other ships while we stared from the window in stunned silence.

I heard dad say, "My God, we are being attacked!" and watched numbly as he grabbed his uniform jacket and raced out the front door in time to jump into Admiral Kimmel's car as it came speeding by.

Well, as I have said, that was a lifetime ago. Not wanting to be alone, I dressed hastily and went across the street to Mrs. Earle's house, where we were soon joined by Mrs. Mayfield. The three of us, seeking comfort in numbers, stood on the Earle's lawn and

watched as our beautiful fleet was destroyed before our eyes.

We were so close to this entire battle, mind you, that we could see the men and officers on the ships that were being bombed and torpedoed. I don't suppose anyone has seen such a sight before, and I trust they never will again.



The **OKLAHOMA** was the first to go down. She just turned right over on her side and, the water there being shallow, her bottom is exposed for about ten feet or more. There are men working on her now, trying to cut through the steel hull to rescue those who are still alive inside. They have communicated with them and have given them air – don't ask me how they do it.

When the **ARIZONA** got her fatal blow, she was a mass of flames instantly. Not having any facts, and only my own observations to draw from – I judge they must have hit her oil tanks or powder magazine. We stood there and watched the **CALIFORNIA**'s bow hit bottom, but otherwise she's up. Then there are



three other battleships right together that are a mass of tangled superstructures. I have heard they are the WEST VIRGINIA, the TENNESSEE and the MARYLAND. The PENNSYLVANIA was also damaged. She had been in dry dock, but managed to get out when the bombing began. The OGLALA was sunk at her dock by an aerial torpedo. Two destroyers were demolished in dry dock with all on board feared lost. I believe several other destroyers were lost as we stood there watching – but the scene was so filled with smoke and flames and noise and so much was happening at once that I can't be sure.

We saw the NEVADA make a desperate effort

to escape the harbor. She pulled herself away from the other ships and headed out the channel for the open sea. When she was almost out, she received a crippling blow and went on the beach.

The RALEIGH, which was tied up on the far side of Ford Island (our Navy Air Base), was hit twice, but is still afloat. I have probably left out some – but what matter. Can you imagine our feelings as we stood there helplessly watching our fleet crumple and go down before our eyes as if the ships were made of papier-mâché? – not able to lift a finger in their own defense during the entire first attack!

Those Japanese devils came down so low it was easy for us to see the round red sun on the bottom of their wings. Oh, they did a good job!

When they (the Japs) came back the second or third time – I forget which – our antiaircraft were put to work and you cannot imagine such concentrated firing. When shrapnel began falling all around us, we took shelter inside as our homes were in the direct line of fire. With the enemy's path of attack just overhead, every gun on top of buildings in the Sub Base and Navy Yard – as well as those of the fleet still above the water – were aimed in our direction. We didn't know at what moment one of those bomb-laden Jap planes would land on the house.

Shell fragments and bullets rattled down on the roof like hailstones – and I have to admit that I experienced abject, stark naked terror. These houses, like most tropical houses, are very flimsy and have no cellars so – when things got very bad – we crawled under the dining room table. We could see hundreds of men swimming through that oilladen water. It was not a pretty picture.

As the Jap's planes were bombing our fleet, they also bombed Ford Island and Hickam Field, the Army Air Base. Gigs, motorboats and launches were plying back and forth from ship to ship all the time the bombings were going on. I should say the raids started about 7:45 a.m. and continued until about 2:30 p.m.

Dad came home for a few minutes last night and there was one alarm while he was here. From every direction, our antiaircraft

weapons went into action. It was the most magnificent (?) sight to witness (if you like fireworks). They were using tracer bullets and every seventh one was a flaming streak — weaving the heavens all about with tangled tapestries of fire.

When dad left, which was immediately, Mary Lou (our maid) and I went over to the Earle's again. We felt if all the women stayed together, it would help keep up morale. There were five of us altogether, and the night started off kind of peaceful. Of course, with a total blackout in effect, it was frightening at best. Toward morning however, so many alarming messages began coming over the Honolulu radio station that the suspense became terrific.

This is a sample of what we heard: "O.P. 12 – N.W. 1500 ft. – enemy – many – heading towards Pearl Harbor. O.P. 2 N.E. 2000 ft. – enemy – many – heading towards Hickam Field and Pearl Harbor" etc. One right after another – and on and on [sic].

Around noon today we heard that this broadcast was not authorized and how or why it was done I'll never know – nor why it was allowed to go on for so long and terrorize the population. But it was and did! By the way, we

have been ordered to keep our radios tuned to KGU day and night and all radio stations have been taken over by the Army.

We have also been told such things as not to drink a drop of water, boiled or otherwise, as they are examining it for evidence of pollution. We were told to keep off the streets and highways and to purchase limited supplies of groceries from the store at which we are known and of course, ordered to blackout.

I haven't had but two hours of rest[full] sleep since I awoke yesterday morning. I hope to be able to sleep tonight. I don't know whether dad will get home at all tonight, but I hope so, as he has had less sleep than I. I have made all available beds, and can take care of five people beside ourselves – several more if they don't mind sofa beds.

As far as casualties are concerned, I have no idea how many there are. I do know that very few, if any, were saved from the ARIZONA. She is still burning – and practically finished. I hope never to see such a sight again as that ship ablaze from stem to stern and burned to the water's edge. Can you believe her flag still flies and waves in the breeze, untouched? Captain VanValkenburgh was in command, and both he and Admiral Kidd, whose flagship she was, were lost with her. Also lost was Captain Bennion of TENNESSEE and, I've heard, Captain Bode of

the **OKLAHOMA** – but I'm hoping that rumor is false.

Betty is the only one of you who can visualize this scene, as she knows the layout. Do you know that an enemy submarine got all the way into the harbor past the Navy Yard? Fortunately it was rammed and sunk by a destroyer. I understand that there is also an enemy sub ashore off Diamond Head.

We have not had any news of the outside world excepting that Wake, Midway, Guam and Manila were also hit. I almost forgot to tell you that yesterday when I came home after that sixhour attack, I found that a shell had gone through the living room window, screen, glass and Venetian blind and all – then hit the door frame across the room – went clean through the door and buried itself in the heavy entrance door in the front hall. A nice little souvenir!

While writing this, I hear the crack of rifle fire every few minutes and know that someone, who has no business there, has gone a little too close to the oil storage tanks – or done one of the various other things for which the marines are ordered to shoot on sight.

Oh yes, I have a seat on the bald-head row! Love and kisses to each and all of you. Mother

The highlight of the evening was the presentation of medals by Senator Wyden accompanied by Douglas County veterans service officer Mary Newman. WWII veteran Jack Lewis, USMC (Ret), from Azalea, Oregon was presented a Combat Action Ribbon and the Asiatic-Pacific Campaign Medal with three stars for battles at Tinian, Saipan, and Iwo Jima. Carol Hunt of Roseburg is the widow of Milton Hunt, a

veteran who served in the USMC during WWII and in the U.S. Navy during the Korean War. She was presented the Purple Heart Medal her husband had earned but never received.
