

# Publications on Copyright

This circular presents sources of publications about copyright. Information on obtaining publications on copyright is grouped here according to the source.

The types of publications that are available include informational circulars, application forms, selected reports, studies on specific copyright issues, copies of the law, copyright registration and recordation information, and volumes of judicial decisions on copyright. Many publications are available online at no charge. Others may be ordered in hard copy (CD, microfiche, paper) for a fee. There is no charge for publications obtained from the Copyright Office.

## Copyright Office

Below is information on how to view and obtain Copyright Office publications and records. Publications are available on the Copyright Office website. Many are available in paper format by request. Copyright Office records in machine-readable form cataloged from January 1, 1978, to the present, including information on copyright registrations and recorded documents, may be searched and examined on the Copyright Office website.

## Form for Primary Registration Method

Use the online electronic Copyright Office (eCO) for registering basic claims to copyright, even if the deposit is not in digital format. For information on regis-

tration with eCO, go to the Copyright Office website or contact the Copyright Office.

### **Form for Alternate Registration Method**

The next best option for registering basic claims is the fill-in Form CO. This is a generic form for registration of a single work of the performing arts and visual arts as well as literary works, sound recordings, motion pictures, and single issue serials. Complete this form on your personal computer, print it out, and mail it to the Copyright Office together with the filing fee and deposit. As you fill out the form, a 2-D barcode is created on each page. The barcode contains the information that you type and will enable the Copyright Office to process the application faster and more efficiently. Do not save and reuse a form that has been filled out. The information it contains is unique for each work that you register.

### **Application for Preregistration**

Form PRE: For preregistering certain works that have had a history of prerelease infringement. This form is only available on the Copyright Office website at [www.copyright.gov](http://www.copyright.gov) and may only be filed online.

### **Registration with Paper Forms**

Paper versions of Form TX (literary works); Form VA (visual arts works); Form PA (performing arts works, including motion pictures); Form SR (sound recordings); Form SE (single serials); and Form CON (continuation sheet for applications) are still available in paper. These paper forms are not accessible on the Copyright Office website; however, staff will send them to you by postal mail upon request. #### **RENEWAL**

Form RE: For renewal of claims of copyright

Form RE/CON: Continuation form to be used only in conjunction with Form RE application form

Addendum to Form RE: For all works published between January 1, 1964, and December 31, 1977, that were not registered during their first 28-year term. Must accompany Form RE.

#### **URAA—FOR RESTORED WORKS**

Form GATT: For restored works

Form GATT/CON: Continuation form to be used only in conjunction with GATT application form

##### **GIVEN IN A REGISTRATION**

Form CA: To correct an error or amplify the information given in a registration

Form CON: Continuation sheet to be used with Form CA

**NOTE:** You must have Adobe Acrobat Reader installed on your computer to view and print the forms. The free Adobe Acrobat Reader may be downloaded from Adobe Systems Incorporated through links from the same Internet site at which the forms are available. Print forms head to head (top of page 2 is directly behind the top of page 1) on a single piece of good quality 8½" × 11" white paper. To achieve the best quality copies of the application forms, use a laser printer. Or you may request paper copies from the Copyright Office.

**Catalog of Copyright Entries**

The Copyright Office published the *Catalog of Copyright Entries* (CCE) in print format from 1891 through 1978. These volumes may often be available at federal depository libraries. From 1979 through 1982 the CCE was issued in microfiche format. The catalog was divided into parts according to the classes of works registered. Each CCE segment covered all registrations made during a particular period of time. Renewal registrations made from 1979 through 1982 are found in section 8 of the catalog. Renewals prior to that time were generally listed at the end of the volume containing the class of work to which they pertained.

Effective with registrations made since 1982, the only way to see the CCE is by using the Internet to access the Copyright Office automated catalog. The automated catalog contains entries from 1978 forward. To access the catalog, go to [www.copyright.gov](http://www.copyright.gov).
