Application for Special U.S. Military Veteran Registration Plate

This application may only be used for a vehicle owned or co-owned by a veteran or service member who served or is serving in the Armed Forces of the United States. Plates may not be personalized. Qualified applicants are limited to one Ex-Prisoner of War plate.

Check the applicable block below. **NOTE:** If your vehicle does not have current registration and you are applying for registration in addition to the special registration plate, please refer to the instructions on the reverse side of this application.

The following plates may ONLY be used on a passenger car or truck with a registered gross weight of not more than 10,000 pounds.

These plates require a \$7.50 fee, provided the vehicle has current registration:

The following plates may ONLY be used on a passenger car or truck with a registered gross weight of not more than 10,000 pounds.

These plates require a \$20 fee, provided the vehicle has current registration:

The following plate may ONLY be used on a passenger car or truck with a registered gross weight of not more than 10,000 pounds.

The following plate may ONLY be used on a motorcycle. This plate requires a \$20 fee, provided the vehicle has current registration:

To renew your vehicle's registration in conjunction with this application, you must complete and attach your vehicle renewal application or Form MV-140 and attach a check or money order for the appropriate annual registration renewal amount and the appropriate plate fee listed below:

Annual Registration Renewal Fee for qualified vehicles:

Truck (5,000 pounds or less) - \$58.50
Truck (5,001 - 7,000 pounds) - \$81.00
Truck (7,001 - 9,000 pounds) - \$153.00

Passenger vehicle - \$36.00
Motorcycle (Veteran's Motorcycle plate only) - \$18.00
Truck (9,000 - 10,000 pounds) - \$198.00

NOTE: Individuals should list their PA Driver's License (PA DL) or Photo ID# in the space provided. No U.S. military registration plate will be duplicated. If your plate is lost, stolen or defaced you will need to reapply for a U.S. military plate by completing this application and submitting with the appropriate fees. Should you need an immediate replacement plate, please complete and submit Form MV-44, "Application for Duplicate Registration Card, Replacement of Registration Plate, Renewal Sticker or Weight Class Sticker" and submitting a fee of \$7.50. A standard issued plate will be issued until the replacement specialty plate can be provided. (Note: Form MV-44 is available on our website at www.dmv.state.pa.us.)

REQUIRED DOCUMENTATION

Veterans who cannot provide the required documentation below should contact their nearest VA Office and obtain Form SF180, "Request Pertaining to Military Records" which should be completed and forwarded to the appropriate Personnel Records Center.

NOTE: A legible certified copy of Form DD214, Separation Papers or Discharge Papers showing eligibility may be submitted as proof for issuance of any special plate listed below in lieu of the items listed under each plate type (except the Korean Defense Service Medal) . The DD214 form, Separation Papers or Discharge Papers must be certified by the County Recorder's Office located in the County Courthouse.

1. **An Ex-Prisoner of War** applicant must submit a legible photocopy of the following which indicates dates of imprisonment. **Registration Fee - \$10.00 processing fee in lieu of applicable full registration fee.**
 - ◆ Certification of Imprisonment from the appropriate branch of the Armed Forces or from the Veterans' Administration.
2. **A Purple Heart** applicant must submit a legible photocopy of one of the following which clearly indicates that a purple heart was awarded:
 - ◆ A copy of the general order.
 - ◆ A copy of the Certificate of Award.
 - ◆ A certification of the award from the Veterans' Administration.
3. **A World War II Veteran** applicant must submit a legible certified copy of Form DD214, Separation Papers or Discharge Papers which indicates service anytime during the period of December 7, 1941 through December 31, 1946.
4. **A Persian Gulf War Veteran** applicant must submit a legible photocopy of one of the following which indicates service beginning August 2, 1990 in the Southwest Asia Theater of Operations through the present time.
 - ◆ A copy of the Southwest Asia Service Medal Award between August 2, 1990 through November 30, 1995 or,
 - ◆ A copy of the Armed Forces Expeditionary Medal awarded between December 1, 1995 to present or, when the applicant is currently on active duty, a statement of service from the applicant's commanding officer verifying duty in the Southwest Asia Theater.
5. **A Pearl Harbor Survivor** applicant must submit a legible photocopy of one of the following which indicates the applicant was present at Pearl Harbor on December 7, 1941:
 - ◆ A copy of the verification made by the U.S. service unit from the appropriate branch of the Armed Forces in which the applicant served.
 - ◆ For non-military applicants, documentation from the U.S. Civil Service Commission such as an I.D. card or other written verification.

Members of a Pearl Harbor Survivors Organization may have the organization verify their qualification in Section D in lieu of a copy of documents above.
6. **A Vietnam Conflict** applicant must submit a legible certified copy of Form DD214, Separation Papers or Discharge Papers which indicate one of the following medals was awarded:
 - ◆ A copy of the Armed Forces Expeditionary Medal if applicant served in Vietnam between July 1, 1958 to July 3, 1965 or,
 - ◆ A copy of the Vietnam Service Medal if applicant served in Vietnam between July 3, 1965 through March 28, 1973.
7. **An Expeditionary Forces** applicant must submit a legible certified copy of Form DD214 which indicates that either a naval or armed forces Expeditionary medal, a Kosovo Campaign Medal or a Global War on Terrorism Expeditionary Medal was awarded.
8. **A Korean War Veteran** applicant must submit a legible photocopy of one of the following which indicates the applicant served in Korea anytime during the period of June 27, 1950 through January 31, 1955:
 - ◆ A copy of the Korean Service Medal Award.
 - ◆ Statement of Service in Korea during the period of time listed above from the St. Louis, Missouri Records Center at: Department of Army, National Personnel Records Center, 9700 Page Blvd., St. Louis, Missouri 63132.
9. **An Operation Iraqi Freedom** applicant must submit a legible certified copy of Form DD214, indicating Operation Iraqi Freedom service or an Iraqi Campaign Medal was awarded.
10. **Special Plate for Veterans** applicant must submit a legible certified copy of Form DD214, Separation Papers or Discharged Papers which indicate honorable discharge from the Armed Forces.
11. **An Operation Enduring Freedom** applicant must submit a legible certified copy of Form DD214, indicating Operation Enduring Freedom service or an Afghanistan Campaign medal was awarded.
12. **A Veteran Motorcycle** applicant must submit a legible certified copy of Form DD214, Separation Papers or Discharge Papers which indicates honorable discharge from the Armed Forces of the U.S. or a reserve component of the armed forces. NOTE: National Guard Reservists will need to submit Form NG22B.
13. **Korean Defense Service** applicant must submit a legible certified copy of Form DD215, indicating Korean Defense Service medal was applied for and awarded.
