Recreation fees provided funding to improve a variety of recreation facilities on the Fremont-Winema National Forest this past year.

Funding provided by recreation fees enabled us to: make improvements at the Mt. McLoughlin Trailhead, rebuild the boat ramp at East Bay Campground on

Thompson Reservoir, and make public health and safety improvements at the Drakes Peak rental fire lookout. Without this important funding source these improvements could not have been made, given our declining recreation budgets.

Keeping all these recreation sites clean, maintained, free of encroaching vegetation and relatively safe is one of the biggest jobs on YOUR Forest. The recreation fee program goes a long way towards helping us do this. Most of the fees received go right back to the area where they were collected. Northwest Forest Pass:
