<i>Retrievability</i>	System indexed by number assigned when suggestion or nomination is received. Suggestions are cross-referenced by name of suggester and subject of suggestion.
<i>Safeguards</i>	Only authorized staff has access to the files.
<i>Retention and Disposal</i>	Denied suggestions are purged and destroyed five years after denial date. Adopted suggestions are retained permanently as are all special achievement awards, quality increase and public service awards, RRB Award for Excellence, and government-sponsored awards.
