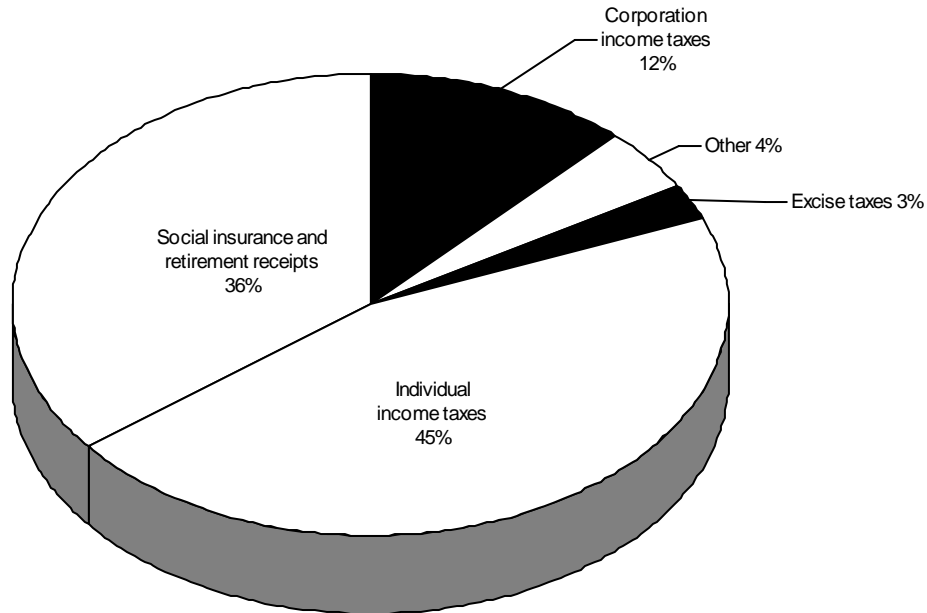


RECEIPTS BY SOURCE

Total receipts decreased by \$44 billion, totaling \$2,524 billion in fiscal 2008. The graph below shows receipts by source.



The text below describes major changes in the amount of receipts by source category. The table that follows shows the amount of receipts for fiscal 2008 and 2007 by source category. It also includes the amount and percentage change from fiscal 2007.

- **Individual income taxes** were \$1,146 billion in fiscal 2008. This was a decrease of \$17.7 billion, or 1.5 percent.
- **Corporation income taxes** were \$304.3 billion, a \$65.9 billion decrease from fiscal 2007 to fiscal 2008 or 17.8 percent.
- **Social insurance taxes and contributions** changed from \$869.6 billion in fiscal 2007 to \$900.1 billion in fiscal 2008. This represents a net increase of \$30.5 billion, or 3.5 percent.
 - **Employment and general retirement contributions** totaled \$856.5 billion, an increase of \$32.2 billion, or 3.9 percent over the prior year.
 - **Unemployment insurance** receipts were \$39.5 billion in fiscal 2008. Receipts decreased by \$1.56 billion from fiscal 2007, which amounts to 3.8 percent.
 - **Other retirement contributions** totaled \$4.2 billion in fiscal 2008, a decrease of 2.2 percent from fiscal 2007.
- **Excise taxes** receipts in fiscal 2008 were \$67.3 billion, an increase of 3.5 percent from the prior year.
- **Other** receipts, including estate and gift taxes, customs duties and miscellaneous receipts increased from \$99.3 billion in fiscal 2007 to \$106 billion in fiscal 2008. The major components are shown below.
 - **Estate and gift tax** receipts were \$28.8 billion, a \$2.8 billion or 10.8 percent increase from fiscal 2007 to fiscal 2008.
 - **Customs duties** in fiscal 2008 were \$27.6 billion, an increase of \$1.6 billion or 6 percent from the prior fiscal year.
 - **Miscellaneous** receipts totaled \$49.6 billion in fiscal 2008. This represents a \$2.4 billion or 5.1 percent increase from fiscal 2007.
