

## Children's Bureau Child and Family Services Reviews Status of Program Improvement Plans and Subsequent Child and Family Services Reviews

The following chart includes information about the status of State Child and Family Services Review (CFSR) Program Improvement Plans (PIPs) and re-reviews.

As of April 23, 2009, 50 States, the District of Columbia, and Puerto Rico have completed the 2-year PIP implementation period, 14 States were reviewed in 2007, 18 States were reviewed in 2008, and 11 States are scheduled for review in 2009, and 9 States are scheduled for review in 2010. The Children's Bureau has completed its evaluation of at least 49 of the PIPs and determined that 43 States achieved all of their PIP goals and implemented all required PIP activities, thus rescinding any applicable penalties. Evaluations of the remaining completed PIPs are pending.
