Assistance for Trade-Affected Workers

While the net benefits of foreign trade are enormous, some workers lose their jobs or see their wages reduced due to foreign trade. These workers may be eligible to receive job counseling, job-search assistance, out-of-area job-search and relocation allowances, and income support while enrolled in training under two Department of Labor programs: the Trade Adjustment Assistance (TAA) or North America Free Trade Agreement Trade Adjustment Assistance (NAFTA-TAA) programs. If the Department of Labor certifies that workers are eligible for assistance, funds are allocated to the States to operate these programs. While certification is pending, workers may receive services through the Dislocated Worker Program, which is available at One-Stop Centers across the country.

Workers who lose their jobs or whose hours of work and wages are reduced as a result of increased imports may petition the Department of Labor for assistance under the TAA program. Workers who believe they have been affected directly or indirectly by increased imports from, or shifts in production to, Mexico or Canada may petition under the NAFTA-TAA program. In addition, workers who lose their jobs as a secondary consequence of trade -- because their employers supplied, finished, or completed products for firms directly impacted by trade -- may petition using the "secondary firm" section of the NAFTA-TAA petition. Petitions also may be filed by employers, unions, community-based organizations, or others who represent a group of workers. Workers may petition, and be certified, under both trade programs.
