**COMPLAINT COUNSEL'S UNOPPOSED MOTION FOR ADDITIONAL EXTENSION
OF TIME FOR FILING OF REPLY BRIEFS AND FINDINGS**

In light of recent developments relating to ChevronTexaco's proposed acquisition of Unocal, and the Commission's review of this merger, Complaint Counsel hereby move the Court for a sixty (60) day extension of time – until July 11, 2005 – for the filing of reply briefs and findings in the above-captioned matter. Counsel for Unocal does not oppose this motion. Currently, the parties are scheduled to file reply briefs and findings on May 11, 2005. The additional extension of time will permit Complaint Counsel to assist other staff of the Commission in reviewing ChevronTexaco's proposed acquisition and to assist in analyzing – and potentially resolving – any issues relating to ChevronTexaco's acquisition of Unocal's RFG patents. In light of these developments, a sixty (60) day extension of time would also permit Complaint Counsel to discuss with the parties to the proposed acquisition the possibility of resolving the ongoing litigation.

Accordingly, Complaint Counsel respectfully request that the Court grant an additional extension of time until July 11, 2005 for the filing of reply briefs and findings.
