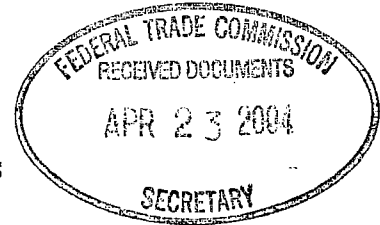

**ORDER ON NON-PARTY PACIFICARE'S
MOTION FOR *IN CAMERA* TREATMENT**

On April 12, 2004, non-party PacifiCare of Texas, Inc. ("PacifiCare") filed its motion for *in camera* treatment of certain potential hearing exhibits identified by North Texas Specialty Physicians and Complaint Counsel and certain deposition testimony. By Order dated April 23, 2004 issued concurrently, PacifiCare's motion is GRANTED IN PART and DENIED IN PART. It is ORDERED that the following documents and information therein shall be accorded *in camera* treatment for a period of five years, to expire on May 1, 2009:
