**UNOPPOSED MOTION FOR ENTRY OF
REVISED SCHEDULING ORDER**

After discussion between Complaint Counsel and counsel for Respondent Rambus Inc. (“Rambus”), Rambus files this Unopposed Motion for Entry of Revised Scheduling Order. As described below, the proposed Scheduling Order would affect only three dates set out in the Second Revised Scheduling Order.

On January 15, 2003, Your Honor issued the Second Revised Scheduling Order, which continued the hearing date and most of the remaining pre-hearing deadlines by approximately three weeks. Counsel for the parties subsequently met and conferred and agreed that because fact discovery will not close until February 24, 2003, and because exhibit lists are not scheduled to be exchanged until March 12, 2003, it is appropriate to continue: (1) the deadline under 16 C.F.R. 3.45(b) for providing notice to parties producing confidential documents of an intent to offer said documents into evidence; (2) the related deadline for motions seeking *in camera* treatment of confidential documents; and (3) the deadline for filing motions for summary decision.

The proposed revised Scheduling Order, which is attached, moves: (1) the deadline for providing notice under 16 C.F.R. 3.45(b) from January 29, 2003 to March 11, 2003; (2) the deadline for filing motions seeking *in camera* treatment from March 12, 2003 to March 21, 2003; and (3) the deadline for filing motions for summary decision from January 29, 2003 to February 19, 2003. The parties also agreed that motions for summary decision would be served on February 18, 2003. All other provisions of the Second Revised Scheduling Order, and all “Additional Provisions” of the October 31, 2002 scheduling order, would remain in effect.
