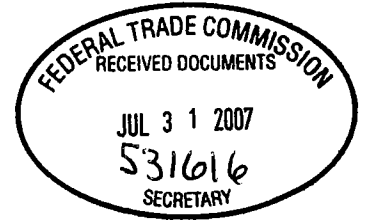

RESPONDENT REALCOMP II, LTD.'S
MOTION TO EXTEND THE DEADLINE FOR FILING CONCURRENT
REPLY BRIEFS AND REPLIES TO PROPOSED FINDINGS OF FACT

Dated: July 30, 2007

Respondent Realcomp II Ltd. ("Respondent" or "Realcomp") moves pursuant to 16 C.F.R. § 3.22 to extend the deadline for filing concurrent reply briefs and replies to proposed findings of fact from August 14, 2007 to August 17, 2007. In support of its motion, Realcomp states:

1. The Order on Post Trial Briefs sets August 14, 2007 as the deadline for filing concurrent reply briefs and replies to proposed findings of fact.

2. A scheduling issue arose after the Order was entered. Realcomp's lead counsel is now required to be in Chicago from August 9 to August 13, 2007. During that period, Realcomp's lead counsel will not be able to effectively work on the materials that are presently due for filing in this case on August 14, 2007.

3. Accordingly, Realcomp moves for a three-day extension of the deadline. Realcomp has discussed this matter with Complaint Counsel, Sean Gates, who indicated that he does not oppose the requested extension.
