QUALIFICATIONS: The U.S. Court of Appeals for the Armed Forces exercises world-wide appellate jurisdiction over court-martial cases involving a variety of legal issues including constitutional law, criminal law, military law, evidence, administrative law and national security law. Because a career clerk must be able to advise the judge on difficult, varied, and important legal issues, the judge is highly selective in hiring. The judge is looking for individuals who have the ability to analyze complex legal issues quickly and to express themselves clearly, both orally and in writing.

At a minimum, applicants must have graduated from an accredited school of law and possess a J.D. degree, be a member in good standing of the bar of a state or the District of Columbia; and have 4-6 years of litigation experience, with some experience in criminal litigation preferred.

The position is a full-time career position. The position is an excepted appointment and employment is "at will."
