- Q31. Despite what is stated in the solicitation; the proposal is to identify key personnel, does the FCC have a desired minimum number of key personnel positions to be proposed? (Page 9 of 23)

- Q32. Can we use our GSA MOBIS Schedule as well as the GSA FABS and IT 70 Schedules?
- A32. Prospective contractors may use MOBIS schedule. However, they must demonstrate applicability.
- Q33. What is the anticipated start date of the contract?
- A33. See A21.
- Q34. In Technical Quote Instructions, Section C Past Performance/Corporate Experience (Volume 3), Quoters are asked to identify up to six Past Performances, and later under Corporate Experience, are asked to describe six comparable efforts. Is it the FCC's expectation that the six Past Performance are mutually exclusive from the six Corporate Experience Contracts?
- A34. No. See 9a and 9b.
- Q35. It has come to our attention that the Past Performance Questionnaires are confusing, in that they appear to have contradictory instructions regarding whether the bidder itself or the referenced customer is supposed to complete the form(s) and submit them to your attention.

Can you please provide clarification?

A35. Vendors submitting quotes shall complete the first part. Customers shall complete and submit Sections 1 and 2.
