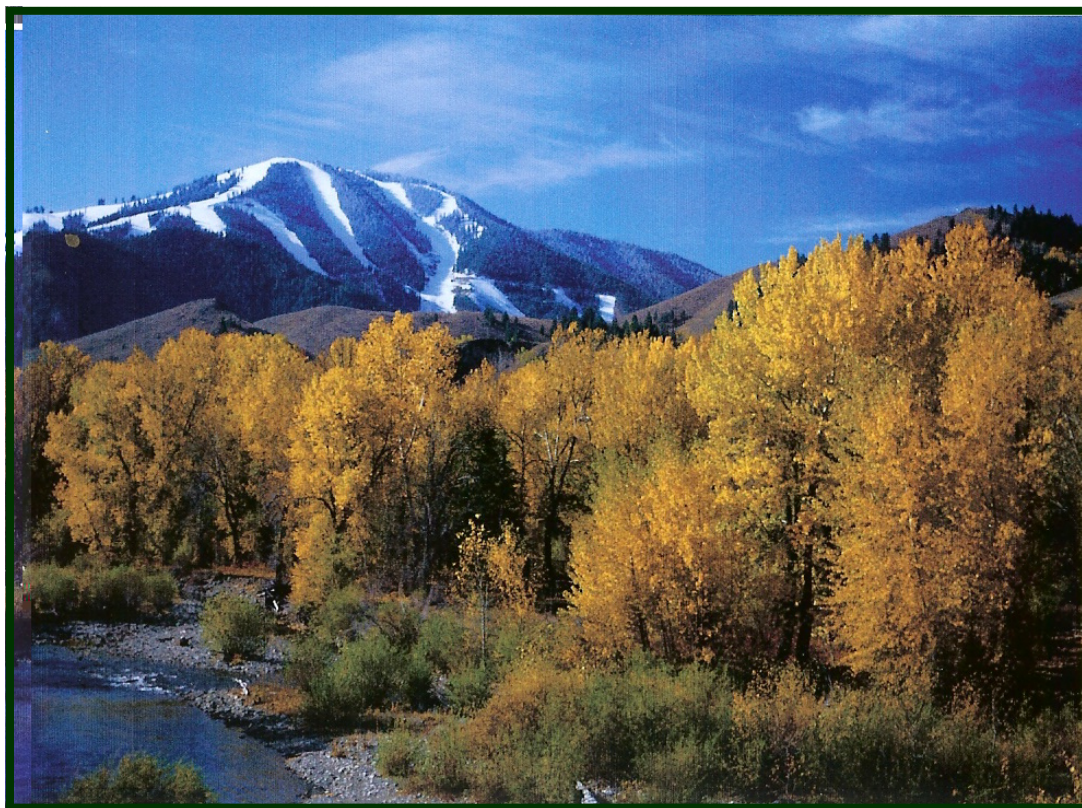

Please join us in mid-October as Idaho hosts the fifth annual Tri-State Federal Bar Association Conference in Sun Valley, Idaho. The Tri-State CLE Program consists of members of Idaho, Utah and Wyoming's Federal Bar Associations. The Conference was organized several years ago by Chief Judges Lynn Winmill (Idaho), Dee Benson (Utah), and William Downes (Wyoming), as a way for practitioners to meet and exchange ideas about federal court practice and procedures of law in the western states. The first Tri-State FBA Conference was held in Jackson, Wyoming, followed the next year by Idaho, and then Utah.

A block of rooms has been set aside at the Sun Valley Lodge at the rate of \$115.00 per night, plus tax. Reservations should be made directly with the Lodge by calling (800) 786-8295. Indicate that you are with the Idaho Chapter, Federal Bar Association.

An evening reception will be held on Thursday, October 8, 2009, with the program beginning on Friday, October 9, 2009. The Conference will end at noon on Saturday, October 10, 2009.
