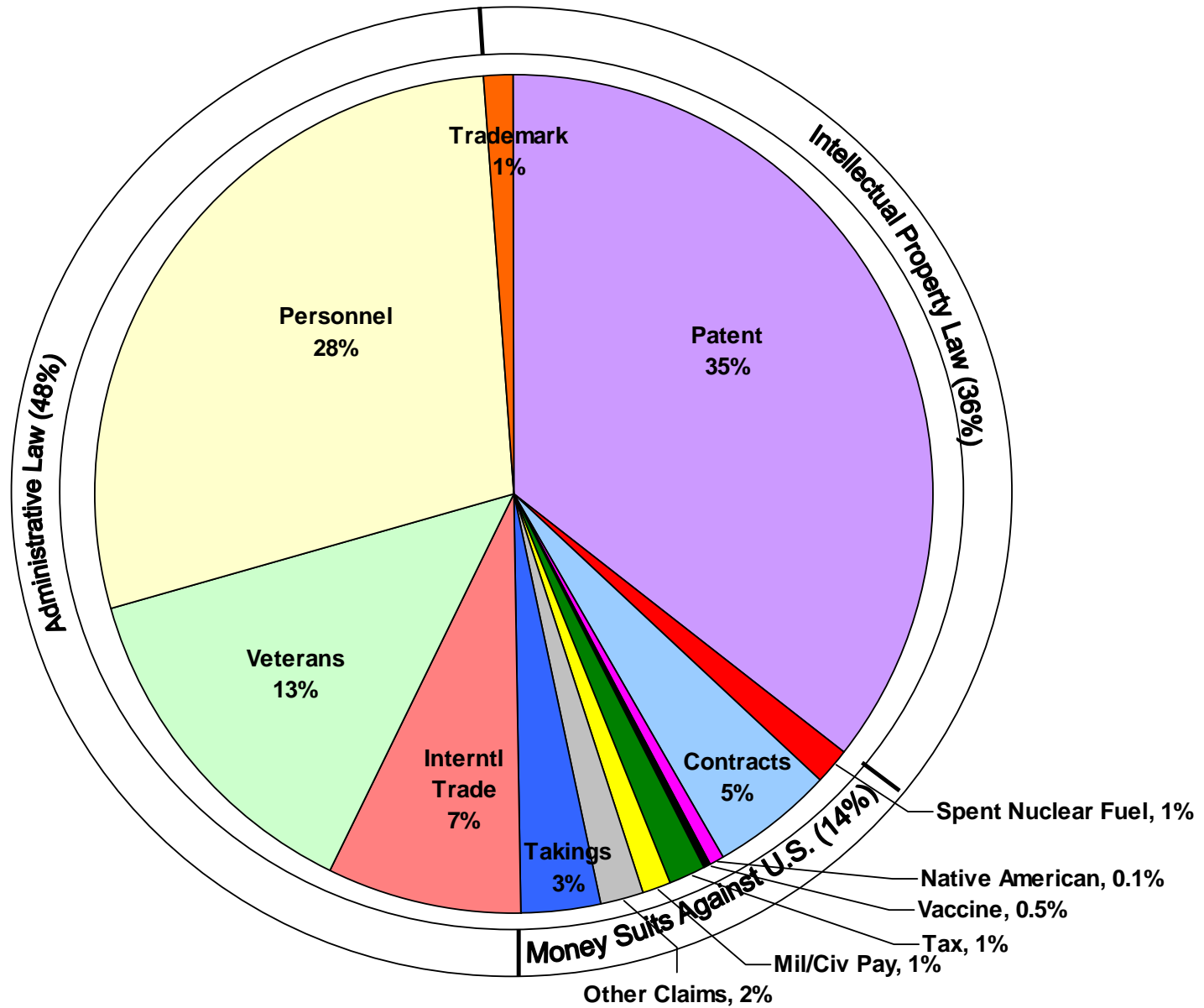

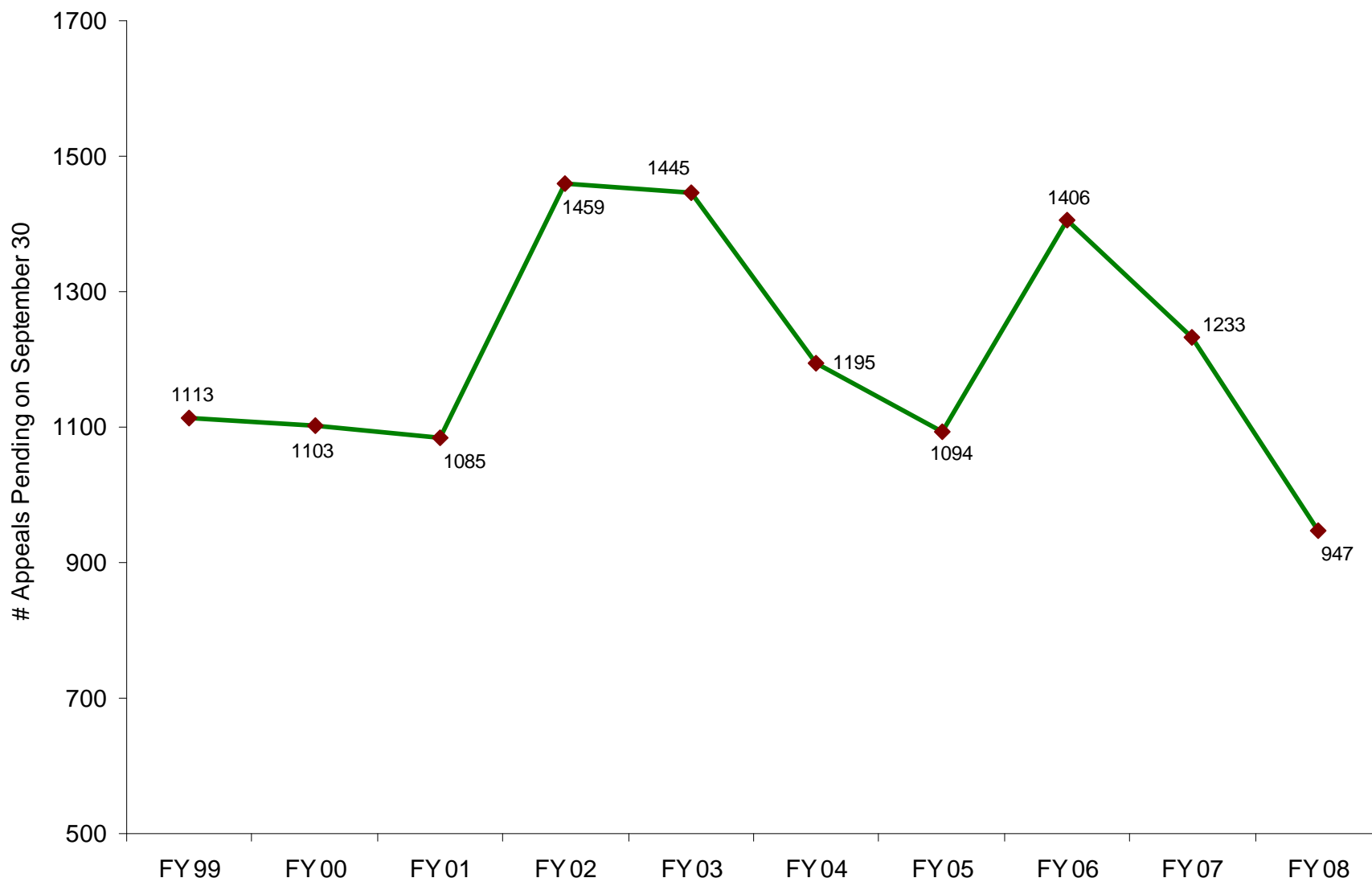

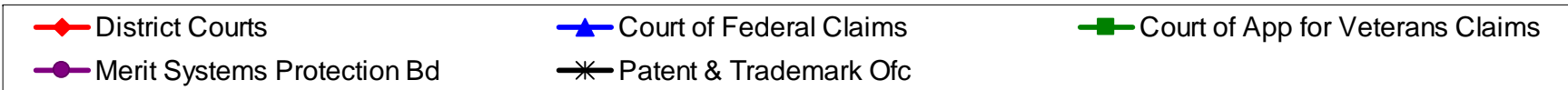
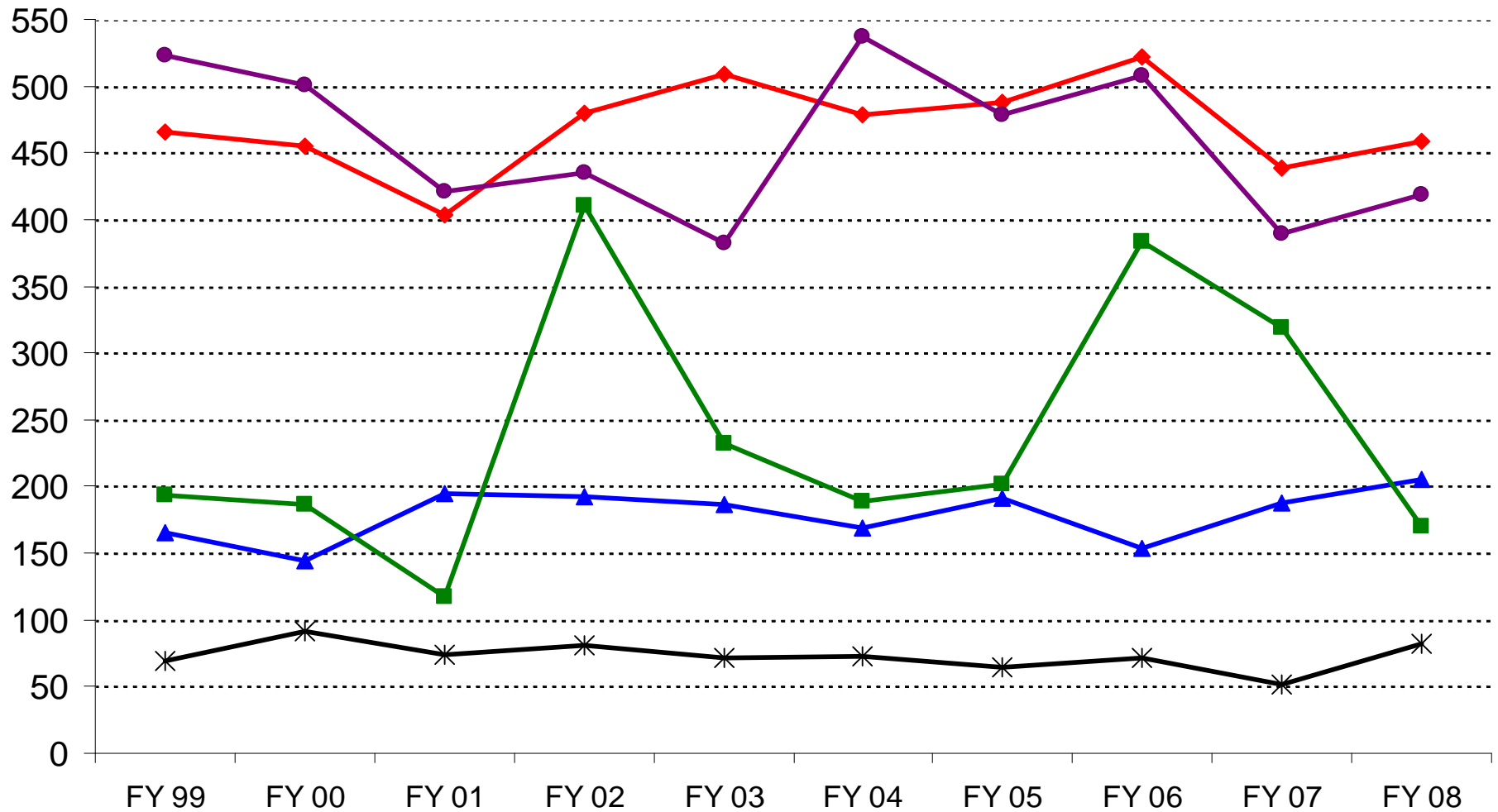
Total Appeals Pending* on the Last Day of the Fiscal Year

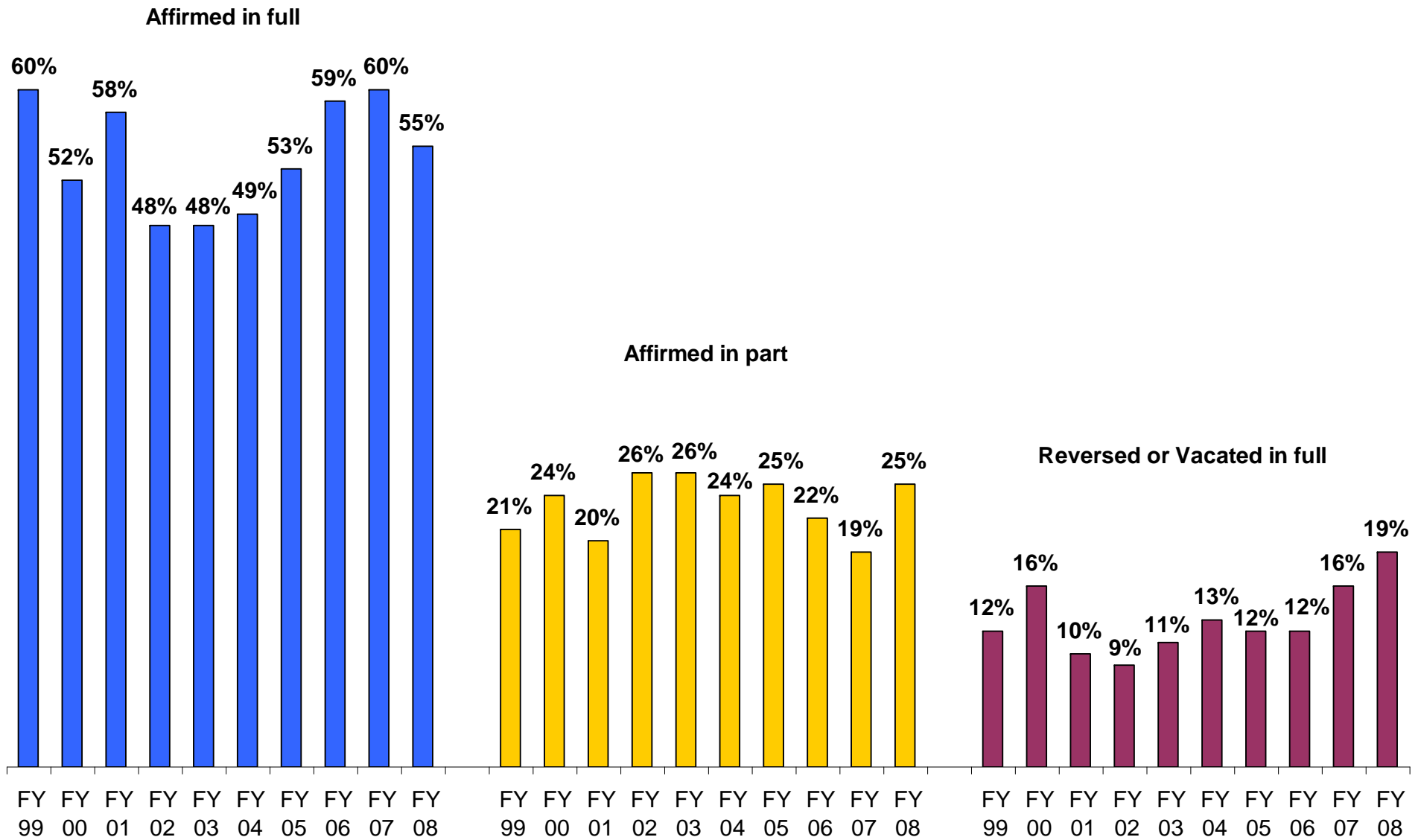

Appeals Filed in Major Origins



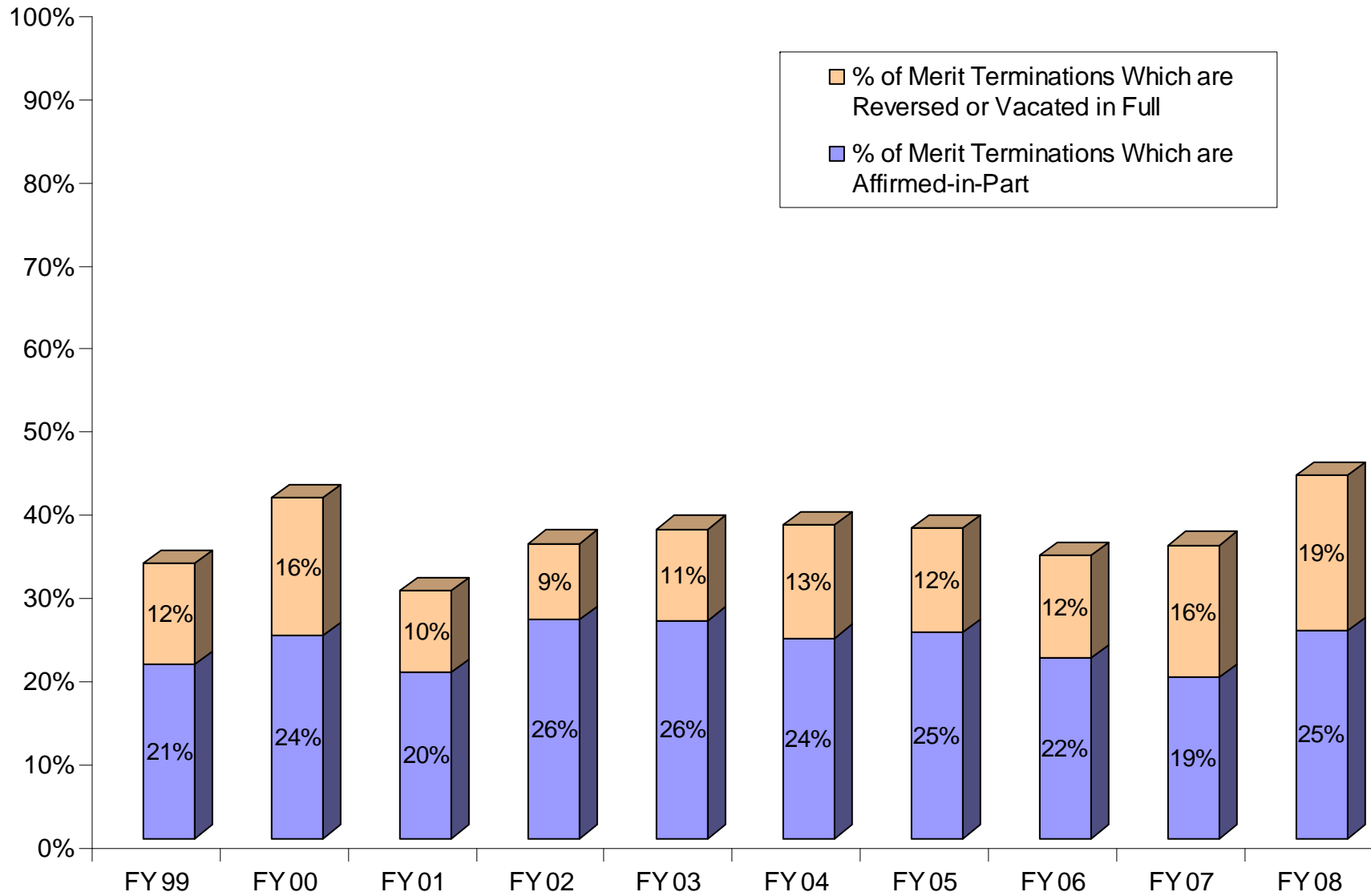

Affirmance and Reversal Rates for District Court Patent Infringement Appeals



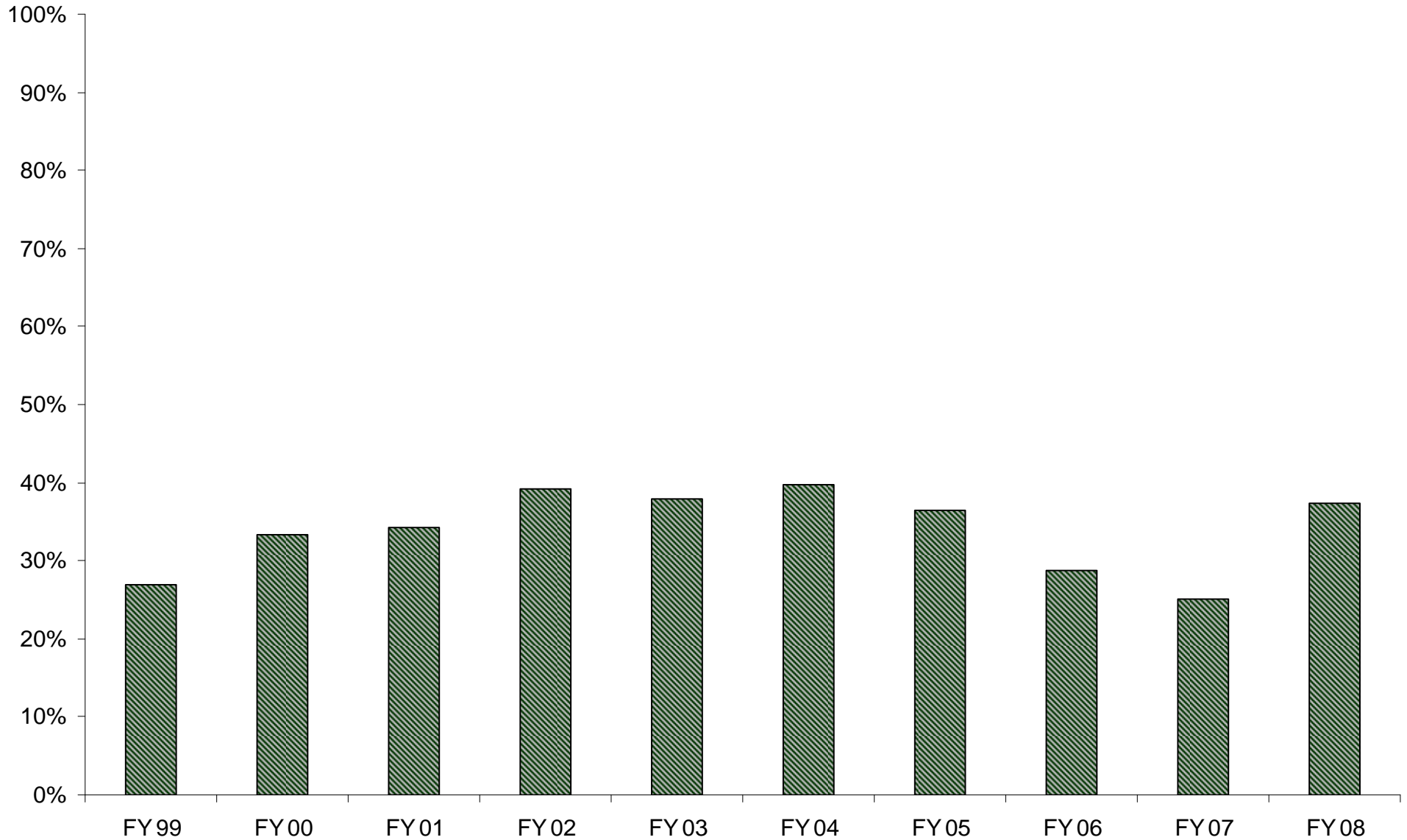

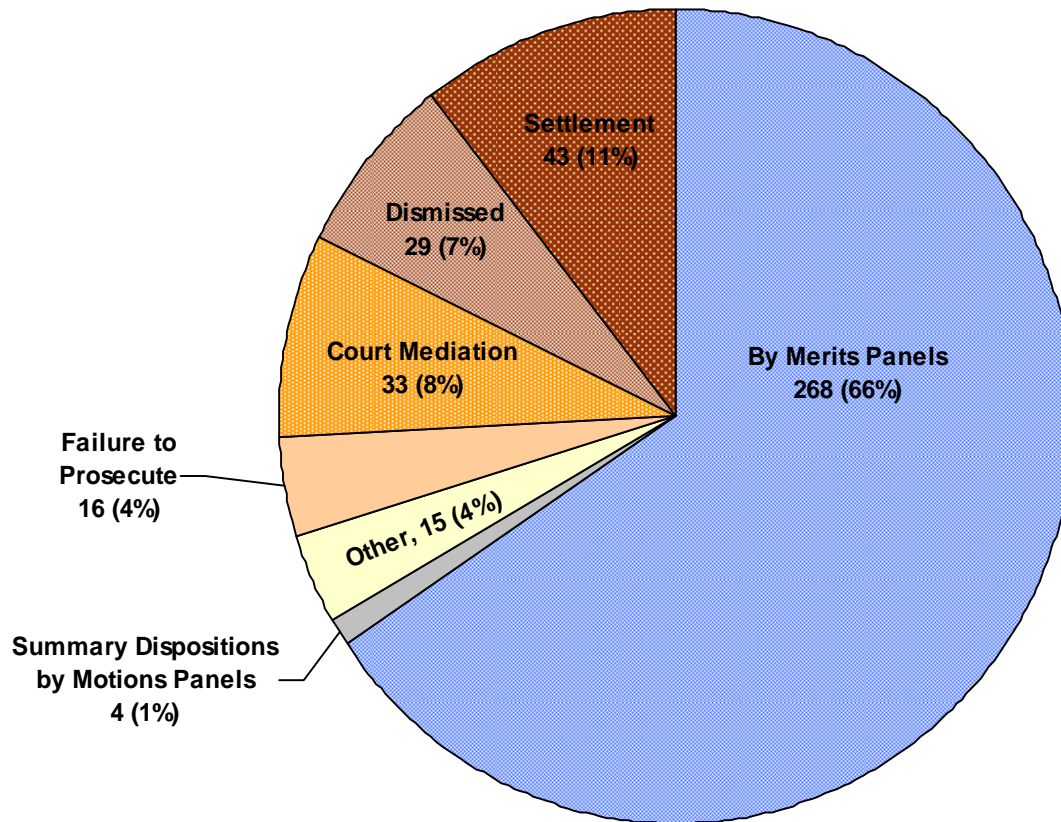
District Court Cases Remanded in Full or in Part by Federal Circuit Merits Panels

Merit and Non-Merit Dispositions for Appeals in District Court Patent Infringement Cases

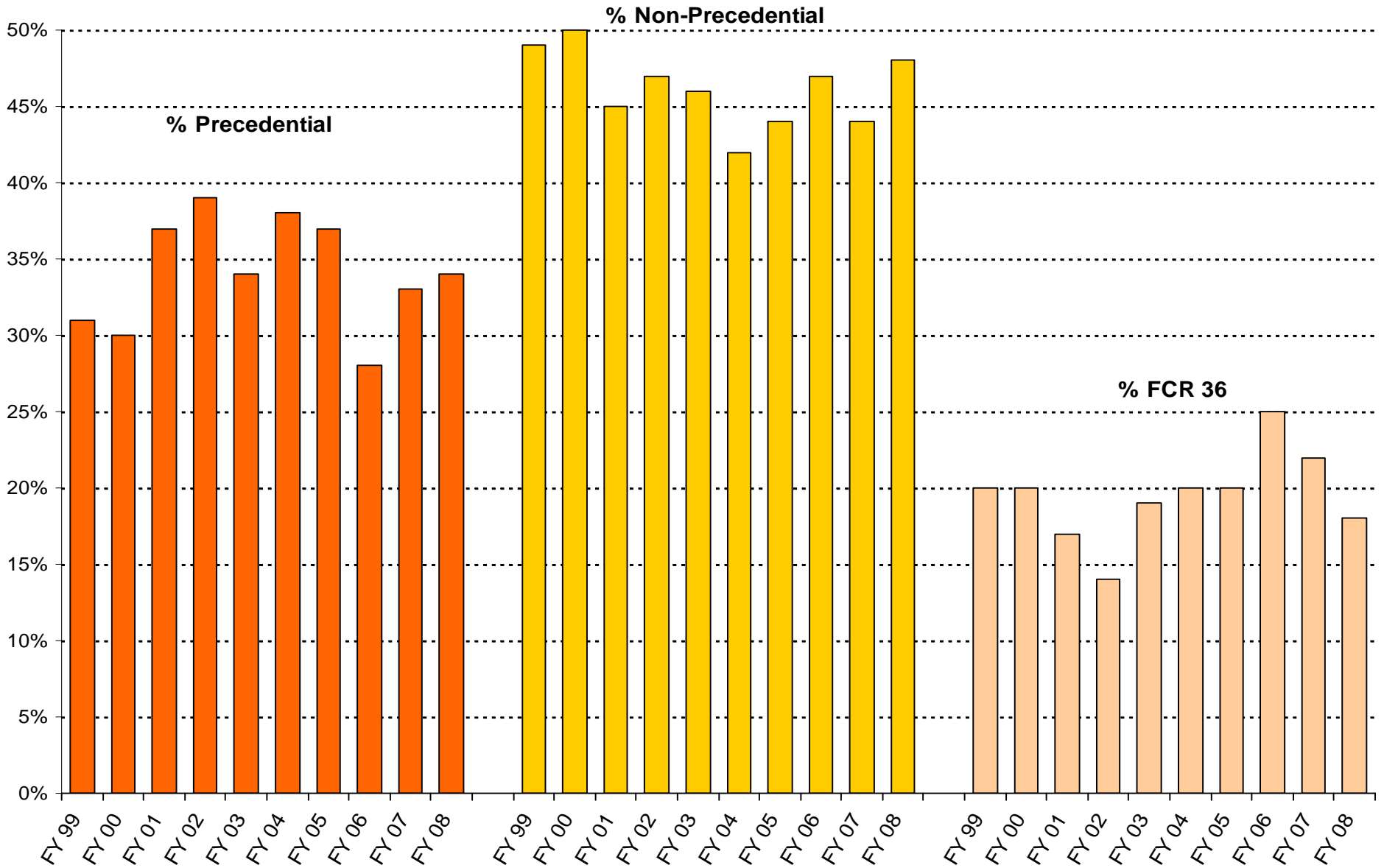

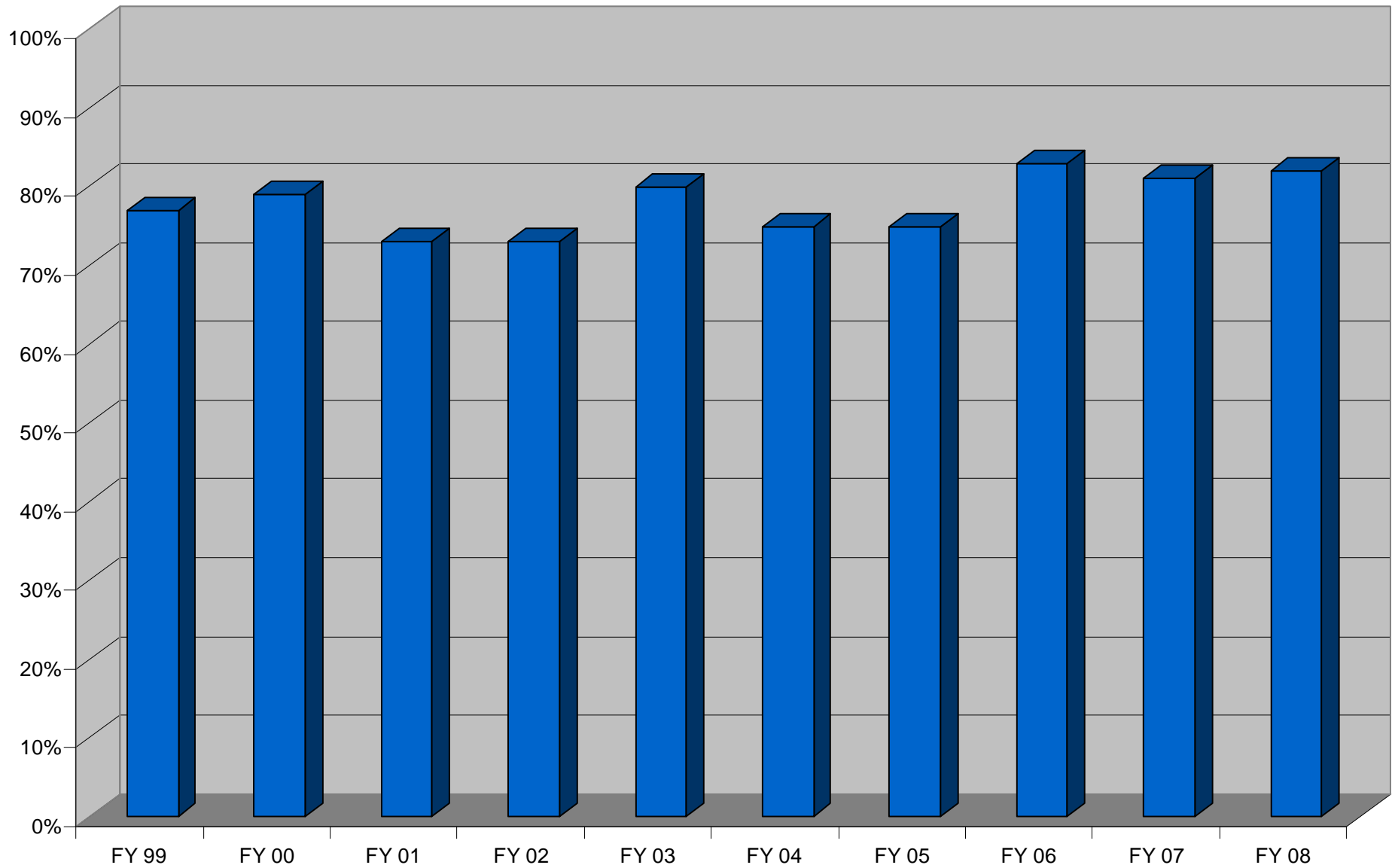

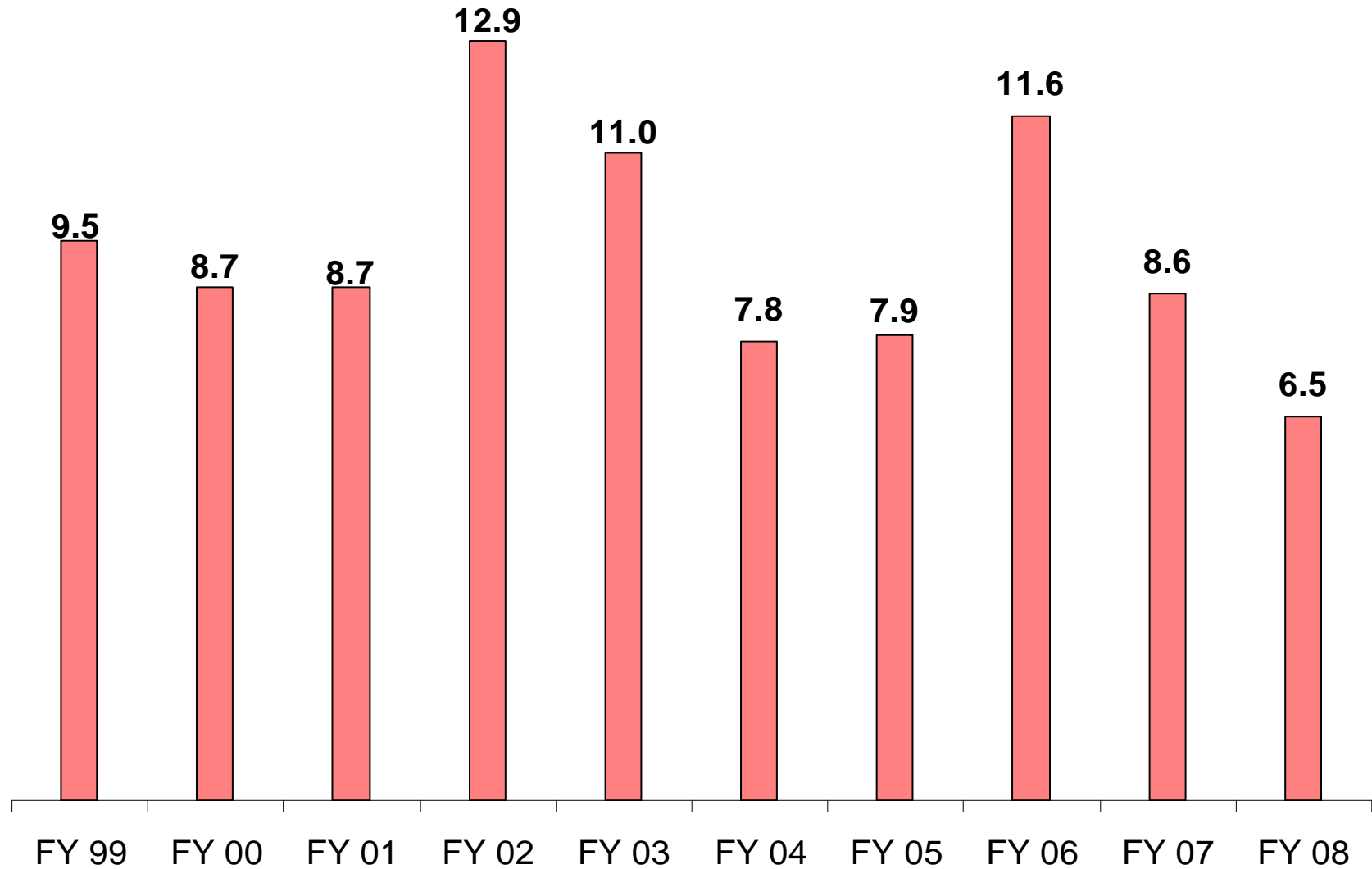
Percentage of Appeals Terminated by Merits Panels in 90 Days or Less

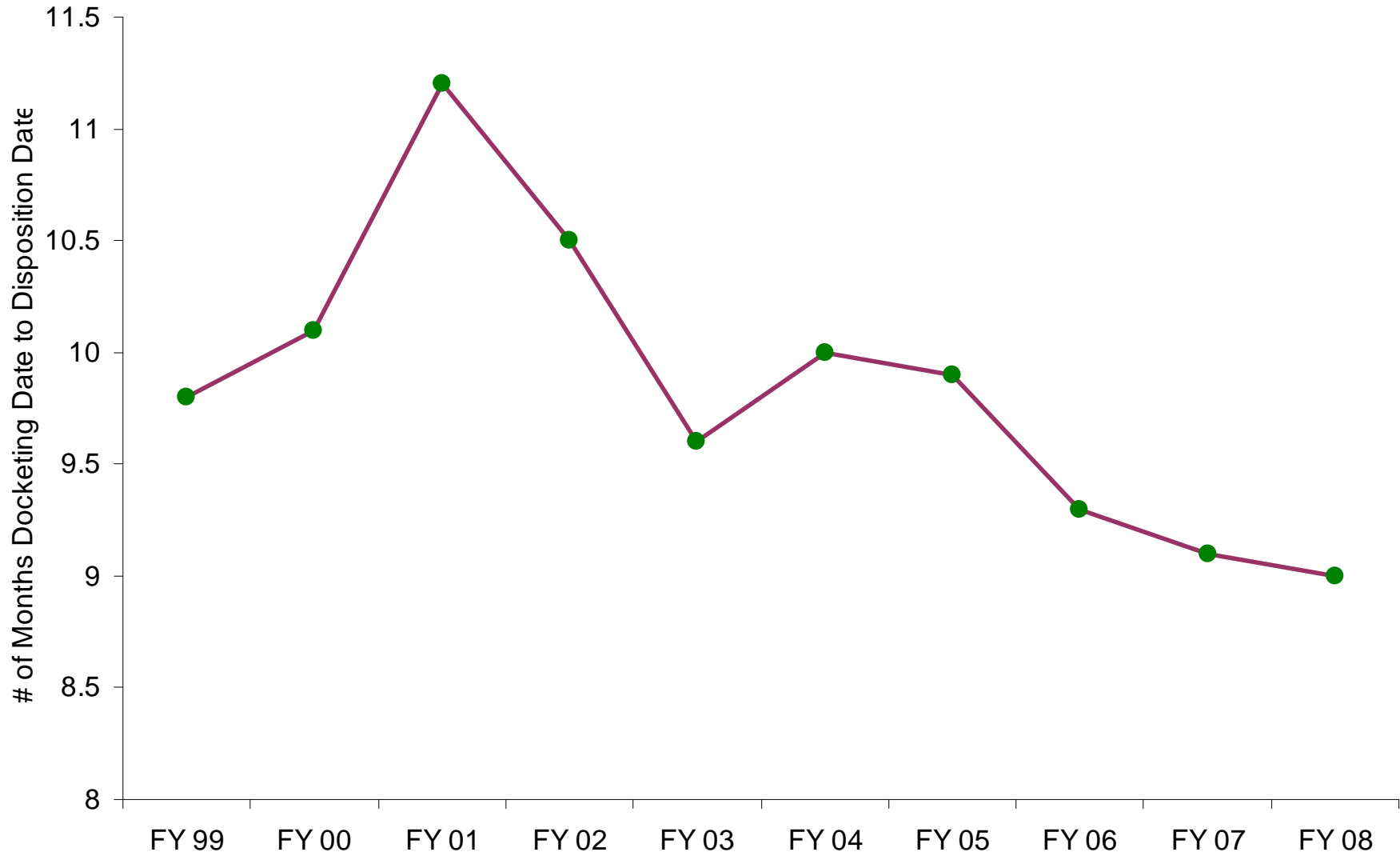
Inventory Control Index on the Last Day of the Fiscal Year

(Number of Months Required to Terminate Current Pending Appeals)



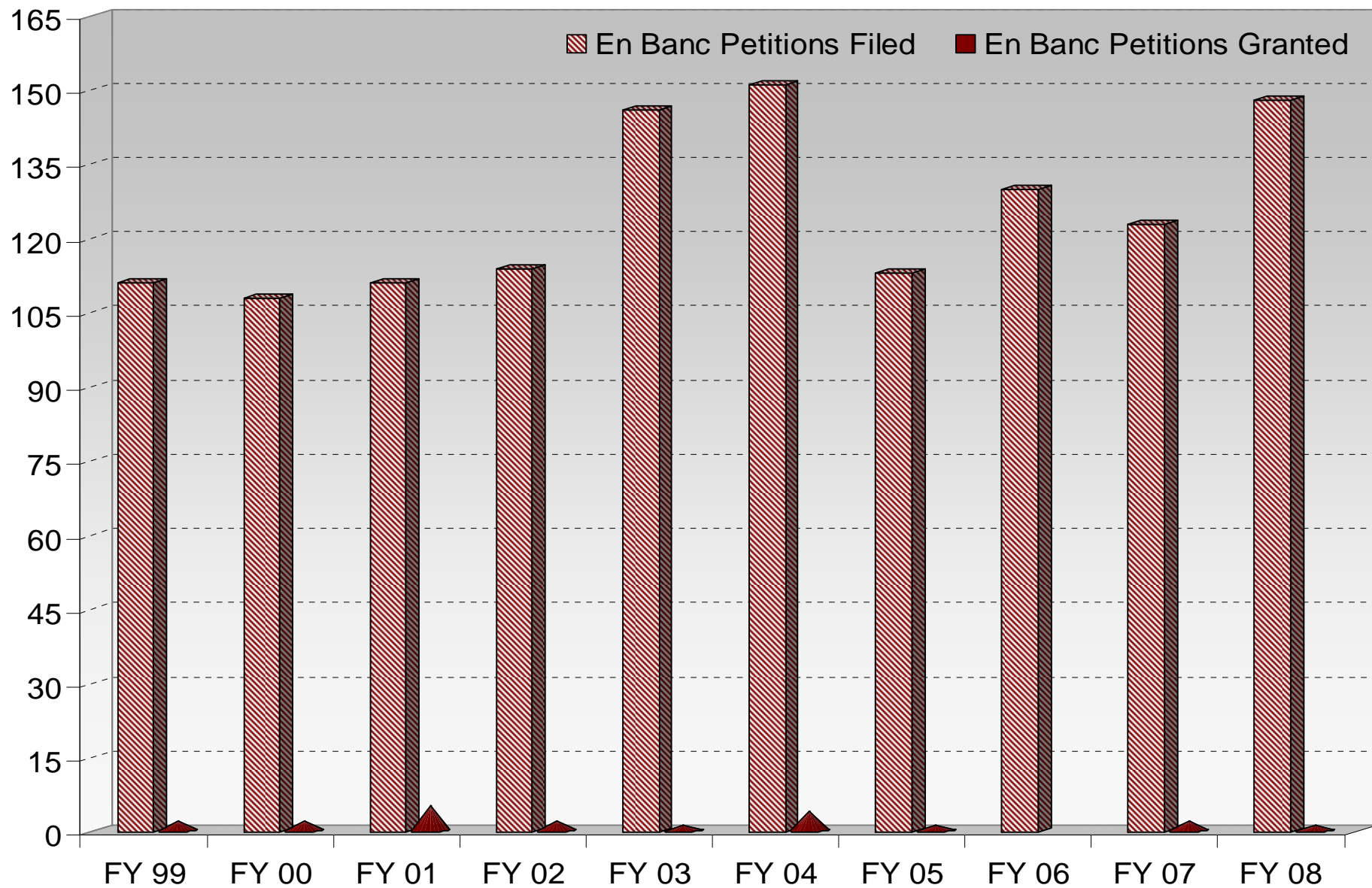

Median Disposition Time for Cases Decided by Merits Panels



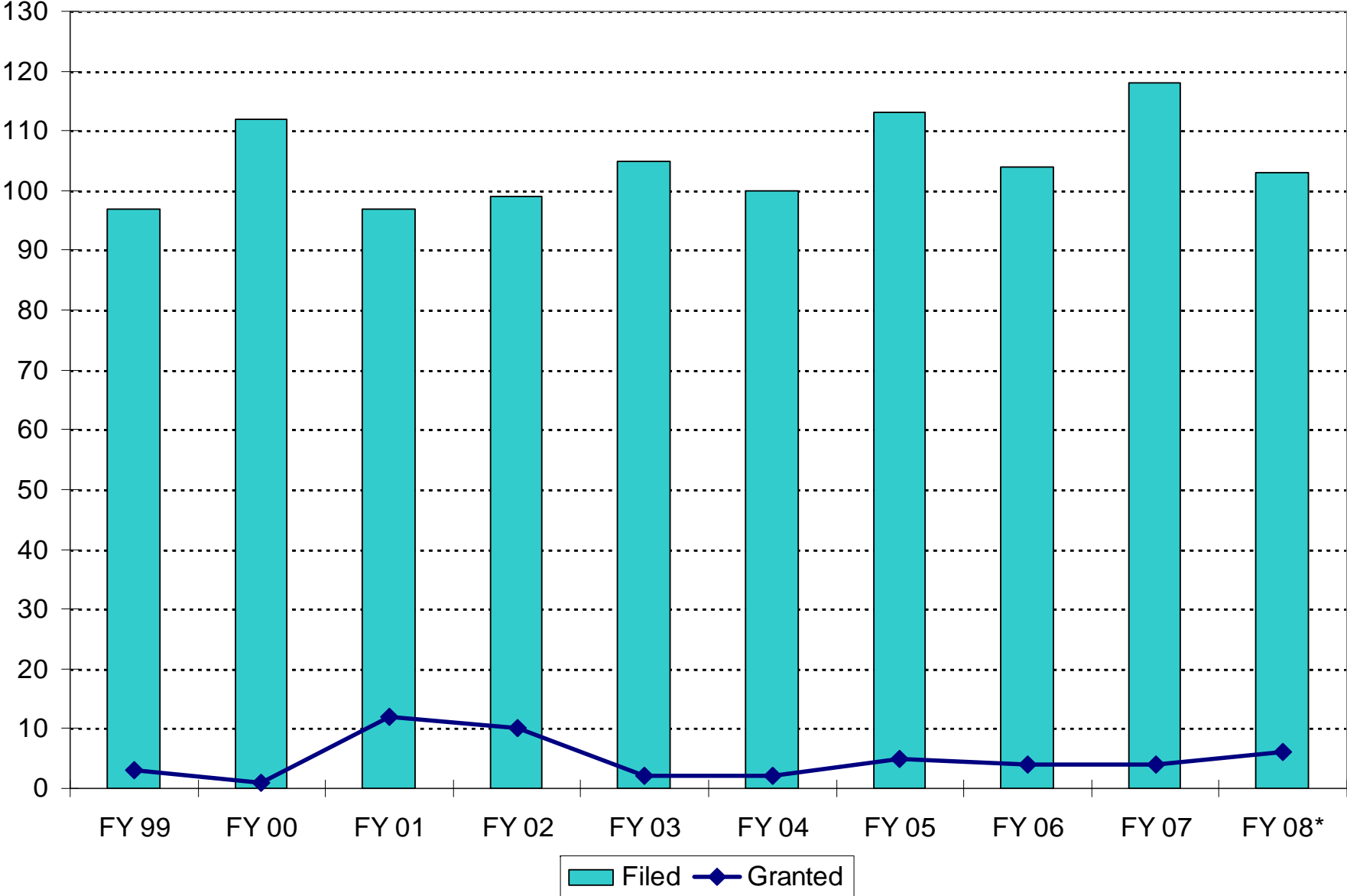

Petitions for Rehearing en Banc Filed and Granted



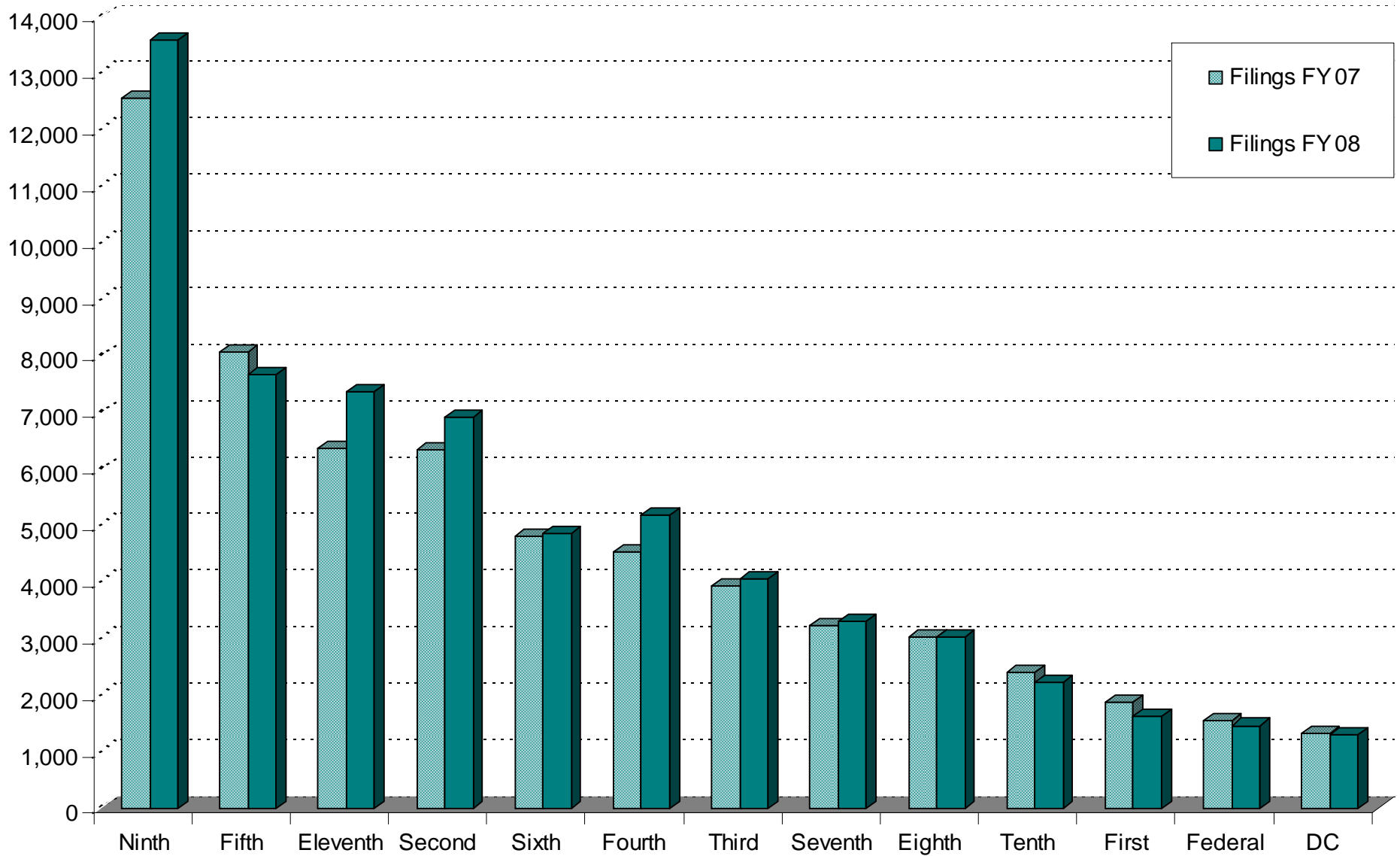

Petitions for Writ of Certiorari to the U.S. Supreme Court from Federal Circuit Cases



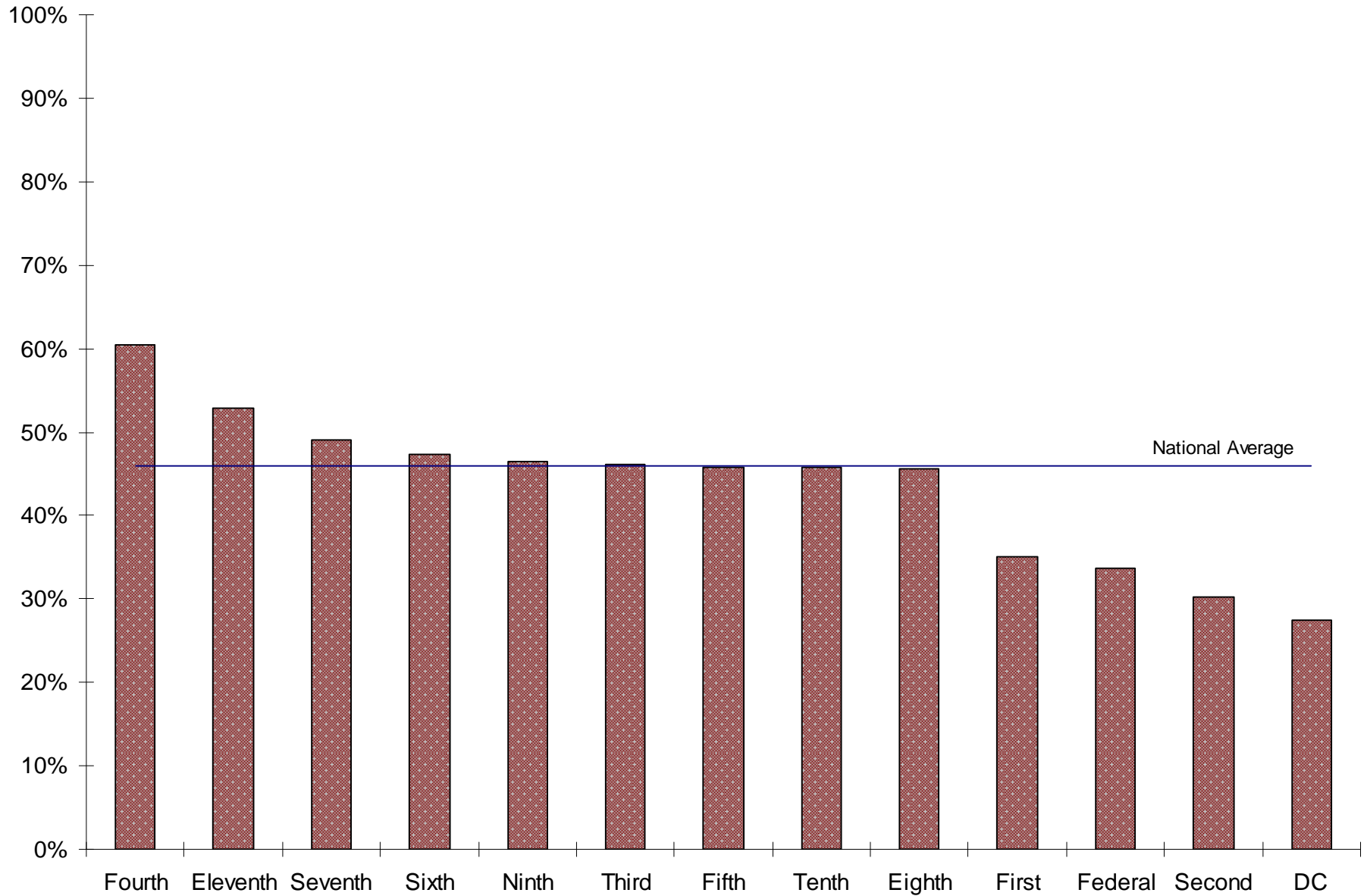

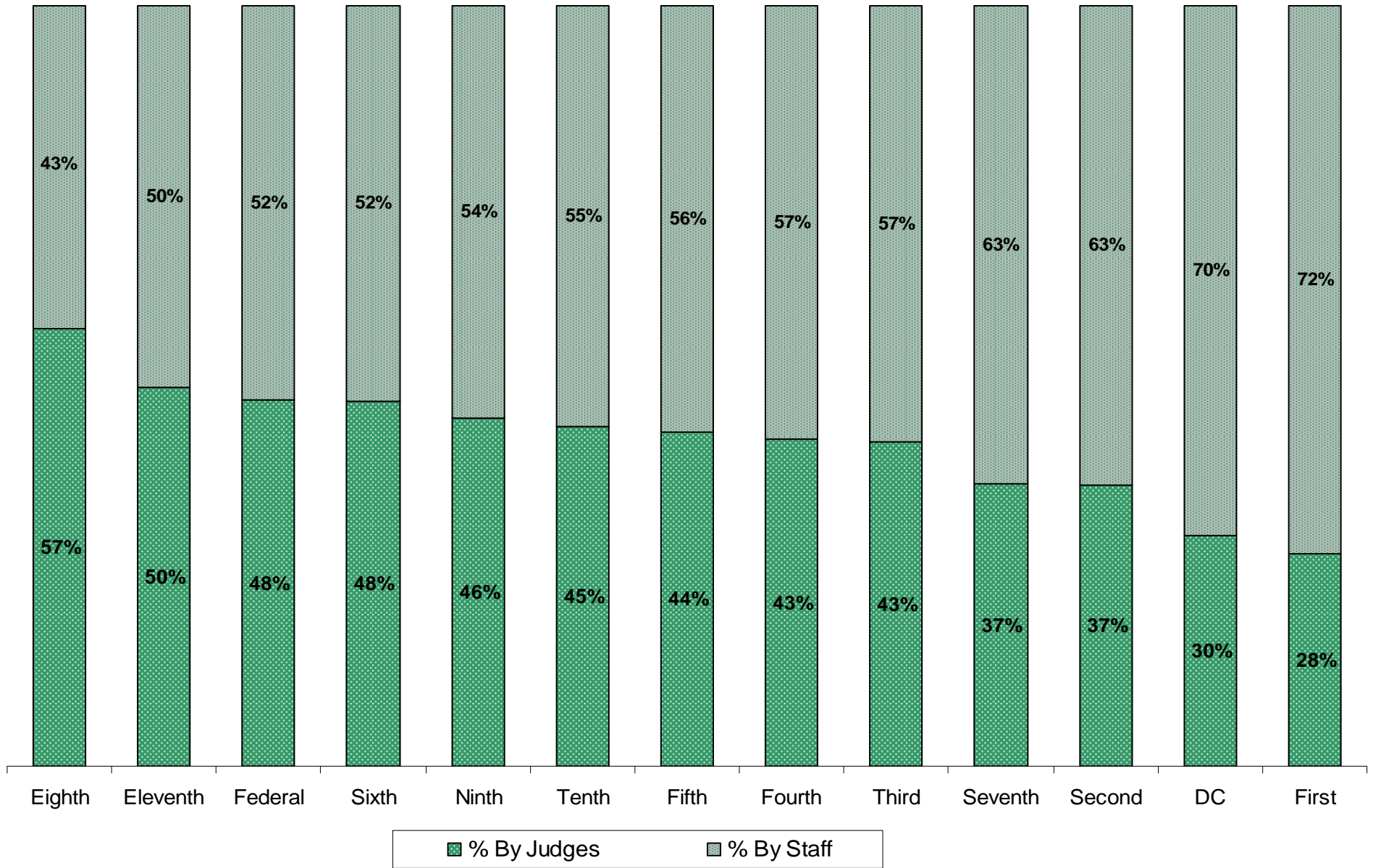
Proportion of Caseload Which is Pro Se - FY 2008

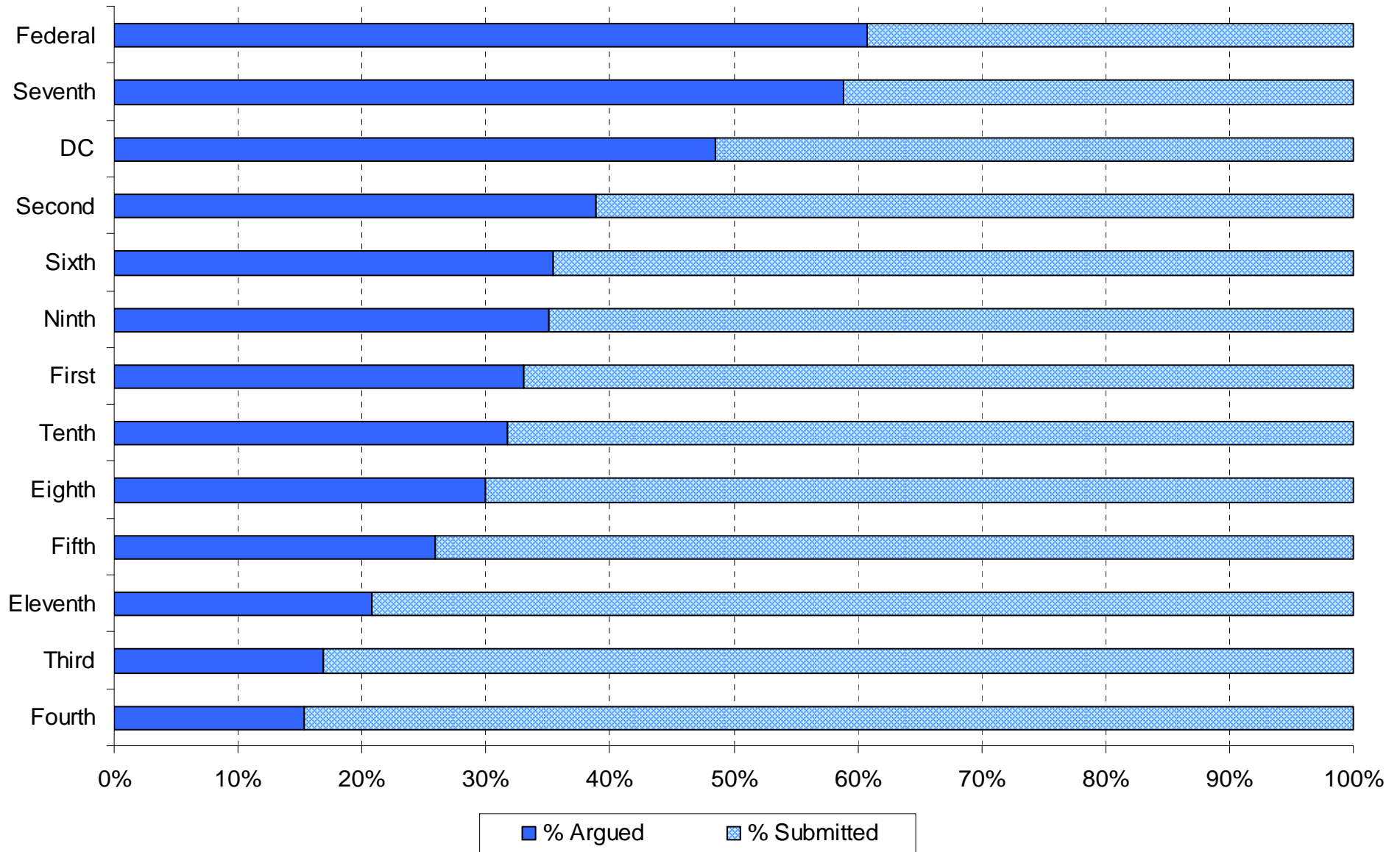

Procedural Terminations - FY 2008



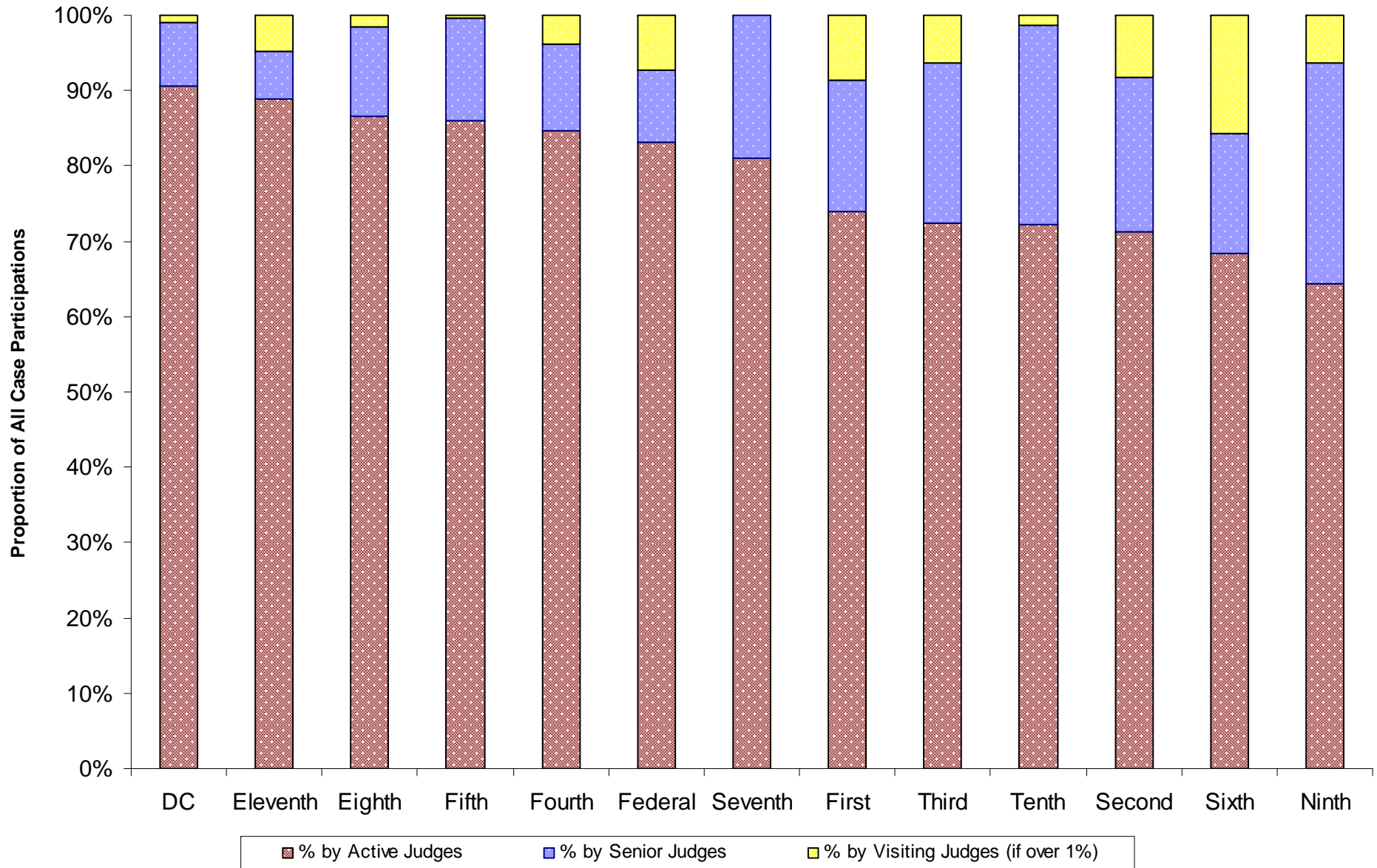

Proportion of Appeals Decided by Merits Panels Heard Through Oral Argument - FY 2008



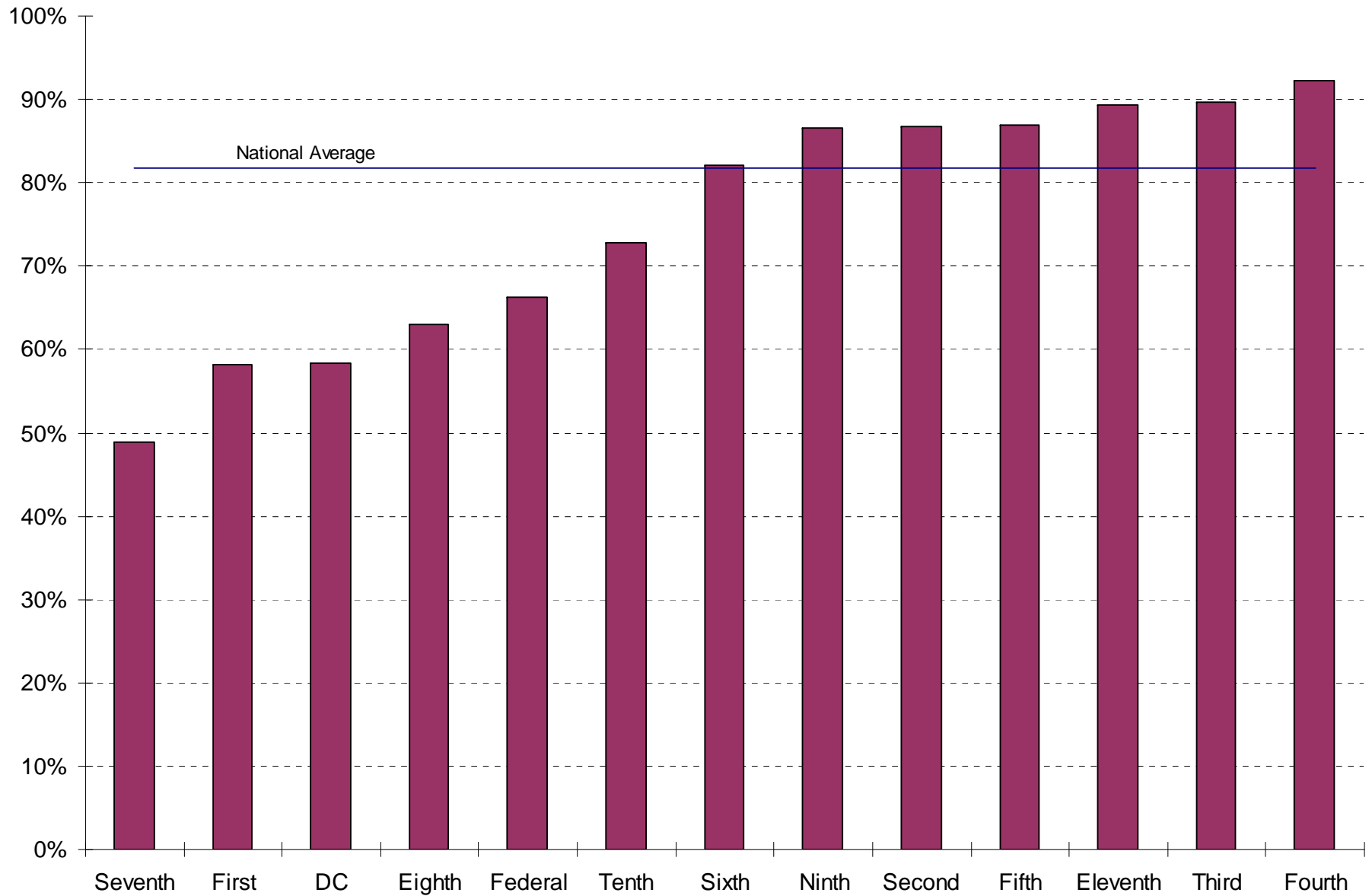

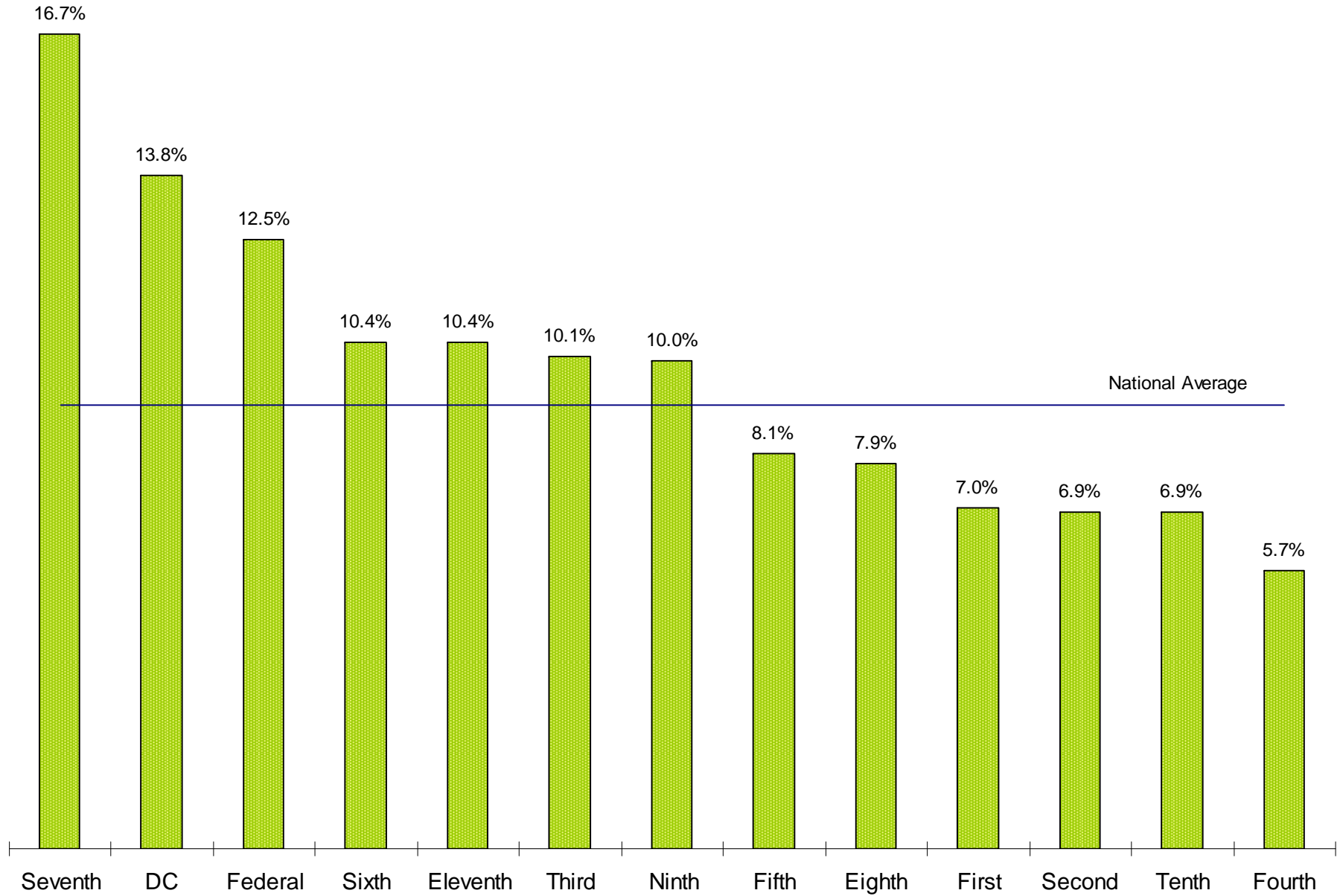
Proportion of Opinions Unpublished - FY 2008

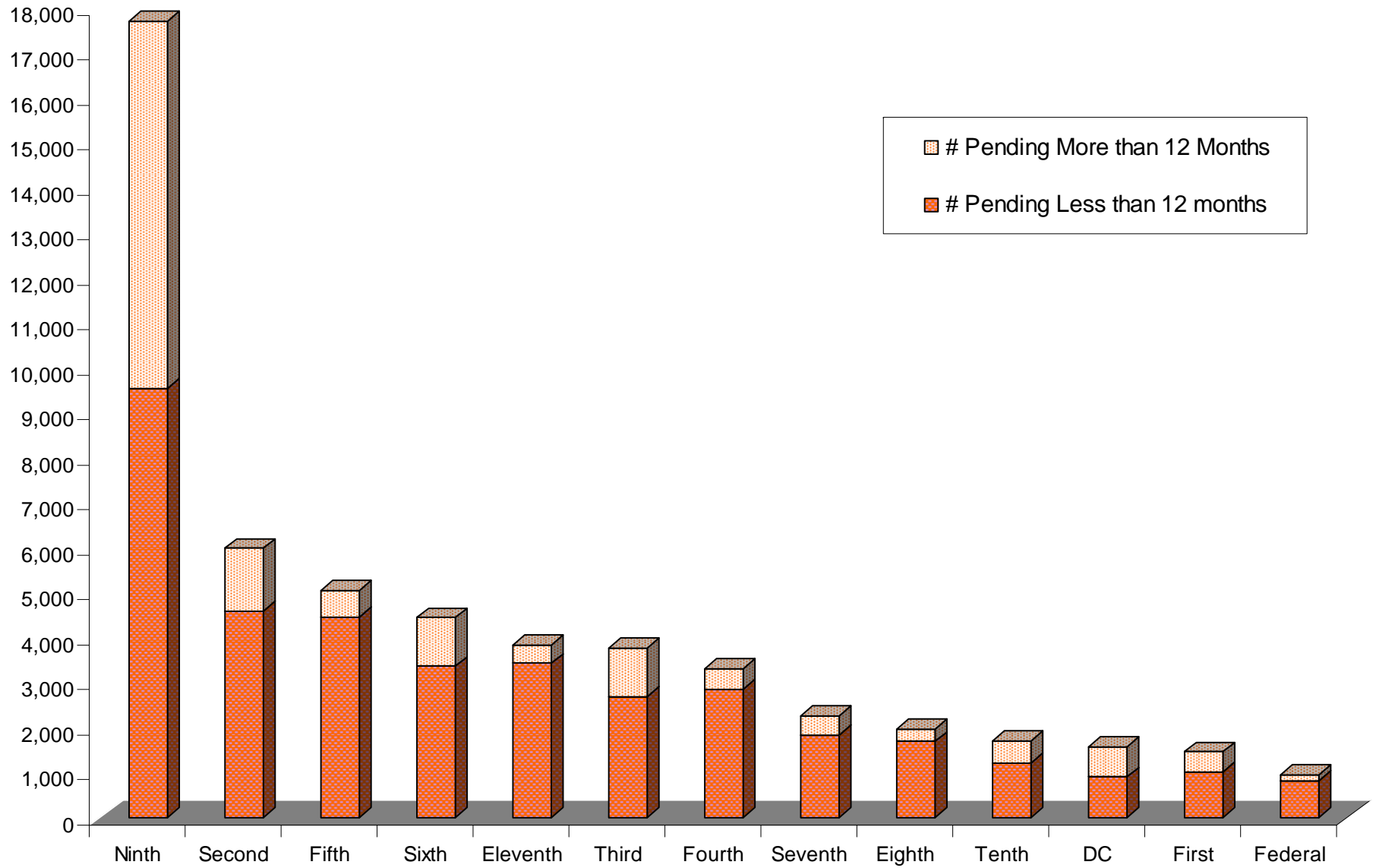

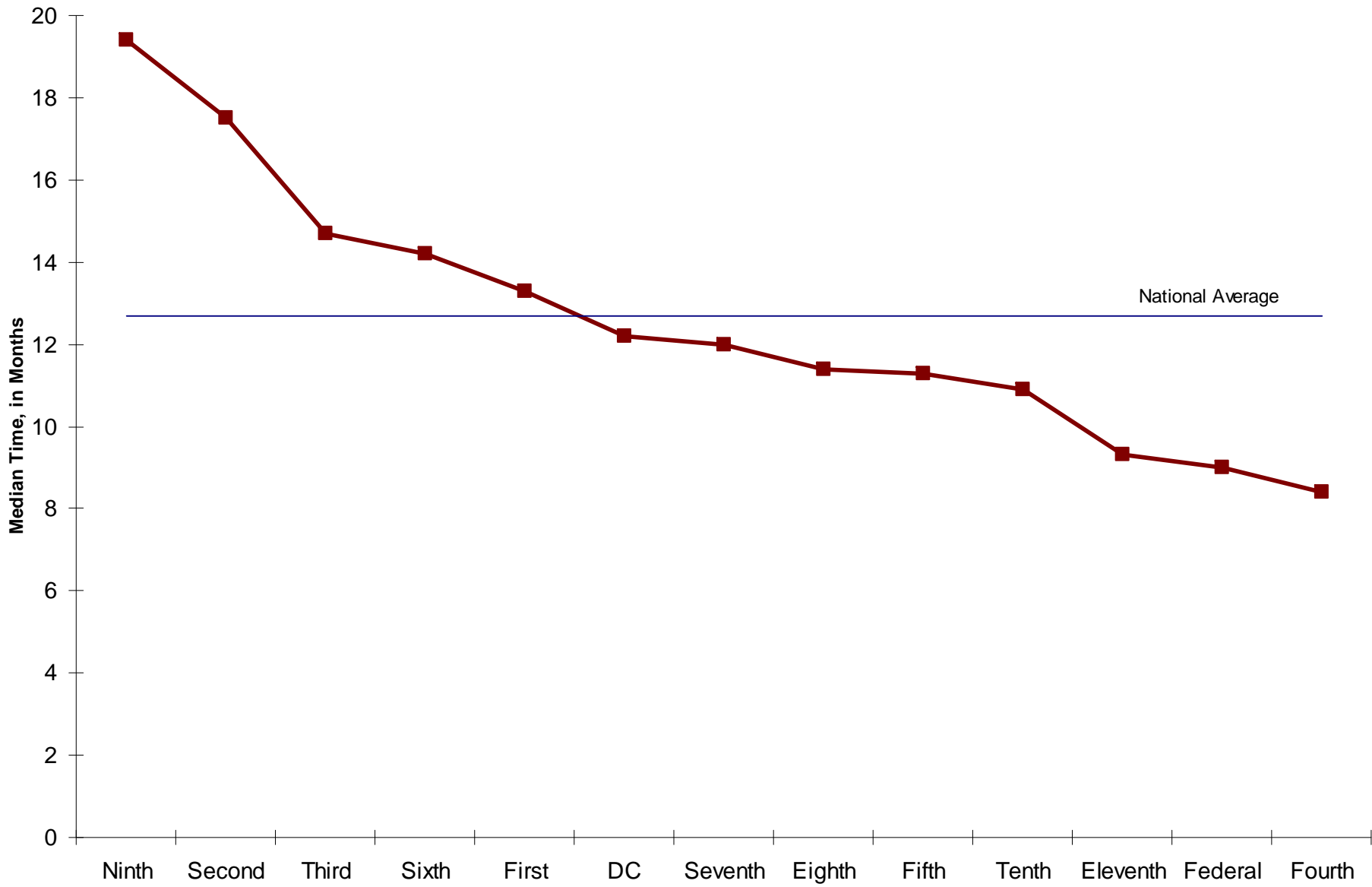
Appeals Pending on September 30, 2008

Median Time in Appeals Decided by Merits Panels - FY 2008

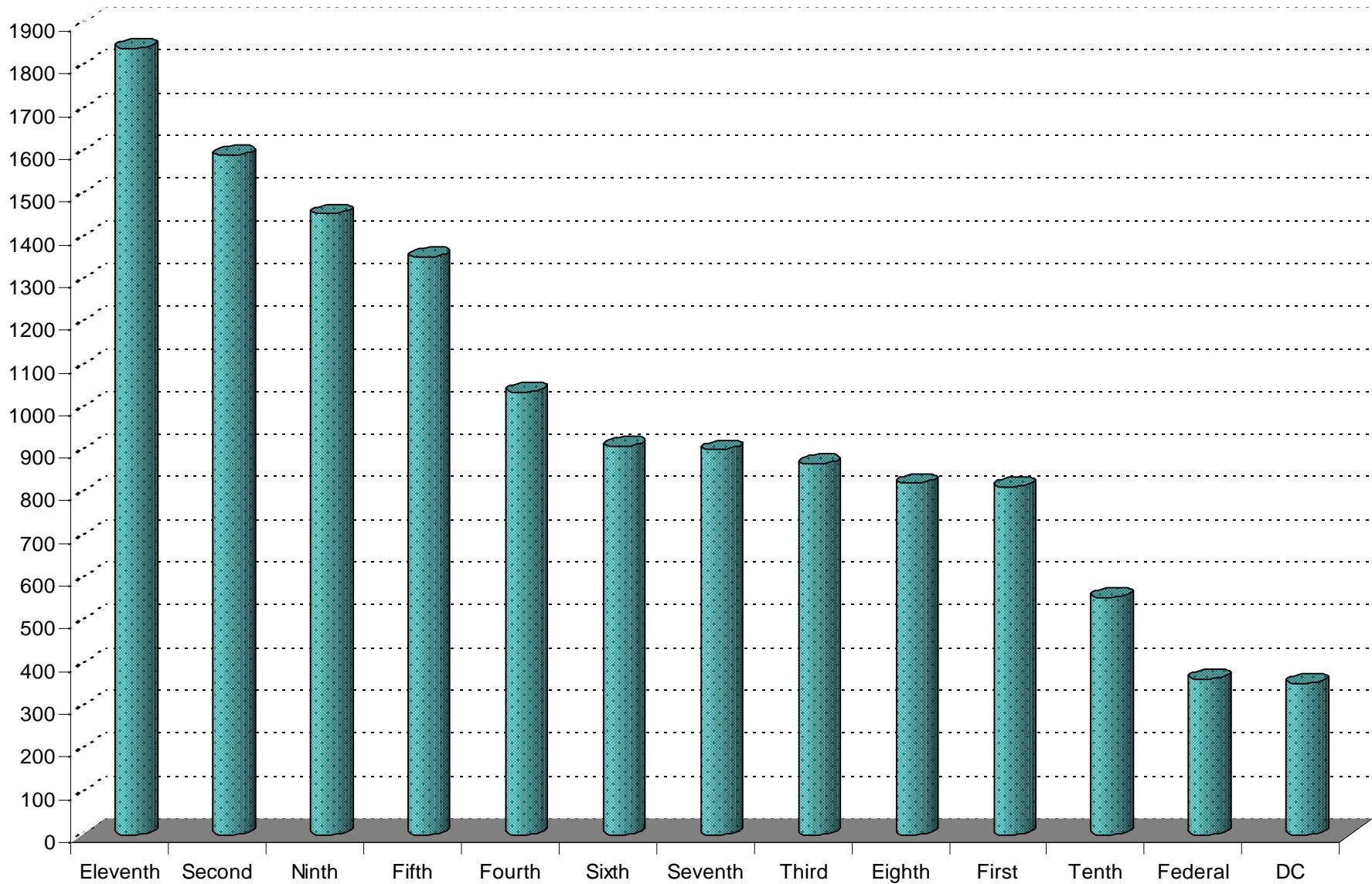

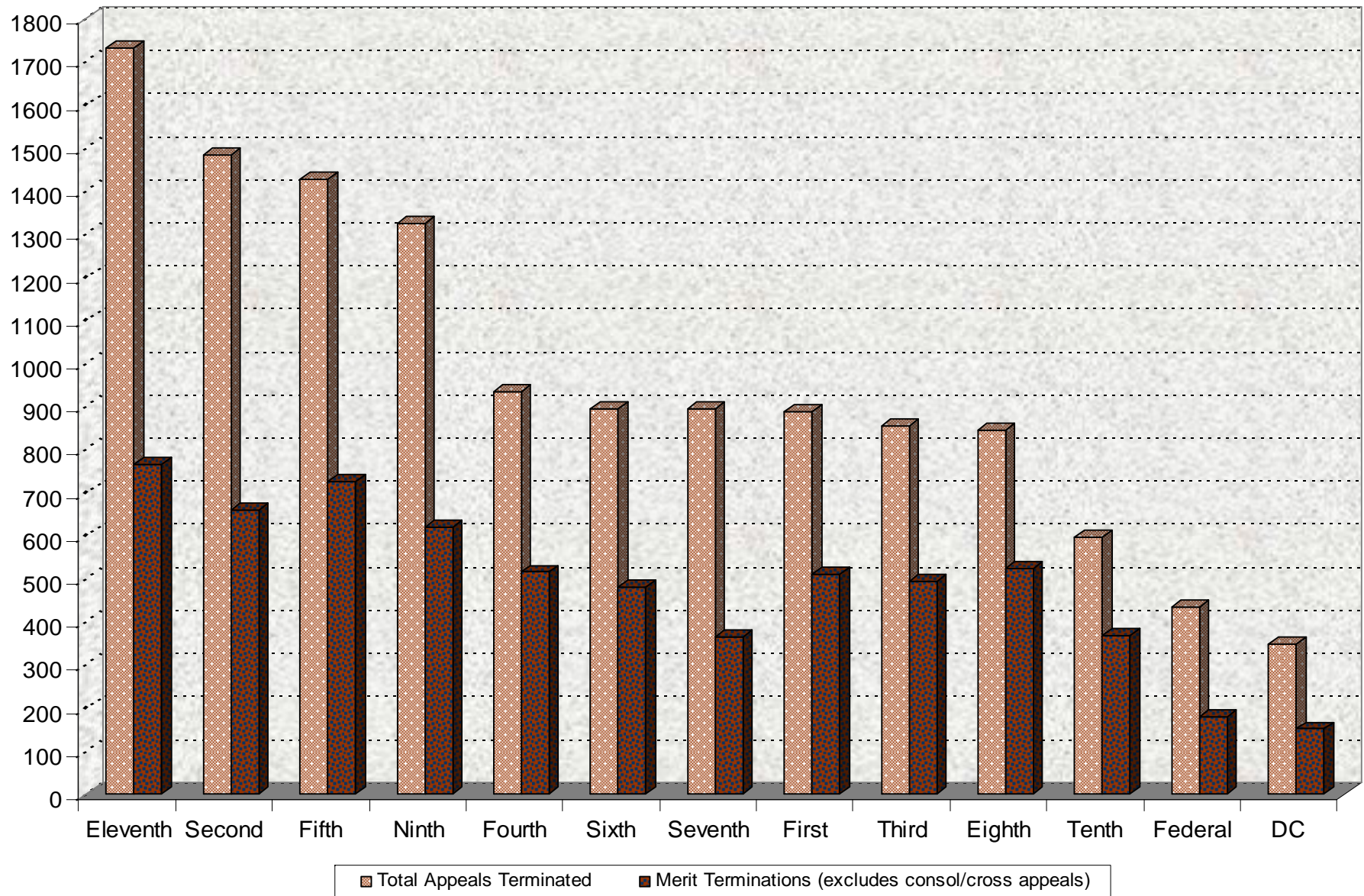

Appeals Filed Per Panel - FY 2008



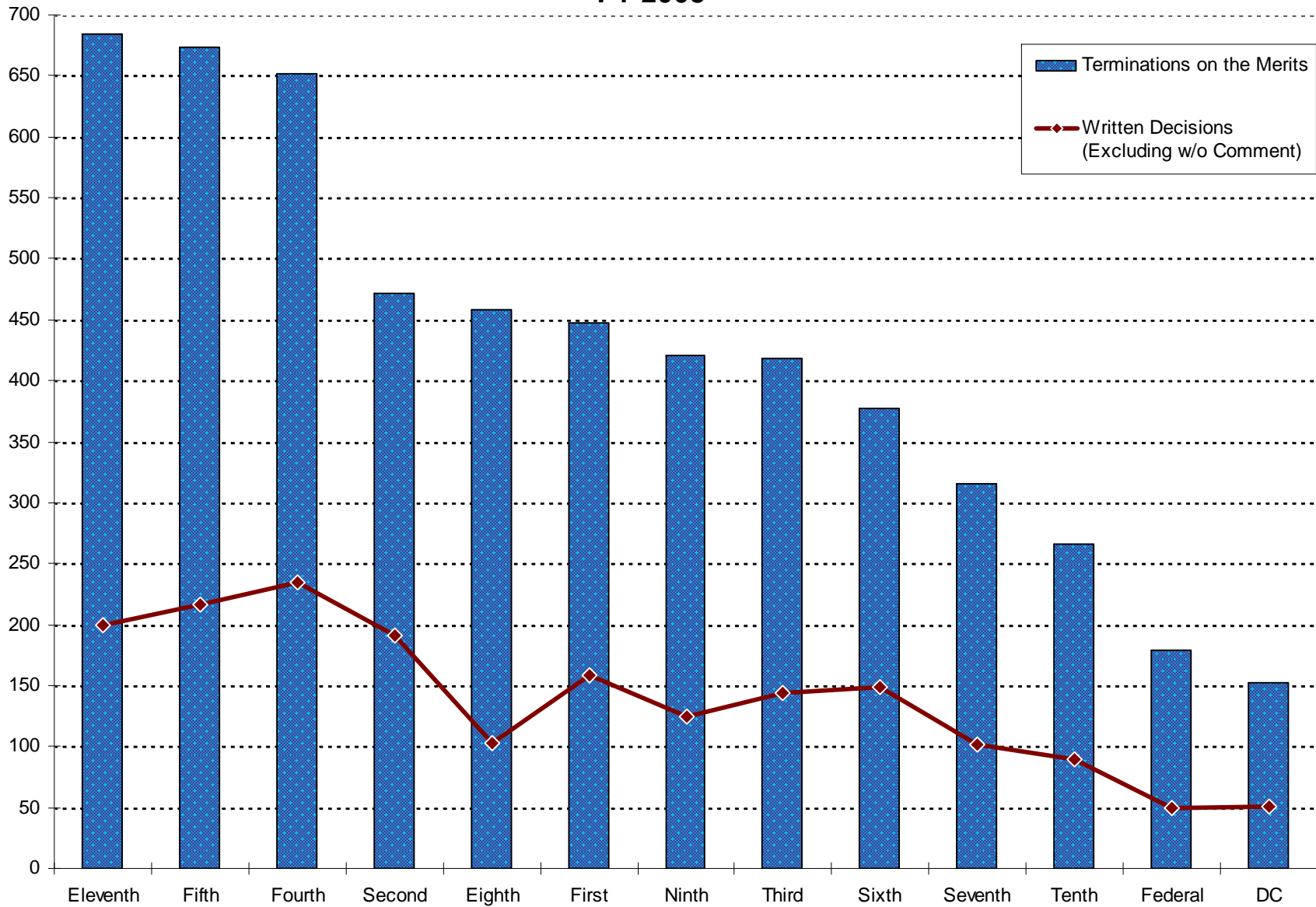

Case Terminations Per Panel - FY 2008



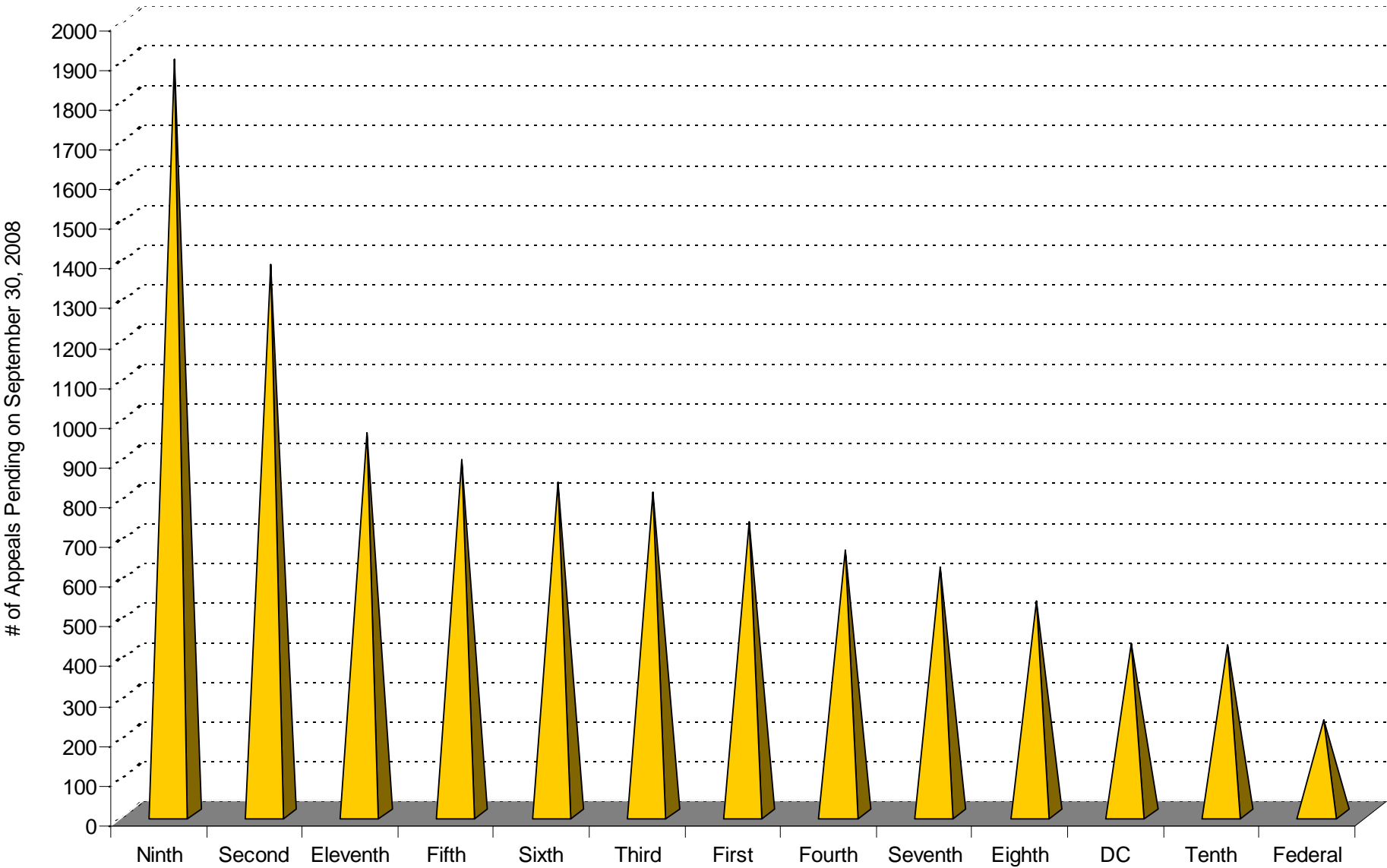

Merit Terminations and Written Decisions Per Active Judge FY 2008



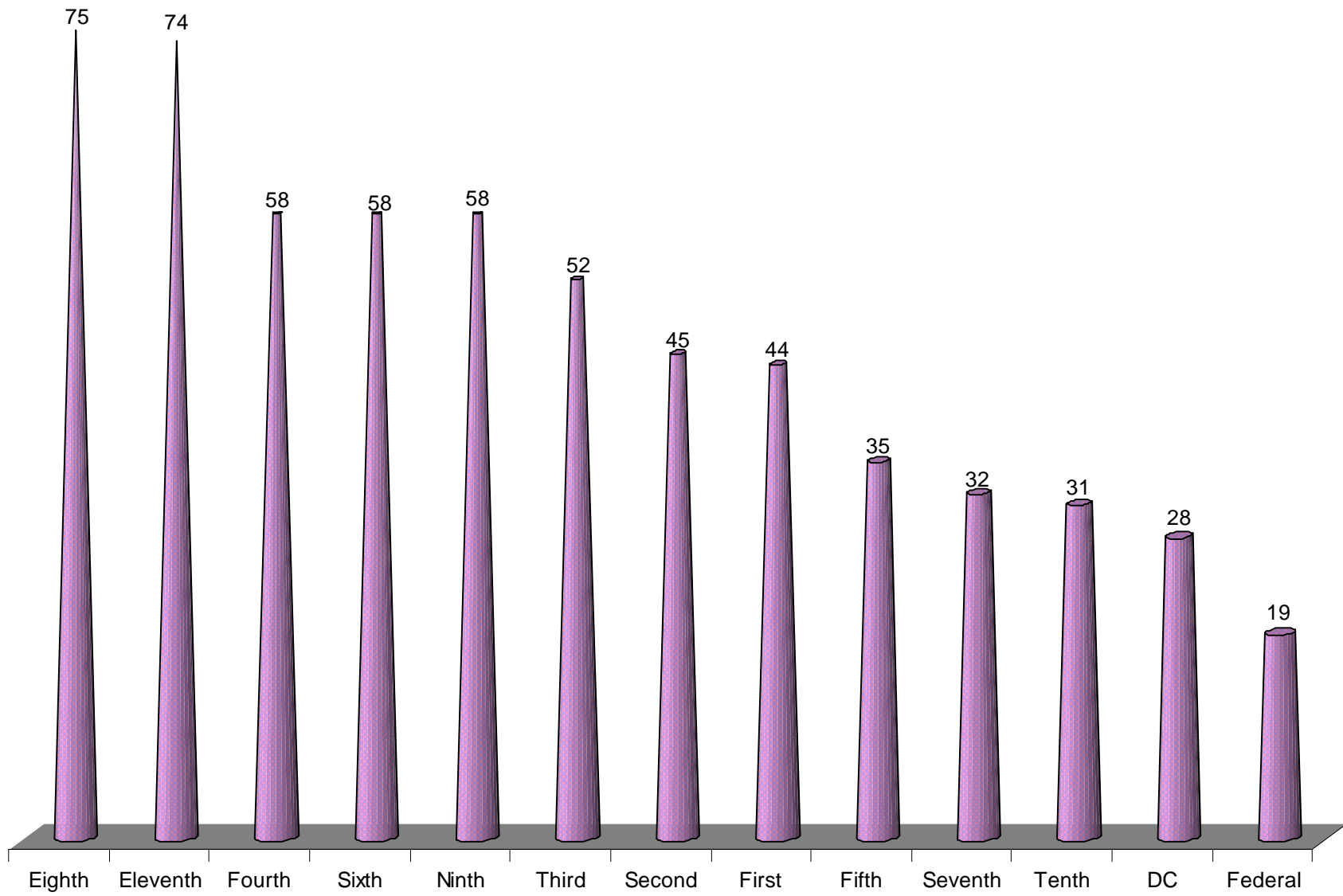
