General law practice since 1963 (beginning by serving as attorney for Legal Aid for one year before entering private practice). I have had extensive experience in litigation and trial work, both civil and criminal. Emphasis in law practice has been in civil litigation with emphasis in business, real estate, debtor-creditor, and commercial litigation. I served as Municipal Court Judge for the city of Lake Oswego from December, 1978 through September of 1982. I have served as pro tem judge for Multnomah County Circuit Court's Domestic Relations Department (appointed in 1986 to assist with overflow cases as needed). I have been selected as an arbitrator in many cases under the mandatory arbitration program in Oregon Courts.

(A) NEVER BEEN SUSPENDED, DISBARRED OR HAD ANY PROFESSIONAL LICENSE REVOKED;
