on

Distribution of Afghan Family Health Book

July 2006

I. Introduction

Afghan Family Health Book (AFHB) is designed to give the essential health messages to afghan families in a user-

friendly way introducing for the first time the talking book. It is covering various aspects of health education

especially on Malaria, nutrition, Family planning and hygiene. Its efficiency in terms of improving health related

issues awareness is significant however there have been questions regarding the sustainability and cost effectiveness

of the project. Primarily developed for afghan families it is aimed to be introduced by the Community Health

Workers (CHWs) to the community. Secondly it is appropriate to make them available in all health facilities to be

used as a tool of health education by the health workers.

II. Proposed Distribution Plan

1) Identifying the CHWs and Health facilities:

The first step was to know the target audience and its number. We used all our resources to have an estimate number

of CHWs and Health Facilities. Our official report on number of CHWs and health posts was exactly like this:

Health Post: 2500

CHWs Number: 5000

Health Facilities: 420

Number of Hospitals: 160

But what we faced was twice and three times of our expectations. Only number of CHWs went to more than 15000.

It was shocking. There were two bias: first probably our counterpart NGOs had over reported the number. This fact

was thoroughly analyzed and we reviewed the population each NGO covers and the number of CHWs they should

have. So practically it was quite logical that for at least 23 million afghan there should be around 15300 CHWs as

per 1500 population. So consequently the claim of the NGOs is not illogical. However, in practice they don't have as

many trained CHWs as claimed. So we requested once more to get the trained number of CHWs. So most of NGOs insisted that there is no over reporting and it is their real CHW reserve. We ignored the future to be trained CHWs in

order to give priority to present active CHWs.

The committee for training and coordination requested that we have to give some copies to Community Health

Supervisors. It was accepted by NGOs. As per each Health Facility there will be a CHS. As a result we decided to

give one copy to each CHS as well. It is not contrary to what we had planed. In fact we anticipated one copy for

each health facility and as per policy of Community Based health Care of MOPH should have one Community

Health Supervisor.

2) Contacting all stakeholders including NGOs, MoPH departments

Soon after we received the fund and we could transfer the books to MoPH we contacted Grant and Contract Management Unit (GCMU) director, Dr. Ahmad Jan naeem to share the project with him and to ask how to involve the relevant NGOs. He suggested that we should have a presentation on 30th April in Performance based Project Agreement (PPA) monthly coordination meeting where head of all NGOs who have a contract to implement Basic Package of Health Services (BPHS). The presentation included the introduction to Afghan Family Health Book and its distribution project and how NGOs would be involved. This introduction was done by Dr. Ab. Tawab Saljuqi as planned. Questions regarding the book and its distribution was answered and NGOs happily showed there agreement to introduce one focal point for the orientation in the month of May.

3) Training of NGOs focal points for how to use the book:

The focal points of NGOs were trained on 11th May 2006. There were 40 representatives from various NGOs. Three Facilitator which were working as a team to prepare the curriculum and plan of Training. These people were:

- 1. Dr. S. Habib Arwal, CBHC Coordinator, MoPH
- 2. Dr. Malang Amiri, Training Coordinator of Preventive Medicine and PHC General Directorate, MoPH
- 3. Dr. Ab. Tawab Saljuqi, IEC national Coordinator, MoPH and Project Manager for AFHB distribution project.

The curriculum, training material and resolutions are given in Appendix 1

4) Distribution of the books to NGOs:

From 11th May till 4th June we were receiving the request of NGOs for books. It took longer than we expected we wanted to have the request within ONE WEEK but the first one came at least ten days later. The last request from IMC came one month later. So we started the real distribution on 3rd June 2006 and ended it on 18th June 2006. We distributed only 80% of what these NGOs have requested, in order to have an equal number distributed to all Afghanistan.



The total number of books we received from IMC was 16749 From this 8849 were Dari copies and 7900 were Pashto. The total amount requested by NGOs were 14049. We expected only 5000 CHWs however it was revealed that we had under estimated the CHW numbers in Afghanistan. We distributed 12282 from which 7437 were Dari and 4845 were Pashto. Now we have totally 4467 copies of which 1412 are Dari and 3055 are Pashto.



There are certain community based NGOs that are demanding some copies for their trainers. We have decided to give them 50% of what they request. These NGOs have CHWs who are not under the BPHS program. The distribution plan is in **Annex 2**.



We plan to give some copies to Institute of health Sciences who are training midwives and nurses and who would have direct contact with communities.



5) Distribution of the book by NGOs:

Right now the training of CHS are going on all around the country by various NGOs and some even have started to distribute the book to them. We have feed back from three provinces (Panjshir, Kapisa and Parwan) where MoPH has the role of implementer and it is a successful process till not.

6) Training of CHWs and health facilities for Usage of the book and its sustainability:

Not yet started. It will be done soon after all CHS are trained and the books are submitted to them to distribute them to CHWs. The training would be more kind of briefing on how to use the book. And CHS will be in continuous contact with CHWs to see how well they have understood the book content and how well they are applying it.

7) Distribution of the Book to CHWs and Health facilities

Started in provinces but not in all of them. This process is dependent on the previous activity.

8) Training of Provincial Moph focal Points for Monitoring and supervision of the distribution

The training could not start yet as the MoPH have added IEC focal points in its new structure. So it was decided by the team to train these IEC focal points for monitoring when they are requited. However still the structure is not approved so we are impatiently waiting for their arrival.

9) Supervision and Monitoring

Not yet started. Planed to be done soon after the IEC provincial officers are trained. It will be for six months. Normally it was planed that these officers will start their work as soon the distribution is started. But it was delayed due to delay in approval of New structure of MoPH for the current year.

11) Evaluation

Not yet started. To be done at the end of project.

12) Reporting

The activities which were explained in previous paragraphs are summarized in the below table. Only there is one major change and that is the change of time. From Quarter one to Quarter two.

IV. Financing and Budget

The transportation will be done by the NGOs but two types of transportation was predicted to be done by our team: first the transport from IMC to MoPH which was done using private sector and as well as MoPH trucks. The second was the transportation of books from MoPH to three provinces which are under MoPH authority. The site of the stock is far away from MoPH so the transportation of staff to and from stock was done by team resources.

It was suggested from MoPH to get the budget in three installments. So the first installment was transferred in April (10477.82 USD) and till today the cost has been 8960.00 USD. So, there is need to receive the second installment. For the detail of expenses you can refer to Annex 3 at end of this document.

Challenges and How did we over come them:

We faced certain challenges that were not anticipated:

- 1- Requested number of books was more than we expected and had in our hand so we distributed 80% of the requested number.
- 2- Request for Dari version was more than Pashto: By reducing the percentage of distribution we could have more copies of dari version. Some areas were given more Pashto copies even if there request for Pashto books were less.
