2000 Enrollment Fact Sheet (Major changes from 6/30/2000-12/31/2000)

- Alabama The State Medicaid Enrollment increase was due to (1) the October 2000 implementation of AL's Plan First 1115 waiver for family planning services and (2) the number of poverty related children (SOBRA kids) continued to increase.
- Florida The State Medicaid Enrollment increase was due to outreach and expansion of Medicaid eligibility for children and teens.
- Ohio The State Medicaid Enrollment increase was due to the increase of 150% over the poverty level for pregnant women and CHIP outreach and expansion programs.
- Missouri The State Medicaid Enrollment increase was due to outreach and expansion of Medicaid eligibility for children and teens.
- Puerto Rico The State Managed Care Enrollment increased was due to the San Juan municipality joining Health Care Reform on 7/1/00.
- Texas The State Medicaid Enrollment increase was due to normal variations and the enrollment into the children's health programs.
