MAJOR CHANGES FROM 6/30/2002-12/31/2002

- ARIZONA The State Medicaid Enrollment increase was due to the economic situation.
- ILLINOIS The State Medicaid Enrollment increase was due to the SeniorCare Program, which offers pharmaceutical benefits only.
- MICHIGAN The State's percentage in Managed Care was not 100% as in previous years because the State does not automatically enroll their Medicaid beneficiaries into the Mental Health program.
- PUERTO RICO The State Medicaid Enrollment decrease was due to the Department of Health utilizing stricter methods of verification of assets and income, which cause many beneficiaries to be dropped from eligibility rolls.
- WISCONSIN The State Medicaid Enrollment increase was due to the economic situation.
