- Georgia The Managed Care Enrollment increase was due to the Katrina evacuees and normal increases in enrollment.
- Illinois The Managed Care Enrollment decrease was due to Humana terminating their contract on 8/1/05, and United terminating their contract on 9/1/05. United's membership was acquired by Harmony Health Plan.
- Mississippi The Managed Care Enrollment decrease was due to Hurricane Katrina which resulted in beneficiaries being displaced to other states and normal decreases in enrollment.
- Missouri The decrease in Medicaid and Managed Care Enrollment was due to the State Fiscal Year 2006 budget changes to the eligibility requirements and the SCHIP population is required to pay a premium.
- New Jersey The Medicaid Enrollment increase was due to eligibility and enrollment.
- Ohio The Managed Care Enrollment increase was due to an expansion that added two
  more counties to the PremierCare program. The State also contracted with an additional
  4 MCOs (Amerigroup, Gateway, Molina, and Unison).
- **South Carolina** The Managed Care Enrollment increase was due to the growth in the PCCM program.
- **South Dakota** The State Medicaid and Managed Care Enrollment increase is due to the normal growth in Medicaid eligibles.
- **Tennessee** The Medicaid, Managed Care, and Expansion decrease was the result in the reduction of the adult Uninsured and Uninsurable demonstration populations.
- Texas The Managed Care Enrollment increase was due to the PCCM expansion.
