SUBJECT: Estimated FY 2009 State Allocations under the Carl D. Perkins Career and

Technical Education Act of 2006 (Perkins IV)

I am pleased to provide you with estimated state allocations for FY 2009 under Title I (Career and Technical Education Assistance to the States) and Title II (Tech Prep Education) of the Carl D. Perkins Career and Technical Education Act of 2006 (Perkins IV or the Act). Pursuant to the Department of Education's FY 2009 Appropriations Act, Division F of the FY 2009 Omnibus Appropriations Act, the first portion of Title I funds and all of your Title II funds become available for obligation by the Secretary on July 1, 2009. Under the Education Department General Administrative Regulations (EDGAR) at 34 CFR §76.703(d), July 1 is the earliest date that your state can obligate these funds.

Funds become available to your state at two separate times. Your first installment of Title I funds (approximately 25 percent) and all of your Title II funds will be made available on July 1, 2009, and will remain available for obligation for a 15-month period ending September 30, 2010. The remaining portion of your Title I funds become available on October 1, 2009, and remain available for a 12-month period ending on September 30, 2010. All of your funds are then covered by the so-called "Tydings Amendment," under section 421(b) of the General Education Provisions Act (GEPA), 20. U.S.C. 1225(b), which allows a state to carryover for one additional year any federal education funds that were not obligated during the period for which they were appropriated. Therefore, all funds must be obligated by September 30, 2011. In addition, under EDGAR at 34 CFR § 80.23(b), you must liquidate obligations within 90 days of the end of the funding period unless an extension is approved by this office.

Table 1 provides estimated Title I allocations for each state and outlying area, including the split of funds between July 1 and October 1. Table 2 provides estimated Title II allocations for each state.

Please note the following with regard to the estimated allocations:

 Perkins IV now requires that states distribute secondary funds under section 131(a)(2) of the Act based on the Bureau of the Census' estimate of the number of individuals aged 5 though 17, inclusive, who reside in the school district served by such local education agency and are from families below the poverty level for the preceding fiscal year, as determined by the most recent satisfactory data used under section 1124(c)(1)(A) of the Elementary and Secondary Education Act (ESEA) of 1965, compared to the total number of individuals who reside in the school districts served by all the local educational agencies in the state for such preceding fiscal year.

- Perkins IV also requires that states distribute secondary funds under section 131(a)(1) of the Act based on the number of individuals aged 5 through 17, inclusive, who reside in the school district served by such local education agency for the preceding year compared to the total number of such individuals who reside in the school districts served by all local educational agencies in the state for such preceding fiscal year, as determined on the basis of the most recent satisfactory—
 - Data provided to the Secretary by the Bureau of the Census for the purpose of determining eligibility under Title I of the ESEA. States choosing this option must use the updated "income year 2007" data, reflecting 2007-2008 school district boundaries, which may be obtained at: http://www.census.gov/did/www/saipe/district.html
 - Student membership data collected by the National Center for Education Statistics through the Common Core of Data (CCD) survey system. States choosing this option should now use the 2006-2007 enrollment data which may be obtained at: www.nces.ed.gov/ccd/pubagency.asp.
