OUR PROBLEM IS THAT ADULTERATION OF ALOE SEEM TO BE THE RULE NOT THE EXCEPTION AND THIS FACT PUTS US ON AN UNLEVEL PLAYING FIELD WITH OUR COMPETITORS.

ULTIMATLY MY QUESTION TO YOU IS ,WILL THEIR BE RECOURSE IN THESE PROPOSED RULE CHANGES TO TAKE ACTION AGAINST THOSE PEOPLE WHO CHOSE TO CONTINUE ADULTERATION OF THESE TYPES OF INGREDIENTS, AND WHOM CAN WE CONTACT TO DISCUSS THIS ISSUE.
