Dear Director Rogan:

This is in regard to the patent term extension application for U.S. Patent No. 4,659,516 filed by AstraZeneca UK under 35 U.S.C. § 156. The patent claims Faslodex (fulvestrant), NDA 21-344.

In the April 17, 2003, issue of the <u>Federal Register</u> (68 Fed. Reg. 18992), the Food and Drug Administration published its determination of this product's regulatory review period, as required under 35 U.S.C. § 156(d)(2)(A). The notice provided that on or before October 14, 2003, 180 days after the publication of the determination, any interested person could file a petition with FDA under 35 U.S.C. § 156(d)(2)(B)(i) for a determination of whether the patent term extension applicant acted with due diligence during the regulatory review period.

The 180-day period for filing a due diligence petition pursuant to this notice has expired and FDA has received no such petition. Therefore, FDA considers the regulatory review period determination to be final.
